4. Appeal grounds for the prayer / relief :

Being deceased father and complaint, I have right to know to decision of the Hearing Authority regarding my grievances against 27 doctors of Murshidabad Medical College and Hospital (MMCH), Berhampore and Hospital Authority. Even after repeated letter and reminder to the Principal Secretary, the Director of Health Service, Dr. Dipankar Maji, JD (DHS) and the O. S. D & Dy. Director Health Service (Admin) they have not provided the Hearing Proceeding held on dated 21.02.24 and 18.08.2024 till date. This indicate the Competent Authority want to save 24 nos. culprit doctors of MMCH, Berhampore and Hospital Authorities, who were responsible for death of my son due to medical negligence.
