**PARTICULARS OF INFORMATION SOUGHT:**

It is pertinent to note that from the perusal of RTI Application dated December 12, 2019 and Reply memo number 245/E dated January 15, 2020 issued by the SPIO, Office of the Superintendent of Police, Malda; it is evident that list of witnesses named in the Charge Sheet contains the name of all the officials of WBSEDCL and no independent witness has been relied upon to frame the Ratua PS Charge Sheet number 180/18 dated July 23, 2018 other than Md. Alim. It is stated that the statement of Md. Alim as recorded under Section 161 of Code of Criminal procedure was recorded on November 19, 2017 when he was not present in India and therefore, the statement of the said sole independent witness is under suspicion.

It must be stated that the Md. Alim alias Abdul Alim son of Sanaullah was a resident of Rukundipur, however, he was not in India on **November 19, 2017**. The said person had departed from India in the month of July 2017 and had arrived back in India in the month of December 2017. Therefore, it is not possible that Md. Alim was present at the time of the alleged incident and also for the Investigating Officer to record the statement of Md Alim on November 19, 2017 vide Ratua PS FIR number 495/17 dated November 18, 2017. Thus, it is evident that the investigation conducted by the Investigating Officer is absolutely perfunctory and motivated at the behest of the officers of WBSEDCL.

1. Please provide me with a copy of the Statement of sole independent witness Md. Alim which was recorded on November 19, 2017 under section 161 Cr.P.C. by the investigating officer.
2. Please provide me information whether the investigating officer recorded the

said statement under the jurisdiction of Ratua Police Station area.

3. Please provide me information whether the investigating officer recorded the said statement in a foreign country.
  4. Please provide me with a copy of Travel-Document and PASSPORT of the investigating officer [If the said statement recorded in a foreign country]
  5. Please provide me with a copy of the Travel-Document and PASSPORT of Md. Alim being the sole independent witness [If the said statement recorded in India]
  6. Please provide me with information whether the statement of Md. Alim being the sole independent witness is genuine.
  7. Please provide me information whether the investigating officer recorded the said statement in a foreign country as per the provisions of the Police Act.
- Your authority may transfer whole or part of this RTI Application to the appropriate authority [Another S.P.I.O.] u/s 6(3) of the RTI Act, 2005 if necessary.

To the best of my knowledge, the information sought does not fall within the restrictions contained in section 8 (Exemption Clause) and 9 (Rejection Clause) of the RTI Act, 2005.
