

The Humble Complaint of the Complainant Most Respectfully Sheweth:

1. Details of the Public Authorities Involved:

• SPIO Details:

State Public Information Officer (SPIO) Dy. Superintendent of Police (H.Q) Office of the Superintendent of Police, Malda Mohan Road, Post–Mokdumpur, P.S. English Bazar, Malda – 732103.

• First Appellate Authority (FAA):

Additional Superintendent of Police (H.Q) Office of the Superintendent of Police, Malda Mohan Road, Post–Mokdumpur, P.S. English Bazar, Malda – 732103.

2.1 Grounds of Complaint:

- I. Illegal & vague reply by SPIO vide Memo- 5422/E, dated 27.09.2023.
- II. The SPIO supplied only a one-line vague and evasive reply, arbitrarily invoking Section 8(1)(j) without any justification, reasoning, or applicability test.

This constitutes:

- Illegal denial of information
- Violation of Section 7(1)
- Violation of Supreme Court orders requiring reasoned exemption orders
- **Misuse of Section 8(1)(j),** which applies only to personal information, not public records.

2.2 FAA mechanically upheld the illegal order on 17.10.2023.

The FAA passed a non-speaking, mechanical, copy-paste order, again without:

- Hearing the appellant
- Examining the RTI request
- · Applying judicial mind
- Recording reasons

Thus the FAA violated:

- Section 19(1) & 19(6)
- Principles of natural justice
- Supreme Court directives requiring "reasoned appellate orders"

3. Violations of Supreme Court & High Court Judgments:

The SPIO & FAA have violated binding legal precedents:

(a) SC: CBSE v. Aditya Bandopadhyay (2011)

RTI exemptions must be strictly interpreted and require proper reasoning.

- (b) SC: Bihar P.S.C. v. Saiyed Hussain Abbas Rizwi (2012)
 Section 8(1)(j) cannot be invoked without justification and reasoning.
- (c) SC: Maneka Gandhi v. Union of India (1978)

 Administrative orders must be fair, reasoned, and non-arbitrary.
- (d) Bombay High Court Prakash K. Badave v. State of Maharashtra (2013)

 Delayed or vague reply = illegal denial of information.
- (e) CIC: R.K. Jain v. Ministry of Finance (2006)

 Non-response or vague response = deemed refusal under Section 7(2).

Thus, both SPIO & FAA have deliberately committed statutory violations.

4. Criminal Liability of SPIO & FAA

Under the RTI Act and IPC/BNS 2023:

- Public servant knowingly disobeying the law.
- Public servant deliberately protecting wrongdoers by illegal denial of records.
- Public servant making a corrupt or malicious order.
- Criminal Breach of Trust by Public Servant
- Forgery for Purpose of Cheating

Criminal Conspiracy

These offences attract **criminal proceedings**, and I request WBSIC to order a higher-ranked officer to initiate such action.

5. Liability under Section 20 of RTI Act

Both SPIO & FAA are liable for:

- Penalty of ₹25,000 each
- Disciplinary proceedings
- Departmental enquiry under service rules
- Entry of misconduct in their service book
- Direction to provide information free of cost

Their actions were:

- Malafide
- Deliberate
- Unreasonable
- In violation of law

Thus mandatory penalty under **Section 20(1)** must be imposed.

FAA is liable under **Section 20(2)** for failing to perform the quasi-judicial function.

6. Prayer Before the Hon'ble Commission:

The Complainant therefore prays that the Hon'ble Commission may kindly:

- a) Direct the SPIO to furnish all information point-wise as sought in RTI dated- 03/09/2023.
- b) Impose maximum penalty on the SPIO & FAA under Section 20(1).
- c) Order disciplinary action & departmental enquiry against them under Section 20(2).
- d) Direct the Superintendent of Police, Malda to record their misconduct in their Service Book.
- e) Direct initiation of criminal proceedings under IPC/BNS 2023 by a higher-ranked officer.
- f) Direct immediate supply of complete information free of cost under Section 7(6).
- g) Pass any other order deemed fit in the interest of justice.
