Ref. : RTI Application filed to SPIO, Turturi Khanda G.P. on 25/08/2023, SPIO, Turturi Khanda G.P. transferred the application to SPIO, Kumargram Block Office on 29/08/2023 & reply of SPIO, Kumargram Development Block vide no. 1782/BDO/KMG, Dt. 20/09/2023 (received on 07/10/2023).

Respected Sir,

I, Rebati Goutam, citizen of India filing First Appeal in front of you as I am not satisfied with the answer given by SPIO against my RTI Application. The SPIO's reply contradicts with the Gram Panchayat's words & action is as under :

- Q.1 Identification of eligible IHHL Beneficiaries is conducted by Gram Panchayat-
which was already denied by SPIO, Turturi Khanda G.P. and transferred the application to SPIO, Kumargram Block Development Office for all liability of reply as they are not involved in any activity.
- Q.2 Field Verification of IHHL application is conducted by Gram Panchayat-
which was already denied by SPIO, Turturi Khanda G.P. and transferred the application to SPIO, Kumargram Block Development Office for all liability of reply as they are not involved in any activity.
- Q.3 Geotag of IHHL has been done by RSM sometimes it may be done by other sources -
What is RSM & who are other sources appointed by G.P./Block/District is not clear and not given the stage wise details with individual agency.
- Q.4 No such document exist-
Which is not satisfactory reply. As nobody/any agency will conduct survey/Identification, Field Verification & Geotag without the authorization/deployment by any authority such as G.P./Block/District who appoints/deployed the personnel/Agency for the specified work -Identification, Field Verification & Geotag of asset/proposed site. It is ridiculous to know that there is no linkage document exist with administration about the implementing agency/hired agency.
- Q.5 Details enclosed herewith-
There is no rejected list of SBM(G)-I & other schemes provided.
- Q.6 Identification, Verification is done by Gram Panchayat-
Responsibility of Geotagging of proposed site/IHHL Asset under the G.P. is not clear. Also there is no any remarks regarding the deployment of anyone by Block or District is done or not done.


