





**Sub: - 1st Appeal under section 19(1) of the RTI Act, 2005 – False/
misleading information provided by JRCS, (KMAH) against RTI
application dated 08.12.2024.**

Sir,

Enclosed please find a copy of the reply dated 28.01.25 of JRCS, KMAH Cell to my RTI application dated 08.12.24 wherein the information that has been provided; marked “A-1”, is found false/misleading [u/s 18(1) (e) of the Act] due to the following reasons: -


1. No specific replies have been provided to my two queries.
2. The Hon’ble Tribunal ordered, marked “A-2” *“Let a copy of this judgement be sent down to the Registrar of Co-operative Societies, W.B. along with L.C.R. immediately for his information and taking necessary action”*
3. Accordingly, the same was received (19.06.24) by the RCS, W.B. and direction was issued (21.06.24) with alacrity upon the JRCS, KMAH, marked “A-3”, since JRCS, KMAH being the sole authority under the RCS, W. B to monitor Housing Co-operative Societies under Kolkata Metropolitan Area, *“for information and taking necessary action accordingly”*. It is not clear what further direction is being expected by the JRCS and from whom, even after crystal clear order of the Hon’ble Tribunal? Then on what basis and against which particular query, it has been stated that **“All parties shall abide by the judgement including the appellant”**? All parties implied and included the appellant, which should have been noted.
4. The appeal was primarily against the prevalent malpractice of illegal collection of the development fund by the society and the order of the Tribunal included direction upon

the errant society to pay amount of Rs. 50,000/- to the appellant along with interest @ 12% by 30.06.2024, which has been totally ignored/ overlooked by the JRCS for reasons best known to him/ her since not at all mentioned in the reply provided whereas the direction upon the Appellant has been given sole weightage.

I will be grateful, if in exercise of the powers conferred under section 19(1) of the RTI Act, 2005, the matter is looked into appropriately so as to expedite furnishing me the true desired information immediately without any further delay.


I am aggrieved by the unjustified order without citing any reason, passed in Appeal no. 431 dated 14.01.25, marked "A-1", upholding the false/ misleading information provided against my RTI application dated 08.12.24 due to the reason stated below: -

In response to query no. 2 of my RTI application dated 18.10.24, marked "A-2", "*Whether any action has been initiated thereon as per orders of the Tribunal? If so, please elaborate and provide a copy of the correspondences/ direction issued by the Registrar, if any*", it was categorically stated in reply dated 06.11.24 of the ARCS (Law), marked "A-3" that, "*Yes, a direction was given by the Addl. Registrar of Co-operative Societies (Law) on 21.06.24 upon the JRCS, K.M.A.H. vide this office Memo no. No. 1159/IV- 1421/88 dated 21.06.24 (copy attached)*". There can be no ambiguity upon any open mind that a crystal-clear direction was issued officially with alacrity upon the JRCS, KMAH as per statute for taking necessary action accordingly, which has been blindly refuted by the JRCS in his office memo. No. 151/IX-01/05/KMAH dated 28.01.25, marked "A-4" but the misleading/ false information of the JRCS was endorsed by the AA as being proper.

It is requested to review the order in the appeal in the light of the facts stated above and issue orders upon the JRCS to furnish the true information without any further delay.



FACTS ON RECORD

Perused the Appeal submitted under section 19(1) of the RTI ACT, 2005. From the papers submitted before the Ld. Appellate Authority, it was found that the SPIO, Coop. Dte. (HQ) forwarded the original RTI Application dated 08.12.24 to the Jt.RCS (KMAH Cell) vide I/596383/2025 dated 14.01.25. The Jt.RCS (KMAH Cell) and deemed SPIO sent a reply to the SPIO, Coop. Dte. HQ, vide.151 dt. 28.01.25. After receiving the reply the information was sent to the appellant vide 299 dt. 06.02.25.

OBSERVATION

It reveals from the facts and relevant documents that, the Jt.RCS (KMAH Cell) and deemed SPIO supplied the required information point wise sought for by the applicant. The reply from the end of deemed SPIO was accurate. It is also observed that query no.2 is not information as defined in RTI Act 2005.

ORDER

After going through the papers, documents, submission and after observation, it is found that the deemed SPIO & the Jt.RCS (KMAH Cell) supplied proper information. As such there is no direction for the SPIO and deemed SPIO.

Thus the Appeal of Alope Singh was disposed of.


