

BACKGROUND:

I had submitted an RTI Application on 20/03/2024 to the SPIO, Sub-Registrar of Uttar Dinajpur District, Karnajora- 733130, Raiganj, West Bengal for certain information, under the RTI Act 2005. I sent the said application through India Post vide Tracking No.- EW957035196IN, dated- 21/03/2021.

A copy of the said RTI application and India Post Slip is attached herewith. (Total- 3 pages)

GROUND FOR FIRST APPEAL:

I, applicant humbly submits as under:

- a) That SPIO, in reply to Point A to B of my application, the SPIO supplied misleading, incomplete, wrong and partial information without deeply understanding the query and requirements/information of Point A to B of my application. I am unable to understand at this stage that SPIO even try to read my application in-patient. I clearly stated that (i) "Whether the Deed No. 3690 of 1963 vide Volume No. 54 and Page No. 8 to 10 which was registered at Islampur ADSR Office, Uttar Dinajpur is readily available under your custody or not." And (ii) Whether the Deed No. 3691 of 1963 vide Volume No. 54 and Page No. 11 and 13 which was registered at Islampur ADSR Office, Uttar Dinajpur is readily available under your custody or not.
- b) The SPIO without giving any thought, replied to my application just to avoid the delay of one month period of statutory provisions and did not provide correct information/documents instead of that the SPIO is directing me in reply to follow State enacted law instead of Central enacted law which is against the RTI Act.
- c) The SPIO is clearly violating Sec. 2(f) 'Information means any material in any form including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any provide body which can be accessed by a public authority under any other law for the time being in form but does not include "file notings"'.

- d) Despite the Sec. 22, "Act to have overriding effect. The provisions of this Act shall have effect notwithstanding anything inconsistent therewith contained in the Official Secrets Act, 1923 (19 of 1923), and any instrument having effect by virtue

of any law other than this Act." which clearly state that the Central Law override state laws however the SPIO issues direction to me to follow the state enacted law which is against the Section 22 of the Act.

Thus, SPIO is expected to provide the information available with him. Hence, this First Appeal is made under Section 19(1) of the RTI Act 2005.

MY PRAYER/PLEA IN THIS FIRST APPEAL:

1. Instruct the SPIO, in writing, to give complete information as requested in my above-mentioned RTI Application.
2. Issue a written warning to the SPIO, under the present Rules and Regulations of Service, instructing him that he should adhere to the *Sec. 2(f) and Sec. 22* of the RTI Act 2005 as well as respect the RTI Act and provide sought information.
3. Inform the concerned SPIO that the appellant will move a Second Appeal before the WBIC under Section 19(3) and will demand imposition of Penalty under Section 20 of the RTI Act, at the rate of Rs. 250.00 for every day of delay (subject to a maximum of Rs. 25,000.00) from the date the information was due till the date the full information is actually given to me.
4. As per Sec 7(6) of the RTI Act, the SPIO should now provide me the information "free of charge" since the provision of information has been delayed beyond the mandated 30 days as provided in Sec 7(1) of the RTI Act.
5. I want to be heard during the first appeal and will be available on Mobile: 7908323949 and email: rtianisur@gmail.com.

It is therefore requested you to conduct a proper hearing for this First Appeal and instruct to SPIO to supply of required Information.
