Sir/ Madam,

This is to bring your kind attention that an RTI letter was submitted before Deputy Controller (R), R.R. & R. Department, Office of the S.D.O., Barrackpore on 29/01/2024.

Reply of that RTI application was received from Office of the Deputy Controller (R), L & L R and R R & R Department, R.R. & R. Wing on 28/02/2024 by hand. Though, I asked for information relating to L.O.P. or E/P No.82A, the reply received on L.O.P. or E/P No.82. Moreover, as per reply, the L.O.P. 82 was allotted in favour of Smt. Nani Prava Banerjee **wife of Late Nihar Ranjan**, whereas, in reality, these two persons are separate plot holders as well as they have no relation. Nihar Ranjan is the plot holder of L.O.P. No. or E/P No.82, Being No.13 and Smt. Nani Prava Banerjee is the plot holder of L.O.P. No. or E/P No.81, Being No.25.

Therefore, as far as knowledge goes, this is a misinformation mentioned in this reply.

I, therefore, prefer **First Appeal** before you to pass correct information as sought for R.T.I. application dated 29/01/2024 regarding L.O.P. or E/P No.82A.

Grounds of Appeal : To rectify Wrong information.
