

I have done my 3 years of Degree Course in BACHELOR OF COMMERCE (1995-1998) from your esteemed organization and passed in the year 1998.

On that point of time total percentage of marks obtained was not mentioned in the mark sheet/Certificate. But presently, to take admission in any course (like general studies, vocational courses, professional courses etc.) percentage of marks is the only criteria and the same needs to be clearly mentioned in the final mark sheet / Certificate of Graduation.

In total 3 years of my Degree course in Bachelor of Commerce, I have scored 639 marks out of total 1400 marks. So, if the Percentage is calculated it comes 45.64%.

In the period of Covid-19 we have faced critical situation in health, faced financial crisis, loss of family members. Since then we all are struggling for livelihood of my family. My husband is working in a private company and his income is not enough to meet all our expenses after Covid situation. Therefore, I have decided to earn some amount of money to support my husband and to give good health, proper food and education to my family members including my daughter and elderly father and mother. I have also several ailments which are not curable but controllable, for which also we need a good amount of money.

In this situation, as a graduate from your University, I have decided to do some professional decree course so that I can earn some money at my own. For last 3 years I am trying to get admitted in some professional courses but no one accepted my application as my percentage of marks obtained is not mentioned in the Certificate.

In this situation, I found that I can get admission in some professional courses if my percentage of marks would have been mentioned in the Certificate of my Bachelor Degree of Commerce.

Not only that I have tried for some jobs but in most of the cases the minimum percentage is 45% in Degree Course. If I calculate my percentage by way of dividing marks obtained by total marks, it comes to 45.64%. But as the same

has not been mentioned in the certificate of Degree Course, I am not being able to get a proper job and/or admission in any educational / professional course.

Therefore, to get that information in respect of my percentage of marks in my 3 years Degree Course, I have applied through RTI Act to the State Public Information Officer.

Hope, you will consider my prayer and help me in getting my percentage of marks obtained in Degree Course of Bachelor of Commerce.




