Appellant begs to state as follows:-

1. That the appellant filed RTI application on **10-06-2024** before the State Public Information Officer Office of the BL & LRO, Bhatar, Vill + P.O. + P.S. -Bhatar, Dist. – Purba Bardhaman, Pin – 713125 and he did not reply the said RTI Application intentionally.
2. Thereafter the appellant repeatedly requested to reply the said SPIO but the said SPIO not given the **Authenticated Copy/Certified Copy of the R.S.R.O.R** as mentioned in the said RTI Application.
3. Thereafter on 20/07/2024 the appellant is given reminder to the said SPIO to reply the said RTI application and Sec.20 Penaly clause of the RTI Act 2005 but the said SPIO intentionally not given any answer of the said RTI application.
4. Thereafter the appellant filed the **Appeal** of said RTI application being **RTI Appeal No.62/2024** before the **The FAA, Office of the DL & LRO, Purba Bardhaman, Pairakhana, Bardhaman, West Bengal 713101** on **13-08-2024**. Thereafter the **1st Appellate Authority ordered** the said Appeal Case on **11/09/2024** "**that the SPIO and BL & LRO Bhatar is directed to respond as per the query of the petitioner within two weeks from the communication of this order**" and the said SPIO intentionally not given any answer of the said RTI application after the order of the of the said First Appellate Authority.

5. That thereafter the appellant filed letter to the said SPIO and 1st Appellate Authority on 28/07/2025 but they did not give any reply in respect of the said RTI application
6. That the Appellant further submits that in Sec.20 of the RTI Act 2005 Penalties are mentioned as follows-(1) Where the Central Information Commission or the State Information Commission, as the case may be, at the time of deciding any complaint or appeal is of the opinion that the Central Public Information Officer or the State Public Information Officer, as the case may be, has, without any reasonable cause, refused to receive an application for information or has not furnished information within the time specified under sub-section (1) of section 7 or malafidely denied the request for information or knowingly given incorrect, incomplete or misleading information or destroyed information which was the subject of the request or obstructed in any manner in furnishing the information, it shall impose a penalty of two hundred and fifty rupees each day till application is received or information is furnished, so however, the total amount of such penalty shall not exceed twenty-five thousand rupees: Provided that the Central Public Information Officer or the State Public Information Officer, as the case may be, shall be given a reasonable opportunity of being heard before any penalty is imposed on him: Provided further that the burden of proving that he acted reasonably and diligently shall be on the Central Public Information Officer or the State Public Information Officer, as the case may be. (2) Where the Central Information Commission or the State Information Commission, as the case may be, at the time of deciding any complaint or appeal is of the opinion that the Central Public Information Officer or the State Public Information Officer, as the case may be, has, without any reasonable cause and persistently, failed to receive an application for information or has not furnished information within the time specified under sub-section (1) of section 7 or malafidely denied the request for information or knowingly given incorrect, incomplete or misleading information or destroyed information which was the subject of the request or obstructed in any manner in furnishing the information, it shall recommend for disciplinary action against the Central Public Information Officer or the State Public Information Officer, as the case may be, under the service rules applicable to him.

7. That as per Sec.20 of the RTI Act the penalty clause (Rs.25,000/-) will be imposed against the said SPIO and the appellant is entitled to get the said Cost.

8. That **Sec 2(j)** of the RTI Act 2005 clearly defined "**right to information**" means the right to information accessible under this Act which is held by or under the control of any public authority and includes the right to—
(i) inspection of work, documents, records;
(ii) taking notes, extracts or **Certified Copies of documents** or records;
(iii) taking certified samples of material;
(iv) obtaining information in the form of diskettes, floppies, tapes, video cassettes or in any other electronic mode or through printouts where such information is stored in a computer or in any other device;

9. That after getting **your notice of hearing in this Case the said SPIO reply to the appellant on 12-02-2026 of the said RTI "that the Certified Copies of RS Khatian No.335,336,2946 and 2947 is not readily available and searching is still going on and you will be informed accordingly when it be available"**. That after **one and half year later** the said SPIO reply the said RTI Application which is incomplete.

That under the above facts and circumstances your appellant prays before your Honour- **(i)** to direct the said SPIO to immediate supply the said **the Certified Copies of RS Khatian No.335,336,2946 and 2947** as soon as possible without fail.

(ii) to impose **penalty** against the said SPIO as per **Sec. 20 of the RTI Act, 2005** and to pass other order/orders as your Honour may deem fit and proper.





Facts on Record :

1. Shri Braja Binod Koner (hereinafter referred to as the appellant) submitted two second appeals before the commission against one RTI application as noted above filed to the SPIO, BL & LRO, Bhatar, Purba Bardhaman seeking the following information;
 - i) Please provide the certified copy of R.S. R.O.R. being Khatian Nos. 335, 336, 343, 1715, 2946 & 2947 in respect of Mouza - Barabelum, PS- Bhatar, Dist- Burdwan, J.L. No. 93.
2. Ground for second appeal was non-response of the SPIO and relief sought is to provide the information.
3. The SPIO has replied to the appellant vide memo no.155/BLLRO/Bhatar/2026 dated 12-02-2026 that out of six Khatians, two Khatians are available in the office. For the remaining four Khatians, a Search Team has been formed for the purpose.

Decision and Deliberation

4. The appellant was represented in person by Mr Sk Nurul Islam. Both the SPIO and FAA were present virtually.
5. Mr Sk Nurul Islam, representing the appellant, submitted that he is the real appellant on whose behalf the instant RTI application has been filed by the appellant / advocate. However, the Commission noted that the RTI application does not mention any such fact. It is seen that the appellant has been replied vide para 3 above. The SPIO was directed to expedite the search for the remaining information within fifteen days.
6. If the documents / files are untraceable and/or missing, the SPIO is directed to take following actions :
 - a) He should file a complaint with the local Police Station about the missing / lost documents / files.
 - b) Appellant should be informed about this fact along with the Police Station's reference.
 - c) He should submit the same facts to the Commission in the form of an affidavit.
 - d) The SPIO should reply within a month. The case is closed.
7. The matter is disposed of.
