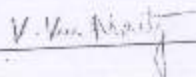

Dear Sir,

This refers to the captioned application and the appeals filed in connection herewith. In this connection, the undersigned likes to state as follows:-

1. As per this office record such letter has not been received by this office. But a letter has been received on 05-01-2023 and you have met with the Assistant Engineer, Contai Sub-Division, PHE Dte at that day and requested for water connection in your premises. A team of Contai Sub-Division, PHE Dte have visited repeatedly 3(three) times to your house to connect the FHTC, but at you were absent from your house. So, No work could not be done.
- 2 & 3. The FHTC connection was done in the premises of Sri Kedarnath Maity on 04-01-2023 as per DMIS report and at that time the Contai Sub-Division Office was unaware of interim injection of Hon'ble Civil Judge, Contai.
- 4, 5 & 6. After receiving the information from the Hon'ble Civil Judge, Contai, The Technical Team went to your premises for FHTC connection on 11-05-2023. But Sri Kedarnath Maity, his Son and some other local people forcefully obstructed to lay the pipe line through his premises. They said to lay the pipe line through a small plot nearby. But as reported by the Assistant Engineer, Contai Sub Division, PHE Dte you have claimed for FHTC connection through the disputed plot only, so, no work could not be done by them.

In this respect this is to inform you that this case is under the judgement of the Hon'ble Contai Court. And as per his kind instruction No.- TS 288 of 2022 an further enquiry has been done on 15-05-2023 and the report has already been submitted to him for necessary action by the Assistant Engineer, Contai Sub-Division, PHE Dte.

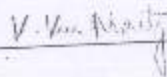

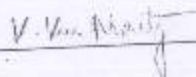

- b) The RTI application submitted at the office of the SPIO; but incomplete information has been provided by the SPIO; even after submitting the first appeal.
- c) This is a case of denial to provide the proper information to the citizen where the Section 3 of the RTI Act, 2005 clearly states, "subject to the provision of this act all citizens shall have the right to information". Thus, all citizens are entitled to obtain all information available with the public authorities subject to the provisions of the RTI Act.
- d) Section 7(1) categorically states, "subject to the proviso of Section 5(2) or the proviso of Section 6(3), the Central Public Information Officer or State Public Information Officer, as the case may be, on receipt of a request under Section 6 shall, as expeditiously as possible, and in any case within thirty days the receipt of the request, either provide the information on payment of such fees as may be prescribed or reject the request for any of the reasons specified in Section 8 and 9.
- e) The SPIO didn't provided the complete information not for any of the reasons specified in Section 8 and 9.
- f) The First Appeal application submitted before the FAA under Section 19 to for the necessary steps; but neither responded nor provided the information by the appellate authority to the

applicant based on the request letter submitted under the RTI Act.

g) This Second Appeal is made for bonafide and for the ends of Justice.

16. Relief sought under Second Appeal :

 - d) Pass an order directing to take the disciplinary action against SPIO for violating the RTI Act.
 - e) Any other order/ orders and / or direction or directions as the West Bengal Information Commission may deem fit and proper in favour of the Appellant/ Petitioner.
