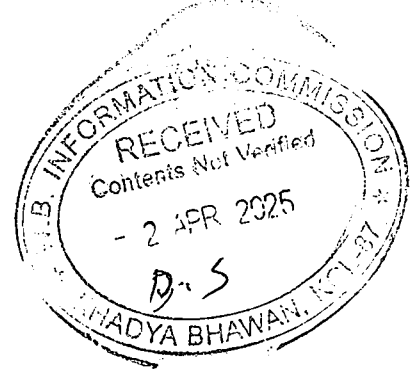

4. Reason for Second Appeal:

- Non-provision of Information:

WBMSC has failed to provide the requested information as per the RTI Act within the stipulated time period of 30 days.

- No Response to First Appeal:

Despite filing the first appeal on 31.01.2025, no response was received, further compelling the filing of this second appeal.

- Violation of Fundamental Rights:

Denying access to this information violates the fundamental right of every citizen to access

information, as enshrined under Article 19(1)(a) of the Constitution of India.

- Violation of RTI Act:

WBMSC has failed to adhere to the mandatory provisions under Section 7, Section 19, and Section 20 of the RTI Act, which entitles me to file a second appeal.

- Legal Precedents:

Supreme Court judgments, such as the CBSE v. Aditya Bandopadhyay (2011) case, reaffirm that transparency in public exams is a crucial constitutional right.

- Failure to Provide Information as per Public Interest:

Withholding information regarding public exams undermines public interest and fair competition.

- Violation of the Right to Equality:

Article 14 ensures that all individuals are treated equally under the law. The denial of information regarding exam results, cut-off, and answer sheets contradicts this principle.

- Judicial Precedent on Public Examination Transparency:

In the case of D.A.V. College v. Director of Education (2008), the Supreme Court emphasized the importance of transparency in public exams.

- Section 4(1)(b) Violation:

WBMSC has failed to maintain records or provide access to records related to the examination process, which is mandated under Section 4(1)(b) of the RTI Act.

- Failure to Follow Section 6 of the RTI Act:

Section 6 of the RTI Act obligates the public authority to provide information within the prescribed time period. WBMSC's failure to comply constitutes a violation of the Act.

- Right to Inspection of Records:

As per the provisions under Section 2(j) of the RTI Act, I have a right to inspect the records of the examination, including OMR sheets and answer sheets.

- Legitimate Expectation:

I have a legitimate expectation of receiving the requested information, which is vital for

understanding my performance and ensuring transparency.

- Penalty for Non-compliance:

Section 20 of the RTI Act prescribes penalties for failure to provide information in a timely manner. I request that such penalties be imposed on WBMSC.

- Non-Compliance with Supreme Court Directives:

The non-disclosure of such information contravenes the principles outlined in several judgments by the Supreme Court that stress the importance of transparency in the public examination process.

- Right to Access Information as a Fundamental Right:

The Right to Information is considered a fundamental right under Article 19(1)(a) of the Constitution, and its denial violates democratic values and public trust.

5. My Request:

In light of the above, I respectfully request the Information Commission to:

1. Direct WBMSC to provide the requested information as per the RTI Act.
2. Take action against WBMSC for failure to respond to my first appeal dated 31.01.2025.
3. Impose appropriate penalties under Section 20 of the RTI Act on WBMSC for non-compliance.
4. Provide transparency and public accountability in the matter by disclosing information regarding the Group D written exam and other related documents.

8. Reasons/grounds for this appeal:

1. As there was no reply from the Public Information Officer, to the RTI application dated 30/09/2024 within 30 days, an appeal is preferred before the First Appellate Authority under the Section 19 (1) of the Right to Information Act, 2005.

2. Under the RTI Act, 2005, a PIO is obliged to provide access to information to a citizen unless as stipulated by Section 7 (1), furnishing of such information is covered by one of the exemptions provided under Section 8 or Section 9 of the RTI Act.

3. The PIO has failed to discharge its duties and obligations and has adopted a lackadaisical approach towards dealing with the RTI application by not responding within 30 days of the application.

4. The PIO has failed to inform the applicant as to why this information has not been disclosed to the applicant and its reasons thereof. Section 4 (1) (d) of the RTI Act clearly lays down that every public authority shall have to disclose the reasons for its decisions to the affected persons.

5. It is obligatory upon the PIO to disclose the information as requested by the applicant. The request of the applicant squarely falls within the definition of right to information under Section 2 (j) of RTI Act read with Section 2 (f) and 2 (i) relating to the definition of information and record. The applicant in his RTI application has clearly enumerated the information which he desires and there is no ground whatsoever for the PIO to not to provide him the complete information.

This First Appeal is accompanied by an application for condonation of delay in filing the First Appeal within the stipulated time as prescribed in Section 19 (1) of the RTI Act, 2005 at Annexure 2.

2. The appellants filed second appeals before the Commission as noted above.

3. Grounds for 2nd appeal were non-receipt of information from SPIO & 1st appellate authority. Relief sought for by the appellants are to provide information.
4. (a) An ATR is received from SPIO, West Bengal Madrasa Service Commission vide memo no. MSC/RTI/176/2025 dated 20.08.2025.
(b) It stated that against the Hon'ble High Court, Calcutta order dated 16.07.2025 several appeals have been filed before the Hon'ble High Court at Calcutta. The Hon'ble Division Bench vide order dated 23.07.2025, observed: "...Appointment, if any, made in the meantime shall abide by the result of the said appeal. Commission is directed to inform the appointees of the pendency of the appeal and the appointment letters, if issued, shall clearly mention that their appointments shall abide by the result of this appeal. For those in whose favour appointment letters have been issued they shall also be intimated. Besides, Hon'ble Division Bench by an order dated 18.08.2025 have been pleased to observe: "... In view of the aforesaid assignment, the order dated 5th August, 2025 recording that all the appeals mentioned above have been made C.A.V. stands recalled and shall be listed along with MAT 1162 of 2025 on 21st August, 2025 at 2.00 p.m....".
(c) The SPIO submitted that considering the aforesaid circumstances, the applicants/appellants have been provided their marks of Written Examination of 1st SLST (NT) 2010 Group- D only and answer sheets of Written Examination will be provided after final disposal of the Group-D matter(s) by the Hon'ble High Court.

Deliberations and Decision :

5. The SPIO is present virtually. The attendance of the appellant is as per list vide para 1 above.
6. The cases are discussed as following –
 - (a) It is seen that 56 appellants of the 58 total number have asked 3 questions as following :-
 - i) Please provide me copy of my answer sheet in connection with the written test arising out of the 1st State Level Selection Test, 2010 (Non-Teaching) (Group-D)
 - ii) Please furnish the marks obtained by me in the written test arising out of the 1st State Level Selection Test, 2010 (Non-Teaching) (Group-D)

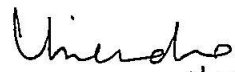
