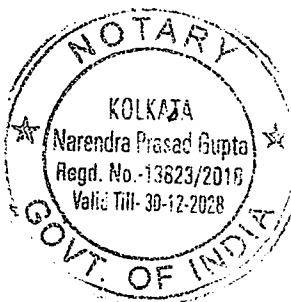

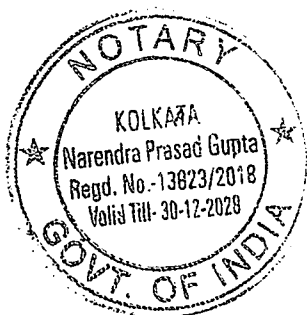

It is most humbly submitted that the NHRC Case No. 4739/25/19/2022 has been instituted on the plea that prayer for mutation of one Uma Ghar in respect of property of the appellant has been illegally denied and as per the direction of the National Human Rights Commission the District Magistrate and District Collector, South 24 Parganas conducted inquiry and submitted a report before the National Human Rights Commission which is adversely affecting the accrued right of the appellant as such the appellant is entitled to receive a copy of such report however the same is being illegally denied by the State Public Information Officer concerned and the First Appellate Authority concerned without any lawful excuse and the same is malice in law and in fact.
- iii. Under such circumstances, I humbly pray before this Learned Tribunal to kindly provide a copy of the full report of the District Magistrate and District Collector, South 24 Parganas dated 06.07.2023 submitted before the National Human Rights Commission in connection with the NHRC Case No. 4739/25/19/2022.
