

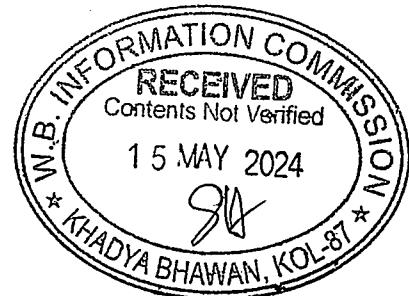

I filed the first appeal Under Section 19(1) on 09/02/2024 for not providing me any information and after the first appellate authority directed the Chief Health Officer North Dinajpur (C.M.O.H) to answer my queries on 22/03/2024 the C.M.O.H gave me an incomplete reply. That is not enough

- 1) I have only been given an answer to my number 1 question in writing
- 2) Copies of documents provided in answer to my question number 2 are not certified copies but only xerox copies.
- 3) They did not answer my question number 4 and number 5 in writing and the two documents they provided are not legible and are not certified copies but I wanted answers to the questions in written form and asked for certified copies.
- 4) As I did not know about the second appeal I again made the first appeal on 28/03/2024 and Received that application on 01/04/2024 has not given me any reply till now so I can take advice from a person to know about the second appeal and request you to arrange where I can get all the information.
