





- 2. The appellants filed second appeals before the Commission and the grounds for 2nd appeal were non-receipt of information. Relief sought for by the appellants is to provide information.
- 3. SPIO, West Bengal Central School Service Commission sent reply to the appellants with a copy to the Commission as mentioned in the table as vide para no. 1.

Deliberations and Decision:

- 4. The SPIO is present virtually. The attendance of the appellant is as per table vide para 1 above. Only one appellant was present in person (SN. 5) & four other were present virtually.
- 5. The Commission noted that Smt. Mondal query no. (i) to (v) was already replied by the CSSC vide their letter no. 109/R-7/CSSC/RTI/2025 dated 03.03.2025 in response to her (earlier RTI application dated 06.11.2024) The WBIC heard on 08.03.2025 the case as second Appeal also and it disposed of vide WBIC order no. 1702/WBIC/RTI/A/100076/176/2025 dated 07.03.2025.

Similarly, it is seen that out of 12 appellants todays, five more appellants namely (i) Smt. Sucharita Pramanik, S.N. 2, (ii) Smt. Nibedita Das Sarkar, S.N. 3, (iii) Sh. Surojit Das, S.N. 6, (iv) Sh. Pronab Kumar Guha, S.N. 7, (v) Smt. Tumpa Maity, S.N. 9, have second time filed RTI application even when they were replied earlier. Their cases were also heard by the Commission in the form of 2nd Appeal and disposed of. These all six appellants are advised that they should not file again and again the RTI application with the same querries. This is wastage of time of the SPIO, FAA and the Commission.

- 6. Out of the 12 appellants only five have been replied by the SPIO. For other seven appellants i.e., SN. 4, 7, 8, 9, 10, 11 and 12, the SPIO is directed to reply within one month.
- 7. The cases are discussed as following -Smt. Smriti Mondal (S.N. 5) - Smt. Mondal is present in person. She expressed that she was satisfied with the reply to her queries for S.N. (i) to (v)
 - a) She discussed the reply to the query from (vi) to (ix) which is about a list of 1463 candidates. She stated that it was the list submitted by the SSC in the Hon'ble High Court and later they were included in the list of eligible candidate for the interview.
 - b) The SPIO was not clear about the issue.
 - c) The Commission observed that the reply of the SPIO regarding total marks obtained in the written examination of TET, Answer sheet / OMR sheet, Academic scores, photocopy of mark sheet of each of the 1463 candidates is alright. But the Commission noted that the issue of 1463 candidates has to be explained. This explanation should be there in the Public Domain.
 - d) The SPIO sought time for clarification about the issue of the list of 1463 candidates. He was allowed for one month time and reply to the candidates about the issue.
- The SPIO is directed to take action vide para 7 and 8 (d) above.
- 9. The next date of hearing for all the candidates is fixed on the 9th December (Tuesday) at 11.30 hrs.

- 2. The appellants filed second appeals before the Commission and the grounds for 2nd appeal were non-receipt of information. Relief sought for by the appellants is to provide information.
- 3. SPIO, West Bengal Central School Service Commission sent reply to the appellants with a copy to the Commission as mentioned in the table as vide para no. 1.

Deliberations and Decision:

- 4. The SPIO is present virtually. The attendance of the appellant is as per table vide para 1 above. Only one appellant was present in person (SN. 5) & four other were present virtually.
- 5. The Commission noted that Smt. Mondal query no. (i) to (v) was already replied by the CSSC vide their letter no. 109/R-7/CSSC/RTI/2025 dated 03.03.2025 in response to her (earlier RTI application dated 06.11.2024) The WBIC heard on 08.03.2025 the case as second Appeal also and it disposed of vide WBIC order no. 1702/WBIC/RTI/A/100076/176/2025 dated 07.03.2025.

Similarly, it is seen that out of 12 appellants todays, five more appellants namely (i) Smt. Sucharita Pramanik, S.N. 2, (ii) Smt. Nibedita Das Sarkar, S.N. 3, (iii) Sh. Surojit Das, S.N. 6, (iv) Sh. Pronab Kumar Guha, S.N. 7, (v) Smt. Tumpa Maity, S.N. 9, have second time filed RTI application even when they were replied earlier. Their cases were also heard by the Commission in the form of 2nd Appeal and disposed of. These all six appellants are advised that they should not file again and again the RTI application with the same querries. This is wastage of time of the SPIO, FAA and the Commission.

- 6. Out of the 12 appellants only five have been replied by the SPIO. For other seven appellants i.e., SN. 4, 7, 8, 9, 10, 11 and 12, the SPIO is directed to reply within one month.
- 7. The cases are discussed as following –

 Smt. Smriti Mondal (S.N. 5) Smt. Mondal is present in person. She expressed that she was satisfied with the reply to her queries for S.N. (i) to (v)
 - a) She discussed the reply to the query from (vi) to (ix) which is about a list of 1463 candidates. She stated that it was the list submitted by the SSC in the Hon'ble High Court and later they were included in the list of eligible candidate for the interview.
 - b) The SPIO was not clear about the issue.
 - c) The Commission observed that the reply of the SPIO regarding total marks obtained in the written examination of TET, Answer sheet / OMR sheet, Academic scores, photocopy of mark sheet of each of the 1463 candidates is alright. But the Commission noted that the issue of 1463 candidates has to be explained. This explanation should be there in the Public Domain.
 - d) The SPIO sought time for clarification about the issue of the list of 1463 candidates. He was allowed for one month time and reply to the candidates about the issue.
- 8. The SPIO is directed to take action vide para 7 and 8 (d) above.
- 9. The next date of hearing for all the candidates is fixed on the 9th December (Tuesday) at 11.30 hrs.
