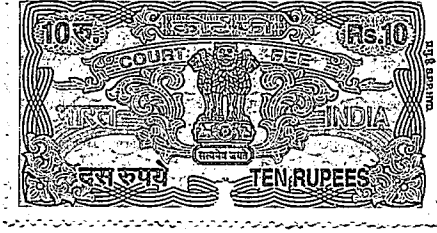

- IV) For that the appellant requires to get supplied the information regarding the list of empaneled and waiting list candidates list with all details in respect of my subject and category, but such information has been refused to disclose by the State Public Information Officer, by maintaining deceptive silence on their part in spite of having such information.
- V) For that the appellant requires to get supplied the information regarding the last date of counselling and last date of appointment and/or recommendation made by your good office for the aforesaid post in respect of my subject and category as specified above, but such information has been refused to disclose by the State Public Information Officer, by maintaining deceptive silence on their part in spite of having such information.
