

Both Appellant Petitioner and Respondent Authority i.e. Dy.S.P. (HQ) & SPIO of Hooghly Rural Police District are present in my office chamber. Both are heard.

Facts:

Through the RTI application dated 16.01.2024, the appellant petitioner sought information from the Principal Secretary, Home and Hill Affairs Department of Government of West Bengal which was received by the office of the Dy.S.P. (HQ) & SPIO of Hooghly Rural Police on 17/01/2024 bearing Memo.No. 22-H (RTI)/1A-12/2024 Dated- 25/01/2024. Accordingly SPIO of Hooghly Rural Police District supplied information to the appellant petitioner vide Memo. No.- 100/RTI-Hgly (R)//RTI Cell/RTI - 01/24 dtd.- 07/02/2024 against which the appellant petitioner appealed before the undersigned mentioning that she is not satisfied with the reply of Dy.S.P. (HQ) & SPIO of Hooghly Rural Police District.

Hearing

During hearing petitioner told to the Appellate Authority that she received a notice dated 15/03/2018 issued by the then Addl. S. P. Hooghly Rural District & Head of the HG Selection Committee for physical verification of credential of candidates pertaining to Enrolment of HG Volunteers and in its evidence she submitted photocopy of said notice which is perused.


In this regard appellant petitioner had sought information in her RTI original petition dated 16.01.2024. On perusal of available records; it has been found that Dy.SP (HQ) & SPIO, of Hooghly Rural has furnished information for point no. (1) as desired by the appellant petitioner. But for point no. (2) & (3), original RTI petition of the appellant petitioner dated 16.01.2024 was forwarded to Commissioner of Police, Chandannagar Police Commissionerate, Chinsurah Hooghly vide his office Memo.No.- 98/RTI-Hgly (R)//RTI Cell/RTI - 01/24 dtd.- 06/02/2024 u/s - 6 (3) of RTI Act'05 after consultation of available records as selection process of Home Guard Volunteers for Chandannagar Police Commissionerate as well as Hooghly Rural Police District was jointly conducted at Chinsurah Police Line under the Supervision of Competent Authority. As a result all documents in this matter are kept under custody of Chandannagar Police Commissionerate. Therefore Dy.S.P. (HQ) & SPIO of Hooghly Rural maintained the process as per RTI Act'05 and in addition Dy.S.P. (HQ) & SPIO of Hooghly Rural also intimated the same to the Appellant Petitioner for further correspondence she may contact with office of the Commissioner of Police, Chandannagar Police Commissionerate. In conclusion the undersigned also told the Appellant Petitioner that she has liberty to appeal before the Commissioner of Police, Chandannagar Police Commissionerate to secure desired information.

Order

Thus appeal petition is disposed off standing with the decision of Dy.S.P. (HQ) & SPIO of Hooghly Rural Police District.

If Appellant Petitioner has any disparity with the decision of 1st appellate authority, petitioner has liberty to appeal before the Second Appellate Authority u/s-19(3) of Right to Information Act '2005 within 90 days from the date of issuance of this order.
