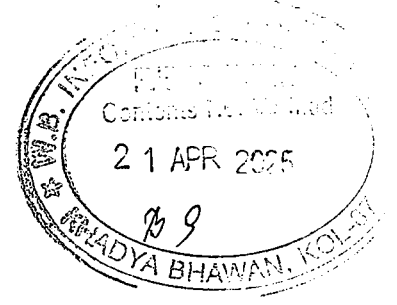

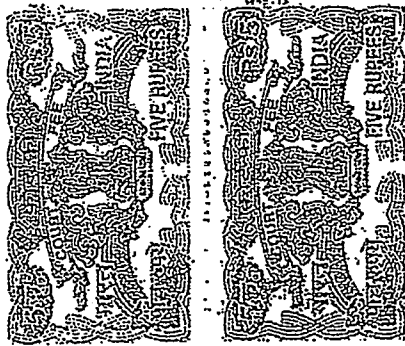


1. Sri Sukanta Kumar Chatterjee, son of Lt. Binay Bhusan Chatterjee, filed an application of RTI to the SPIO, O/o the BL&LRO, Chanchal – 1, on 10/09/2024 for getting case no. 7AA/138/2012.
2. The petitioner was given a reply vide this office memo no. 1147/BL&LRO/CHL-1/2024 dated. 01/10/2024.
3. After that, Sukanta Kumar Chatterjee filed another application of RTI to the Sub-Divisional Land & Land Reforms Officer, Chanchal and DICO, Malda.
4. I am also directed by the Additional District Magistrate (GEN), Malda, vide his good office memo no. 227/GEN (RTI), Malda Dated. 25/11/2024, to dispose the application received from Soupal Chatterjee, Advocate, and also directed to send the reply directly to the petitioner vide his good office memo no. 286/GEN(RTI), Malda dated. 27/12/2024.
5. 

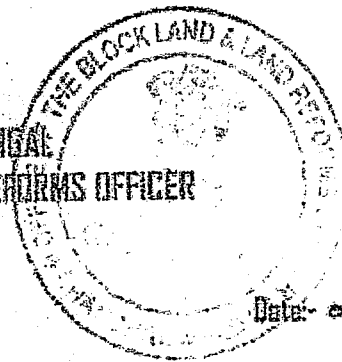

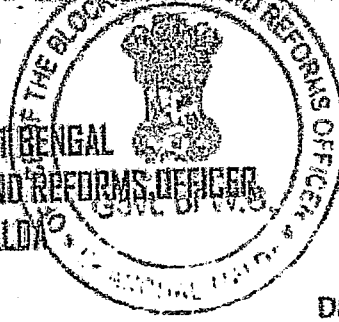
