Dear Sir,

1. The appellant filed an RTI application on 28.09.23 which was received by the office on 29.09.23 seeking three points of information regarding electricity connection bearing CON ID- 501225874. It also revealed from the application that the appellant wanted to confirm whether the said connection belongs to some Krishnakanta Das or not.
2. From the reply of the SPIO vide memo no- ZM/BDN/E-52/2285 dtd- 27.02.24 it is found that on ground of information related to 3<sup>rd</sup> party the SPIO barred to disclose any information under sec 8(1)(d) and 8(1)(j) of the RTI Act, 2005.
3. The 1<sup>st</sup> Appellate Authority has found that the RTI application was more investigation in nature and seeking information about connection of some 3<sup>rd</sup> party namely Sri Krishnakanta Das, which has rightly been denied by the under sec 8(1)(d) and 8(1)(j) of the RTI Act, 2005.

Thus, the 1<sup>st</sup> Appeal petition is hereby disposed off.
