

- (ii) For that, the C.M.O.H. Hooghly by his order dated 18.7.2018 as stated above not furnished information to the appellant/applicant in respect of his query no.3(a); wherein appellant as applicant sought for information, "Please furnish/supply me the details of informations about vacancy to the post of Group-D/ Class IV Staff/ GDA in Hooghly District/ Block wise statement many parts are lying vacant, please furnish me details of statement", and as such he has not furnished full and complete informations to the appellant;
- (iii) For that, in respect of quarry No.3(d) of the said application dated 02.7.2018 the C.M.O.H. Hooghly by his aforesaid memo dated 18.7.2018 not furnished any information to the

appellant/ applicant not furnished any copy of the reformed memo no. HFW/HSDI/331 dated 21.6.2010 therefore the said informations furnished by order dated 18.7.2018 is incomplete and not full and correct particulars furnished and tried to mislead the applicant.
