8. Date of receipt of Decision of the First Appellate Authority (FAA): 18-03-2024. (copy enclosed).
9. Grounds for Second Appeal:
- A) The FAA has not applied his free, fair and judicial mind in his decision vide his Memo No: 822/3/DRSR- 16-01-2023-ESTT SEC-DRSR dt.14-03-2024 (copy enclosed) as per RTI Act, 2005.
 - B) He has not held any hearing as indicated by him. That is absolutely wrong and **NOT** true.
 - C) Only he has quoted the extract of one para of DOPT OM No: 1/3/2008-IR dt. 25-04-2008 to settle the issue.
But that guidelines have been updated vide DOPT OM NO: 1/4/2009-IR dt. 05-10-2009 and further been updated vide DOPT OM NO: 1/32/2013-IR dt.28-11-2013/ 17-02-2015 which he is not aware of.
 - D) The FAA has not given a detailed and speaking order, giving justification for the decision arrived at in terms of DOPT's OM No: 1/32/2013-IR dt. 17-02-2015.
 - E) Section 2(f) and Section 2(i) of RTI Act,2005 read together clearly imply :-
 - i) That an "information" is- which is available in a material form.
 - ii) Such "information" may be in the form of "opinions", "advices" etc. etc. as the CIC observed on 18-01-2008 in a case.
 - F) The FAA has wrongly indicated that the Appellant wants solution of his problem.
In fact, the issue is the administrative problem/ lapse because the administrative personnel of District Registrar/ Raiganj have deliberately committed wrong in the Appellant's registered Deed.
 - G) The Addl. District Sub-Registrar, Raiganj vide his Memo No: 11/ADSR/RGJ/24 dt. 19-01-2024 duly forwarded by District Registrar, Uttar Dinajpur, Raiganj vide his Memo No: 57/1(1)/RTI-2024 dt. 22-01-2024 has "advised" the applicant **either to go to the competent Court of Law OR to file a complaint in the police station.**
Therefore, the related answers/ replies/ information to these particular contexts as raised by him, in other words as opined/ advised by him is definitely held by him. So, the such related information/ replies have been requested vide my appeal to FAA dt. 16-02-2024. (copy enclosed).

10. Brief History of the case i.e. the cause of my RTI application dt. 29-12-2023 received by office on 03-01-2024 (copy enclosed) :

NIWA RANI SARKAR

My (the appellant) Late mother while living executed 03 registered Gift Deeds for a piece of 09 shatak Bastu land among her 03 sons in equal share viz. 1) Swapan Kumar Sarkar (Appellant), 2) Kalyan Sarkar, 3) Debasis Sarkar.

There is an entrance passage which she gifted to her 03 (three) sons to be used as "EJMALI". This has been mentioned in the Registered Deeds of Kalyan Sarkar and

DebasisSarkarat Page-7 marked "AA" where in my name has also been mentioned. **But in my Deed no where it has been mentioned deliberately or erroneously** by the Deed writer, compared by comparer and signed by the Addl. District Sub-Registrar.

The 03 (three) Deeds were written on the same date by the same Deed writer, compared by same comparer and signed by same ADSR.

This evidently proves an administrative lapse.

11. Prayer or Relief sought :

The left out portion (para) as at Page-7 marked "AA" of 02 other Deeds be incorporated in my Deed by issuing corrigendum or a fresh digital Deed incorporating the same **to eliminate administrative error/ lapse.**

** The copies of 3 (three) Deeds of 3 (three) sons are again sent marking similarity and dissimilarity with Red ink for ready reference.

- B) She (my mother) executed the Gift Deed that piece of land among her 3 (three) sons measuring as under:—
 - a) Swapan Kumar Sarkar.

North to South = 34 link
= 2652 sq. link.
 - b) KalyanSarkar.
Same as above i.e. 2652 sq. link.
 - c) DebasisSarkar.
Same as above i.e. 2652 sq. link.
- C) There is one Entrance Passage measuring



Which she executed as ejmali passage (i.e. common passage) to be used by her Aforesaid 3 (three) sons. And such endorsement has been made in the Deeds of my 02 (two) brothers at Page-7 marked "AA" of the Deeds of them.

But those endorsement has not been made in my Deed by the Deed writer and preparer Shri Gopal Ch. Ghosh, License No. 49 (R) though the said 3 (three) Deeds were written and prepared by the same person on the same day i.e. by Gopal Ch. Ghosh.

It is also taken aback that the same has been compared as "TRUE" by one Shri Bimal Ch. Dutta.

****** D) It is not understood as to how my Deed has been certified as "TRUE COPY" by the Additional District Sub- Registrar, Raiganj in spite of containing errors (i.e. left out endorsement at Page-7 marked "AA" of my Deed.) going against the will of the Donor.

In view of the above, please provide the following information:---

- i) The reason of knowingly (as seems) given incorrect, incomplete and misleading information /context at Page-7 marked "AA" in my Deed which attracts section- 20(1) of RTI Act,2005.
- ii) It is requested to kindly arrange for making the same endorsement in my Deed "as left out" at Page-7 (i.e. the ejmali passage as executed by the executant of the Deed) so that the 3 (three) Deeds find uniformity in all respects & show correct information to avoid future complications according to the will of the Donor, *if not done yet*.
- iii) The action taken against the person / persons at fault in this case for making unnecessary harassment to a 73 yrs. old Lungs & heart operated patient like me by committing such gravious intentional wrongdoing in the Deed.

5. I state that the information sought for does not fall within the exemptions contained in Section-8 of the RTI Act,2005.

7. The grounds for appeal: Aggrieved by the reply of SPIO/ District Registrar/ UD vide his Memo No. 57/1(1)/RTI-2024 dt. 22-01-2024 as sent through SPIO, O/O The District Magistrate & Collector, U/D vide his Memo No: 137/RTI/Genl. Dt. 25-01-2024. (received on 31-01-2024).

8. Particulars of information/
Documents required:

The RTI reply given by the SPIO cum District Registrar/ UD suffers from some infirmities such as -----

- a) He has not mentioned his full name and designation under his signature which is as per Govt. Norms.
- b) He has not mentioned the full name and address of the 1st Appellate Authority to whom appeal lies.
- c) The 3 (three) Deeds of ours (3 brothers) containing 24 sheets were submitted for perusal pointing out the errors in writing in my Deed at page/7 marked- "AA", for correction and return of the same to me in the way of information.

But, neither my Deed corrected nor our 03 Deeds returned which costs Rs: 48.00 for xeroxed though these are our documents.

On compulsion, again our 03 (three) Deeds containing 24 pages have to be Xeroxed costing Rs: 48.00 for your ready reference.

The errors at Page-7 of my Deed marked "AA" committed by the Deed writer and dittoed chronologically by the comparer and ADSR.

The details are reflected in my application dt. 29-12-2023, received on 03-01-2024. (copy enclosed).

- d) Any new addition/ alteration cannot be done in the Deed or any Govt. papers/ documents but the errors done in any papers/ documents or a portion of the contents of the Deed/ Govt. papers left out due to administrative lapse can be corrected at any time so far my knowledge goes. And this is the stated case.

⑦

In view of the above, please provide the following:-

- i) My Deed duly corrected the error as committed due to administrator's lapse at Page-7 marked "AA" as per will of the executant of the Deed that has been written in my 02 (two) brothers' Deed at Page-7 marked "AA".

If not, a copy of the circular may be supplied which stipulates that errors committed due to administrative lapse cannot be corrected.

- ii) The executor of the Deeds gifted the passage as ejmali for her 03 (three) sons including me as would be revealed in the Deeds of my 02 (two) brothers at Page-7 marked "AA" but that has not been written in my Deed by the Deed writer, blindly compared by the comparer and certified as "TRUE COPY" by the Additional District Sub-Registrar.

A copy of the circular may please be supplied which stipulates that an empowered Govt. Official/ Officer signing a document has no value or he has no responsibility to that document/Deed containing errors but he has certified as "TRUE COPY" treating him a mere Registering authority.

(This is in context to item (1) of the reply of ADSR/ Raiganj vide his Memo No: 11/ADSR/ RGJ/ 24 dt. 19-01-2024 as sent by SPIO cum DR.) (Copy enclosed)

- iii) This is not a case of addition or removal anything inside the Deed or from the Deed.

This is a case of error committed due to administrative lapse at Page-7 marked "AA" in my Deed which has to be corrected in relation to other 02 (two) Deeds of my 02 (two) brothers in the same place at Page-7 marked "AA".

(This is against item (2) of ADSR's reply dt. 19-01-2024 as sent by SPIO cum DR.) (Copy enclosed)

- iv) Vide my application dt. 29-12-2023, received on 03-01-2024 at clause-(iii) of Page-2, the intention of the context lies that the Govt. official/ Officer concerned signing the document (which becomes authentic after Govt. Officer's signature) can at least "counsel" the person/ persons at fault who wrongly wrote, blindly compared and presented the Deeds for his signature for certification.

"Counselling" is a type of action which vests with the Section Head, Office Head or the officer so far my knowledge goes for proper functioning of the machineries at all spheres.

If not, a copy of the circular to this respect may be supplied to me for my perusal and information.

(This is in context to item (3) of ADSR/ Raiganj's reply dt. 19-01-2024 as sent by SPIO cum District Registrar vide his Memo dt. 22-01-2024.) (Copy enclosed)

- v) A) Please let me inform in which Court of Law, under which section and against whom the case is to be filed as advised.

And who will bear the cost for continuing the case against a matter of administrative lapse?

- B) Please also inform the contents of the complaint to be lodged with the police station and against whom as advised? And in which police station?

(This is also in context to item (3) of ADSR's reply dt. 19-01-2024.) (Copy enclosed)

- vi) Please inform the full address of the State Chief Information Commissioner, West Bengal Information Commission for further requirement, if any i.e. for second appeal under section 19(3) of RTI ACT, 2005, if needed.

In reply to the appeal dated 16.02.2024 received on 07.03.2024, made by Sri Swapan Kumar Sarkar before the First Appellate Authority u/s 19(1) of the RTI Act , 2005 which has been addressed to A.D.M.(General) & First Appellate Authority , Uttar-Dinajpur and forwarded by him vide his Memo. No. 279/RTI/Genl. Dated: 27.02.2024 to SPIO & D.R., Uttar-Dinajpur who has transferred the appeal vide his Memo. No. 152/1(1)/RTI-2024 Dated: 01.03.2024 to the First Appellate Authority of Directorate of Registration and Stamp Revenue, this is to inform that as per para no. 9 of the guideline issued by the Department of Personnel & Training , Government of India vide OM No. 1/3/2008-IR dated 25.04.2008 on the RTI Act , 2005 (may be searched from Google), only such information is required to be supplied under the Act which already exists and is held by the public authority or held under the control of the public authority. It is beyond the scope of the Act to create information; or to interpret information; or to solve the problems raised by the applicants; or to furnish replies to hypothetical questions.

Hearing: Heard the party and SPIO & D.R., Uttar Dinajpur over telephone this day.

The appellant wants some solution of his problem relating to the schedule of his registered deed written by a deed writer. As per above guideline, solution of the problem raised by the appellant is beyond the scope of the RTI, Act, 2005.

With the above decision, the appeal stands disposed of.

However, if aggrieved, the party concerned may prefer second appeal before the State Chief Information Commissioner, West Bengal, Khadya Bhawan , 11A , Mirza Ghalib Street, Kolkata – 700087.
