Ground for 1st appeal: Not satisfied with the reply of SPIO.

We raised a RTI Application vide No. 190/RTI/SED/23

I, **Tabish Ehsan**, being a complainant and getting my FIR Registered with the **Tiljala Police Station** complying section 156 (3) then order passed by Honourable Court of Additional Chief Judicial Magistrate, Alipore, 24 Parganas. Here is a FIR Number vide **71/23** registered with Tiljala Police Station dated **24.03.2024** once again mentioned just & only for your reference and knowing. Still, copy of registered FIR is enclosed herewith.

Now, I would like to bring under your kind notice that, my Lawyer, my concerned Legal Advisor, much respected my senior Ld. Counsel raised RTI Application underneath my permission with your good and much respected office sent via Speed Post & that we even received a reply from the concerned authority and I want to say Thank you to your so called respective office, to the respected Assistant Commissioner of Police (IV) and to the State Assistant Public Officer of South East Division: Kolkata Police. I even want to say Thank you to the Officer In-Charge of Tiljala Police Station in particular and to whole Tiljala Police Station in general, which by default is under your Control.

Q1) In the raised RTI Application my 1st question was, Are both my minor children murdered and are dead by now?

Counter Reply for question 1:-

For the above mentioned question the Authority In-charge of Tiljala Police Station replied me that, No such information received by the PS till now. The authority in-charge of Tiljala Police Station made a point that they recovered both the minor children and produced them before the Ld. CWC, Kolkata on 06/05/2023. Henceforth, the answering authority did not furnish me with any answer which I did not know about not this answer from anywhere relates with the question I asked. The given answer is all together going in different direction and had no relation or nothing to do with the question asked. Still I believe Tiljala Police Station by mistake forgot to mention in this reply of theirs that, just before a couple of days prior to the mentioned date of producing both the children along with her mother which is stated above 06/05/2023 there was the hearing date just a couple of days before at the Honourable Court of ACJM, Alipore, 24 Parganas and my Ld. Senior Counsel was praying the respected Magistrate to Allow CRPC 97 which my legal team had already put up the petition of CRPC 97 and this was the 2nd hearing just before 06/05/2023 as date and action mentioned above. So, in that hearing which was conducted as i mentioned a couple of days back, my Ld. Senior Counsel was presenting his argument in order to pass CRPC 97 as petition was filed with the same Honourable Court of ACJM and this was the 3rd hearing where Tiljala Police Station even after knowing the whole case and the sensitivity of the whole case didn't even moved an Inch to think something over the same and Authority In-charge being the head of Tiljala Police Station was doing nothing even in the regards of recovering at least 2 minor kids. On that hearing date Honourable Court of ACJM scolded the Investigation Officer who was present in the court on that hearing date and as we were present at the court room we as normal law abiding citizen & as well being a complainant also got scared and every entity who was present in the court room at that time heard and

seen the way Honourable ACJM scolded over the negligence and avoiding the seriousness of the case, the much respected our Honourable Court of ACJM, gave Tiljala Police Station last warning in written order to do the needful as far as recovering of kids are concerned and present the children in front of the concerned authority within next date or on the next date I will accept the prayer of complainant and pass the order of CRPC 97. It was then the authority of Tiljala Police Station had to show some movement only because of the strict written order by the Honourable Court of ACJM. As per Investing Officer of this case they already took 3 chances in order to recover the kids but couldn't find them on the address we mentioned. I know that I.O. of the case and Authority In-charge of Tiljala Police Station are providing with fake and false statements which they used in regards of recovering both my minor children. I know that they didn't search at all even for once. Still on the contrary I accept and believe that yes Tiljala Police Station have tried to recover my minor kids and just imagine in a hypothetical situation that they went to the address and that address is a permanent residential address of Accused number 1 and 2 named Md. Rashid

On our complaint suit file so, why did your Authority In-charge of the Tiljala Police Station made NO arrest of Md. Rashid S/O, Syed Sagir Ahmed and Syed Sagir Ahmed S/O, Lt. Eqbal Ahmed a permanent resident of 16, Sapganchi, 1st Lane, Tiljala, Kolkata-700039 as these two mentioned named are the accused number 1 and 2 in the mentioned FIR vide 71/23 and if you go through my complaint a copy which is very available in the Case Diary of registered FIR vide 71/23 alongside a copy of the same is submitted and safe and secured with the Honourable Court of ACJM. In that complaint copy each and every minute details is mentioned which I have to keep repeating writing in any and all the written applications or if any letter I write to any Authority of Government or Public Office. Under such serious charges the accused number 1 and 2 as their names mentioned above are freely moving as and any where they feel like.

Now, I want to draw your attention on the dates as it has great significance which establishes the fact that how careless, ignorant and how negligent the Authority In-charge of Tiljala Police Station is in particular and I.O. and the whole Tiljala Police Station in general. As you see my mentioned FIR vide number 71/23 got registered on 24/03/2023 and in the reply against the RTI Application filed, Tiljala Police Station, themselves are stating the date on which both the minor children along with their mother who is the primary accused and miscreant in this entire case named Nazia Ambreen Quraishi D/o, Lt. Aftab Ahmed Quraishi were produced to Ld. CWC, Kolkata on 06/05/2023. I would request you give a kind attention to what I am going to mention now. The Tiljala Police Station or the Authority In-charge of Tiljala Police Station gave verbal statement to me for 3 times that we made an effort to recover your kids but we could not find your kids, hence we are sorry for that and we are still searching. When I understood that though be the I.O. of this case or the Authority In-charge of Tiljala Police Station is only providing me with fake and false statements, it was then I understood how incapable our Law Enforcement Agency is, in whole of the West Bengal in general but my case is under the jurisdiction of Tiljala Police Station so the Tiljala Police Station along with the concerned authority in-charge of Tiljala Police Station are good for nothing, it was then I decided to take the initiative of searching my children under my own capacity to track where my children are so that I could furnish the

same with the Authority In-charge of Tiljala Police Station and then they might take this pain of going to that exact location and pin point address, if I could furnish them the same as I mentioned. I did whatever needed to be done using my sources and resources in particular and did something which should have been done by Tiljala Police Station. I cracked the location and exact address within 24 hours. I did something which so called Law Enforcement Agency and that too which comes under your control, in specific, Tiljala Police Station along with the Authority In-charge could not do the needful in a period of 40 to 42 days approximately, I on myself under my personal capacity did it in a duration of 24 HOURS and then I went to Tiljala Police Station, met the Authority In-charge in person and furnished his office the required details in order to recover my minor children and it was then, the Authority In-charge in particular and the Tiljala Police Station in general took that pain, sent the required team and I was available along with the team and in my presence they then, recovered both my minor children and produced them along with their mother before the Ld. CWC, Kolkata. Henceforth, as I mentioned above that it took approximately 40 to 42 days to the Authority In-charge of Tiljala Police Station in particular and the Tiljala Police Station in general in order to just to recover my minor children. Your good office could even take this in a way that, which the Authority In-charge of Tiljala Police Station or whole of the Tiljala Police Station which comes under direct control of yours could not do the needful even in 40 or 42 days since my FIR got registered till the date my children were produced before Ld. CWC, Kolkata I did the same within 24 hours of time. I only feel sad for Tiljala Police Station, for Authority In-charge of Tiljala Police Station, for the Law Enforcement Agencies of West Bengal in general and last but not the least, I feel SAD and I PITY on you in person thinking that, the position, the designation and most importantly the chair you are sitting on and in this I include Authority In-charge of Tiljala Police Station as well and leave on to you to think that are you or the Authority In-charge of Tiljala Police Station are capable enough to hold on to that designation you are blessed with and the Chair on which you sit including Authority In-charge of Tiljala Police Station, are you capable enough, are you competitive enough to sit on that Chair as that is not merearl a Chair, what you need to understand is "THAT CHAIR IS OF GRAVE RESPONSIBILITY". I am using this statement only out of the state of dispare. Henceforth, I do not accept the answer provided to me by any of your concerned authority and to state also to bring under your kind notice that, the answering authority did not state anything new in his answer which I didn't knew. I would request your much respected office to kindly sit and take a Calendar in your hand and then calculate that how many number of days and how many number of months has been passed and gone since my 2 minor children were produced before the Ld. CWC, Kolkata and what are the probabilities of anything bad happened with both my minor kids.

NOTE:- [If your concerned office wants to know that what negative and what cruelty a mother a own biological mother can do with her kid, then kindly refer the very recently occurred murder case of a 4 year minor kid of Bangalore, how his own biological mother killed and murdered her own innocent and such a small kid of 4years, may be that could open your eyes and guide you on right path and to take correct and needful decisions on time and execute the same ASAP. before anything goes wrong]

If you go through my RTI Application raised with your department against which I received only so called Technical and Political correct reply, which I do not accept, under any given circumstances, I have mentioned in that RTI Application of mine that, how is Ministry of Home Affairs, Central Government, Ministry of External Affairs, Central Government, Regional Passport Office, Kolkata, Foreign Registration Office, Central Government, Vigilance Commission of Central Government, PSP Division, Intelligence Bureau and Intelligence Bureau of Immigration, Central Government and Of Course The Homes and Hill Affairs, State Government are involved in this case. How they investigated the matter, how they submitted the reports against the same directly to concerned Ministries and based on that Ministry of External Affairs, Regional Passport Office, Kolkata cancelled and revoked the Passport of main accused the miscreant named Nazia Ambreen Quraishi. RTI Applications forwarded to Ministry of Home Affairs have sent the reply to me and it clearly states that, Central Government have sent the files along with the Ministry Letters to various concerned authorities of Government and Public Offices to take proper action against the same and then report back to the Ministries as per the concerned Offices and departments out of which Ministry of External Affairs, Regional Passport Office, Kolkata have already cancelled and revoked the Passport of a primary accused, the miscreant named Nazia Ambreen Quraishi as already mentioned above. The Copy of Reply from Ministry of Home Affairs, Central Government have been enclosed herewith for your reference.

Passport revocation and cancellation letter from Ministry of External Affairs, Regional Passport Office, Kolkata has been enclosed herewith for your reference.

This is just to bring under your kind notice that we have already shared the required documents with Authority In-charge of Tiljala Police Station along with forwarding letter, though it be the Document from Ministry of External Affairs, Regional Passport Office in which Ministry and Passport Office clearly states that the said Passport of Nazia Ambreen Quraishi, issued to her in the month of June, 2020 has been cancelled and a letter again from Ministry of External Affairs, Regional Passport Office, Kolkata is asking the accused to surrender that cancelled Passport back to the Regional Passport Office, Kolkata and both the documents have been submitted with the Authority In-charge of Tiljala Police Station along with my forwarding letter. The concerned letter where Ministry of External Affairs, Regional Passport Office, Kolkata is asking to surrender the cancelled passport and the document issued by Ministry of External Affairs, Regional Passport Office, Kolkata has been enclosed herewith for your reference.

No accused by himself or herself goes to the Regional Passport Office to surrender that passport which the ministry has cancelled on their own after an investigation conducted by the Law Enforcement Agencies of Central Government, for they all know the intensity and seriousness of the case filed against them. It is then the duty of concerned Authority In-charge of the Police Station to confiscate the documents one and all and once the Police Station confiscate all the original documents, though it be Passport of the accused, Voter Card, Pan Card or Aadhar Card and then report the same to Honourable Court of ACJM and then surrender all the seized documents and Nationality Cards before the Honourable

Court, though it be any court where the matter is being heard by Ld. Magistrate or respected Judge and it will be kept deposited with the Honourable Court itself until any verdict issued against the same. Like, in my case, Authority In-charge of Tiljala Police Station should have seized all those documents of the primary accused named Nazia Ambreen Quraishi and should have informed the Honourable Court of ACJM and surrender the same, the seized documents to the Honourable Court of ACJM. But then, I believe why would the Authority In-charge of Tiljala Police Station needs to take so much of pain, so let it be how it is, because those minor children are neither the children of the Authority In-charge of the Tiljala Police Station nor of the Deputy Commissioner of Police of South East Division: Kolkata Police. So yeah, take it easy and be cool and relax for both the Authorities have their Chair allotted by the Government of West Bengal., my pray for you is kindly sit on those respected chairs and Relax... No issues...

So, like I mentioned above that me and my Syndicate of legal advisor and above all my Lawyer who stands in the argument for me respected senior Ld. Counsel. Reject this reply of yours. The way concerned authority has answered the very 1st question of mine which is a question No.1 in my raised RTI Application, that answer itself establishes the fact that how childish and careless attitude of the Tiljala Police Station including the Authority In-charge of Tiljala Police Station and the answering authority of my raised RTI Application has hardly have any knowledge of Law and Judiciary. The answer starts with "**NO SUCH INFORMATION RECEIVED BY THE P.S. TILL NOW**". Then I assume that one fine day a random phone call will be received by Tiljala Police Station stating that, "I AM A GARBAGE PICKER and I am calling from this area and location and while picking up the garbage I found 2 dead bodies and looking those bodies, it seems that these,2 dead bodies are of small kids.

Then the Authority In-charge of the Tiljala Police Station and obviously along with his highly capable other officers from Tiljala Police Station will arrive the place where the dead bodies of minor children and Authority In-charge of Tiljala Police Station could recognize the face of one of the dead body and after confirming it with himself that, Yes, they are the children of the complainant of the registered FIR No. Vide 71/23 both the children are of Tabish Ehsan the complainant of the mentioned FIR VIDE 71/23. After recovering the dead body of both the minors, some authority from Tiljala Police Station will call me and will ask me to come to any certain Government Hospital in order to identification of dead bodies of both my minor kids and then will hand over the dead bodies of my 2 minor kids to me along with a fake and false statements, that, keep patience, we will surely investigate and find out the murderer of both your minor kids but for now, be strong and keep patience and I will be like, such a kind human this officer is and will go gaga over his buttery words and sentences. I am wondering that how big and special will it be as they recovered both my minor children, No issues if they are dead but the point of proud will be that, they recovered both minor kids of Tabish Ehsan, so distribute sweets to whole of the Tiljala Police Station and how could the Authority In-charge miss on to the Office of the much respected office of the Deputy Commissioner for South East Zone: Kolkata as Tiljala Police Station comes under the control of respected Deputy Commissioner as I mentioned above. So, the Tiljala Police Station which comes under the direct control of respected Deputy Commissioner, South

East Division will receive a packet of sweets sent by the Authority In-charge of Tiljala Police Station out of success they achieved and the happiness would be the result of success of recovering 2 dead bodies of minor kids of Tabish Ehsan. I wish if could also be available on this success of yours, I would as well Clap, sing and dance to express my happiness on your success.

On that day, I will feel like the King of some Dynasty and will tap the back shoulders of all the officers of Tiljala Police Station in general and will do the same for Authority In-charge of Tiljala Police Station as they were able to crack down the case and recover both my minor children, it's only that, they are dead, only that part will make us feel a sad couple of times but yeah the truth could not be changed and truth is, highly capable, highly appreciable and in action so quick and fast that how could any Law Enforcement Agency could make such a quick movement and come in action within No time and execute their duty without even losing fraction of second. At last, I give them an applause and then this time me and my lawyer would do a proper Press Conference inviting all the National Media Houses and we will make sure that one very National Media Houses apart from telecasting the Press Conference they need to keep showing the Head Lines over each and every National Media Houses, broadcasted over the Television and Of Course our media conference. We will try to get our press conference telecasted in a time frame when maximum population sees and hear the news. After all, it my duty to let the world know how efficient our Law Enforcement Agencies are in general and Deputy Commissioner office, South East Division: Kolkata Police and Tiljala Police Station along with the Authority of Tiljala Police Station. How could I not thank them for what they did to me and for me. Last time media involvement we kept it a bit low profile and did the needful only with India Today but still all the leading media houses reported published the case in print media & News Papers and gave television interview only to Aaj Tak Bangla, so, that 10 mins. Interview was telecasted only on Aaj Tak Bengali and both me and my lawyer gave our statement in Bengali itself but if necessary, this time we will take proper care of everything so that a mass majority across the globe should know that how good and how efficient our Law Enforcement Agency is, Tiljala Police Station in particular and obviously Deputy Commissioner of South East Division, : Kolkata Police by default will be addressed.

This is to bring under your kind notice that, the place, the location and the address of the home from where Tiljala Police Station recovered 2 of my minor kids and the primary accused named Nazia Ambreen Quraishi, Just after the production of both my minor children along with the primary accused named Nazia Ambreen Quraishi, they left that flat, they moved out from that flat and at this present time I do not have any idea that where both my minor children are but I know where ever they are, they must be with the primary accused and miscreant named Nazia Ambreen Quraishi. Since both my minor children are in the hands of Criminals like this, I fear their life, only if they are alive and not murdered by primary accused named Nazia Ambreen Quraishi along with the help of Md. Rashid and Syed Sagir Ahmed, accused number,1 and 2 in my complaint copy. As soon as i came to know that they have left the place I rushed to the Ld. CWC, Kolkata and informed the respected lady who is also a chairperson of Ld. CWC, Kolkata. She was least interested even to hear what am I saying and after pleading and requesting when she agreed to listen

to me, I informed her that both my minor children along with the accused named Nazia Ambreen Quraishi have left the house and some new family is residing there. Now, on 06/05/2023 when both my children along with the accused was present there, I informed her that it's very dangerous to leave the children with her and I prayed before her that kindly take the children from her and for the time sake let both my minor kids stay in the house of Ld. CWC, Kolkata so that at least they will be safe but then she convinced me that you do not have to worry for an authority from Ld. CWC, Kol. Will keep visiting on every alternate day to the place where your kids are residing and this is how we will take care of your kids until any verdict comes against the FIR you registered against Nazia Ambreen Quraishi and she also promised me that I will have a talk with Authority In-charge of Tiljala Police Station to atleast send the I.O. twice every week just to keep a check for the well being of your children. Now, that day when I went to meet the authority who is a respected lady at Ld. CWC, Kolkata in regards of informing her that my children and the accused named Nazia Ambreen Quraishi are no more in that home and that they have changed the place of stay with the help of Md. Rashid and if you could help me with where both my minor children are then she replied that it's not our concern, it has everything to do with Tiljala Police Station where your FIR is already registered and again file a diary or get new FIR register stating as Minors Missing Complaint. It was then I rushed to the Tiljala Police Station and wrote complaint diary sitting in the passage area and it was just a normal diary for the 2 minors missing complaint. As one of the officer took a written complaint to register the diary, the concerned I.O. of case asked me that what is it about and then I told him everything from top to bottom including the conversation I had with the concerned authority of Ld. CWC, Kolkata and i informed my I.O. that the concerned authority of Ld. CWC, Kolkata has asked me to register a diary related to 2 minor children missing and I am the biological father and guardian of both my minor children. The I.O. of my case denied and said to me that we can't register this case or register diary against the same as we have once recovered both your children and produced them at the Ld. CWC, Kolkata, I told my I.O. that the concerned authority from CWC has only directed me to register a missing FIR or at least missing diary for both the children. Still, my diary concerning the missing of both my minor children was not entertained, hence not registered. Then at that very moment I met the Officer In-Charge of Tiljala Police Station and told him everything from start to end but I was not surprised with the kind of reaction he gave over this information and only told me that, you informed us, we will see to it and now, don't worry and go home. These were the 2 authorities who took me in confidence, at first the respected authority of Ld. CWC, Kolkata and she is a chairperson in that office and took me in confidence assuring me that we will keep proper watch and surveillance over the well being of both your minor children. In fact she was the one who relaxed me and took me in confidence that she will have a talk with Authority In-charge of Tiljala Police Station to keep a check over both the minor children by asking the I.O. of this case to give a physical visit along with a lady officer twice a week in order to confirm the safety and security of both my minor children.

I feel sad for whole of the society in general after seeing with my own eyes and experiencing in person that how do Authorities sitting on a chair and that chair means a grave responsibility and lie to the victims on face just to safeguard their designation and chair they are holding. I feel SHAME, MY HEAD BOWS DOWN and I only feel pity on the authorities

who are holding chairs of designation but i doubt that they hardly know anything or even the meaning of responsibility and today I agree with my senior Ld. Counsel who put up the argument from my end in the Honourable Court of ACJM and on the last hearing date which crossed was on 20/01/2024 in the presence of the Investigative Officer of this case of mine, even addressing the Authority In-charge of Tiljala Police Station that it's almost 1 year approximately, we come in the Honourable Court on every date which respected ACJM orders. At this very moment every ground is clear and certain allegations are established facts over the documented evidences but the Authority of Tiljala Police Station has not made even a single arrest till date. The authority In-Charge of Tiljala Police Station has every ground clear to at least make an Arrest of at least 3 accused namely:- 1) Md. Rashid, 2) Syed Sagir Ahmed and 3) Nazia Ambreen Quraishi but the bitter fact is Authority In-charge of Tiljala Police Station has yet done nothing apart from making fake and false statements and promises to the complainant who is a biological father and a senior guardian of both the minor children and he is only concerned about the well being of his 2 minor children. Hence, apart from helping him the Tiljala Police Station has only made the life of the complainant miserable and vulnerable always by calling him to come to Tiljala Police Station in order to interrogate and ask questions alone to him, a complainant. It feels like the complainant who is Mr. Ehsan has made a crime by getting this case registered. Ask the I.O. of this case and Officer In-Charge of Tiljala Police Station if they have moved or took even a single step in order to arrest at least 3 accused as mentioned above. The answer is No. So, if this is what the situation is then ask the Authority In-charge of Tiljala Police Station and other I.O. of the same and the office under whose control the Tiljala Police Station, ask them all to resign, pass the order for these officers resign with the statement, "That, I am neither capable enough to handle this case nor I am able and capable of making arrest of 2-3 accused even after having clear ground and documented evidences which have established the facts which were allegations at the time of getting this FIR registered. Henceforth, we resign from our posts and jobs and step down of these chairs. These are the scoldings which I.O. of this case heard from his own ears on the last hearing which was on 20/01/2024.

Q2) Are both my minor children have been supplied to any extremist group or any terrorist organization or Begging Mafia of Bangladesh or Pakistan?

Counter Reply for question 2)

What answer can we expect for our question 2? The concerned authority when is not capable enough to Answer the question No.1 then there is not zero, in fact negative % and negative expectations from our end that the answering authority have this ability, capability and audacity to answer this question no. 2. When for the last 1 year approximately, the authority in-charge of Tiljala Police Station could not move even for single arrest instead of having clear ground and documented evidences which establish the fact of the part of the crime these accused named in the FIR Copy vide 71/23 and also in our complaint copy, in which we have discussed the details, every minute details about all the 6 accused in the registered FIR, in our complaint copy where we discussed in detail that which accused was used for which illegal activities and crime done by every single accused. I would request you to kindly go through our complaint copy once again and you will come to know everything in

details about each single accused, being the total number of accused is 6. You will get to know everything about each individual and the crime conducted by every single individual accused.

Q3) If both my minor children are still alive and not yet supplied to any terrorist organization or Begging Mafia, then on which address and in which particular home are they residing at this very moment in a real time scenario. Kindly furnish me with the proper address and home where both my minor children are residing till date, (i.e. date of receipt of application). Only if both my minor children are alive or if yet not supplied to any terrorist organization or Begging Mafia of Bangladesh and Pakistan.

Counter Reply for question 3)

Neither do I know nor do I care, be your Investigation in progress and keep doing it. Over here the answering authority could not think of anything so simply wrote whatever came in his mind along with some technical details and fancy words so that the individual who has Raised the RTI Application and asked some questions from the authority of Law Enforcement Agency would fear and will get scared reading this answer against the question one has asked and then that individual person would take his / her stance back and out of fear that individual won't ask any further questions anymore. Unlikely, see the fortune that this time the individual who is standing, who is a father of 2 minor children is not just someone. He is all together a different kind of person with all together different mind set-up, so you could be rest assured that until I get both my minor children back to me after an Arrest of minimum 3 accused out of 6. By name Md. Rashid, Syed Sagir Ahmed and Nazia Ambreen Quraishi. The permanent residential address already mentioned above which is 16 Sapganchi, the complete address is already mentioned above and also mentioned in title suit of our complaint copy along with many other documents as an evidence against the allegations we put up. One set of file was delivered to Tiljala Police Station and one set of file submitted with the state, at the Honourable Court of ACJM. Md. Rashid and Syed Sagir Ahmed are the one's who's been helping them in their illegal activities and crime for more than 2 decades and the primary accused named Nazia Ambreen Quraishi is getting help under the supervision of Md. Rashid and Syed Sagir Ahmed. Md. Rashid, Syed Sagir Ahmed are also a close relative of primary accused, Nazia Ambreen Quraishi and her family and in the very initial stage when this whole case started that time both my minor children and primary accused, Nazia Ambreen Quraishi stayed in the home of Md. Rashid and if you want to cross check the same which I am mentioning then kindly cross check the same as the proof and self testimony is registered and it is available in the Tiljala Police Station, FIR vide no. 265/22 and the Investigating officer is Raj Kumar. Kindly order to bring a C.D. along with the complaint copy of FIR No. 265/22 and in that complaint copy you will find that the testimony self declared by the primary accused named Nazia Ambreen Quraishi and the witness of that FIR which I mentioned vide 265/22 witness of the testimony is Md. Rashid and Syed Sagir Ahmed. Since, they came to know, that, we have got to know about the frauds and illegal activities and crime they are involved in, since that day with the help of Md. Rashid the primary accused named Nazia Ambreen Quraishi started playing hide and seek along with 2 minor children of mine. As mentioned in my RTI Application sent to you

and even to other Concerned offices of both Central Government and State Government that they, I mean all the accused and involved in the Anti-National Activities which as well include "Cross Border Terrorism". I know it's not easily possible or should I say next to impossible to investigate that, but I have information via authentic source that Ghaiyyur Quraishi from America and Faisal Quraishi from Canada keep transferring funds to the Extremist and Terrorist organizations in order to execute their Anti-National Activities and in India mainly Ghaiyyur Quraishi from USA keep sending funds to Md. Rashid, Syed Sagir Ahmed and his own sibling who is primary accused, even to hear but via help of Western Union, Money Gram and other firms as well to transfer the funds to India and then in just a day or should I say within seconds or maximum a minute hundreds of innocent children, father, mother died and we could do nothing and I say this in a state of dispare.

Rashid, Syed Sagir Ahmed and Nazia Ambreen Quraishi who are present under the jurisdiction of Tiljala Police Station, and interrogated and questioned them as per the complaint registered by us in writing, these accused also need to be questioned about their involvement in the Anti National Activities and Cross Border Terrorism.

This is an answer we have received against this question number 4. Ok, can anyone in your respected office please tell me that what is restraining you from making an arrest of at least these 3 accused named, Md. Rashid, Syed Sagir Ahmed and Nazia Ambreen Quraishi. Instead of having clear ground and documented evidences which proof that many of our Allegations is proven as a established fact. Still, the Authority In-charge did not move for the arrest of at least these 3 accused. May we please know the reason that who is barring you and restricting you from making an arrest of these 3 accused and safely handover both my minor children to me. Let me guess, see, in the first place Authority In-charge of Tiljala Police Station have very powerful documented evidences and I have recently received some more replies against the RTI Application we filed with MHA, Central Government and I have even forwarded the most efficient and effective Reply to the I.O. when only we 3 person was available. You asked me to share the scanned copy in pdf format of that reply letter, I did it instantly. You already have the letter of Ministry of External Affairs, Regional Passport Office, Kolkata which is a letter of cancellation and revocation of the Passport of the primary accused and miscreant named Nazia Ambreen Quraishi. You have a report copy of the FRO & a couple of more authentic documented evidences. So, even after having so much of material what is that thing which is restricting you of making an arrest of at least 3 accused as above mentioned. Md. Rashid and Syed Sagir Ahmed doing what in order to help them as well as Anti National Activities, which is something to argue about. At present the primary accused named Nazia Ambreen Quraishi is under the supervision of Md. Rashid and Syed Sagir Ahmed how he kept her in his house that i have already explained above and at present when so much has happened they are left with No option except to play hide and seek and Md. It is not exempted information u/s 8 (1) (j) and 8 (1) (h) of the RTI Act, nor is it forbidden from disclosure by the honourable courts in India. In such scenario how can a SPIO deny information to me?

The SPIO has not provided me complete information; therefore I am not satisfied with the information provided so far.

Please review the decision of SPIO and provide me with complete information as soon as possible. Thank you

No.2) First Appeal Raised against the same with the Office of the Respected, The Deputy Commissioner of Police, &, Appellate Authority. South East Division: Kolkata Police. Hence the reply and the answers received under Memo No.- SEDR/40/RTI/24 Dated 03.02.2024.

Therefore, all the Reply and Answer Copies we received against our raised RTI Application and our raised First Appeal are hereby enclosed along with their Memo Numbers and dates for the reference of your good office.

Further ahead, neither do I & nor my Legal Team and my Senior Ld. Counsel was satisfied with the Answers provided, as it was Biased Information's and Answers. As mentioned above the replying authority is the Officer In-Charge of the Tiljala Police Station. So, based on the case, the RTI Application raised, then First Appeal Raised as the Answers provided by the Officer In-Charge of the Tiljala Police Station was Biased even over the reply of Fresh RTI Application at first and while replying the First Appeal, the Answers provided by the Officer In-Charge of the Tiljala Police Station is not only Biased, it can certainly be proven in

What took the office of the Tiljala Police Station 10 LONG MONTHS to start with this process of investigation. That too he did it just because we kept a proper vigilance on the movement of the Officer In-Charge of the Tiljala Police Station in regards to this case of mine or else he would have never done it because he was busy helping, safe guarding and furnishing those Criminals and Terrorists the ideas that how could they have to keep themselves safe and sound, and all these because of what, just for some personal benefits of his own.

Counters to the reply and answers received:-

Answer 1. Counter Number, Part 1.

I make a humble request to the answering authority, the much respected, Officer In-Charge of Tiljala Police Station to kindly prove that whatever petitioner has referred to here, in regards to the Murder of his 2 minor children by the accused booked in the Registered FIR Vide No. 71/23 dated 24/03/2023 with the Tiljala Police Station, and following are the name of Murderers, 1) Md. Rashid; 2) Syed Sagir Ahmed and 3) Nazia Ambreen Quraishi and that, this is All together a Hypothetical Situation. kindly prove it that the Murder of 2 minor children are a hypothetical analysis. Alone the answer which is being provided to us via raised RTI Application and then raised First Appeal is not establishing the fact that both my minor children are alive or just mere statement of the Officer In-Charge of the Tiljala Police Station on the same are not establishing a fact that both my minor children are still alive and in a condition of Well Being. Kindly prove to the respected bench of Commission at first and then to me, that both my minor children are alive and their well being is taken care of under the vigilance of the authorities of concerned offices.

The alone and only way for the Officer In-Charge of the Tiljala Police Station to prove that the petitioner is referring to a hypothetical situation is only by bringing both my minor kids, both my minor children in front of me in the presence of the Concerned Authorities who holds higher office, who are higher Authorities than to the Officer In-Charge of the Tiljala Police Station and show me that both my minor kids are alive and are in a good shape of Life as far as their Well Being is concerned. If the Authority In-charge of the Tiljala Police Station fails to do so then, on that very point, on that very moment the Officer In-Charge of the Tiljala Police Station will have to and will be bound to Register another FIR under section 302 of IPC, that is case of Murder of 2 minor children against, Md. Rashid, Syed Sagir Ahmed and Nazia Ambreen Quraishi. As i am the Biological father of both those minor children and whole soul only Legal guardian of both my minor children the office of the

Tiljala Police Station is butted and bounded to bring both my minor children in front of me. As a father I am dead serious about what I am saying.

Answer 1. Counter number part no. 2: _

I want to make a kind and humble request with the respected bench of Commission, with the Commissioner of Police, Kolkata, with the Joint Commissioner of Police at Laal Bazaar Police Head Quarters, with the concerned Deputy Commissioner of Police, who is as well an Appellate Authority, South East Division : Kolkata Police and last but not the least I make the same, kind and humble request with the Officer In-Charge of the Tiljala Police Station to kindly furnish me with the Certified Copy of Court Verdict which at first establish the fact of Legal Divorce along with the verdict from the Court of LAW where Honourable Court has in written passed an order in favour of the booked and now an established Criminal, the Cheater, the Anti-National Element, the Terrorist, involved in "Cross Border Terrorism" named Nazia Ambreen Quraishi, where Honourable Court of Justice has in written given the Legal Custody of both my minor children to the Miscarient, the Criminal, the Terrorist after accepting the prayer of Divorce filed by the criminal named Nazia Ambreen Quraishi and the Learned Court further giving the verdict in favour of the named Criminal, Nazia Ambreen Quraishi by allowing the legal divorce via Court of Law along with the verdict of Child Custody of both my minor children in favour of the miscarient, the criminal, the terrorist who herself is not the Legal Citizen of India but along with serious and grave dangerous charges against her and other accused, where both the minor kids are born citizen of India and I am a biological father and legal guardian to both the minor children. It is necessary because the answering authority, the Officer In-Charge of the Tiljala Police Station is stating in his answer that, "PRESENTLY THERE IS NO EXPRESSED ORDER OF LD. COURT OF LAW UPON THE POLICE TO TAKE THE MINOR KIDS FROM THEIR MOTHER AND HAND THEM OVER TO THE PETITIONER (THEIR FATHER).

[Kindly take a note that over here we are referring the orders directly from the Honourable court of law, verdict passed underneath the stamp of Honourable court of law and the respected magistrate or judge being a signatory authority on the order passed after having proper trials and hearings conducted and both the parties got equal amount of justice in regards to putting up the arguments from both the ends in that very court of law where hearings and trials conducted in the presence of the respected bench of magistrate or judge]

We are not buying any single word said by or any report forwarded by the Ld. CWC, Kolkata. Above all, that so called Ld. CWC, Kolkata, the Authority of that office take the support of fake statements, Utter any Lies straight forward on the face of petitioner and turns away and go to back foot from their own made statements and the office of the Ld. CWC, Kolkata has done this with me in practical, I have gone through this and has experienced this happening with myself in practical and the concerned authority did this just to manipulate me and my mind so that I do not further ask any questions to them and take a Note of it that the Officer In-Charge of the Tiljala Police Station has time and again did the

same with me. We will say it all in front of the Bench of Commission on the Hearing date of this raised Second Appeal of Mine.

[Apart from that and paper or documents put up in front of us which will relate to the legal divorce and legal custody of my minor children, we will tear off those documents and further will throw the same in the garbage bag or dust bin in front of any & all the panels who would be present there at the time of hearing against this second appeal raised over the same]

Hence, we want to make a very humble request with your good and dignified office to take care of the same, so that, No situation of that Stature Arises and I have every and all hopes with your good office and respected bench.

Answer 1. Counter number part no. 3: _

I would like to bring under the kind notice of the respected bench that, the respected answering authority, who is the Officer In-Charge of the Tiljala Police Station forgot to mention that the Accused named Nazia Ambreen Quraishi was as well booked under the Passport Act and the accusation against the same, we have in details discussed above that how the Criminal named Nazia Ambreen Quraishi, used forged documents, fraudulently obtained documents and further ahead, Directly Cheated the Court of Law, The respected Judiciary of India as well by stating every word a Lie, and mentioning fake details and getting the Court Attested Affidavit. As she was not able to do this alone, then along with the help of other accused who are local citizens of Kolkata, Accused No. 1 named Md. Rashid s/o, Syed Sagir Ahmed and Accused No. 2 named, Syed Sagir Ahmed s/o, Late Eqbal Ahmed, permanent resident of Kolkata, and the complete address for the same is well mentioned in our Filed Complaint Suit did the needful crime.

As Ministry of Home Affairs, Central Government and Ministry of External Affairs involved, Intelligence Bureau, Foreign Registration Office, Bureau of Immigration and Security Control organization and got the enquiry done against the same and submitted their investigation reports with the concerned Ministry Offices, hence established my accusations and proved my made allegations to be fact & true. It was then the Ministry of External Affairs, Regional Passport Office, Kolkata cancelled and revoked the Passport of the named Criminal, Nazia Ambreen Quraishi. The same has been submitted to the Officer In-Charge of the Tiljala Police Station which alone in itself is that concrete documented evidences that which is more than enough for any Police Station to Arrest the Criminal but, i feel sorry to say and mention that the Tiljala Police Station did not made any legal move against the established Crime.

For, when the Passport Forgery case or allegations got proved as an established Crime and the Ministry of External Affairs, Regional Passport Office, Kolkata cancelled and revoked the Passport of the Criminal, than, Why did the Office of the Tiljala Police Station did not made an Arrest of the Criminal named Nazia Ambreen Quraishi.

Note:- [Blunders made by the office of the Tiljala Police Station].

I want to bring another Blunder under the kind notice of your good office which was made by the Officer In-Charge of the Tiljala Police Station in particular and the Tiljala Police Station in general but this blunder was not anyone's mistake or just by fluke something got missed which the Office of the Tiljala Police Station should have done. It was entirely and purely an Intentional move which took place as per, what the Plan of Action should be, by the office of the Tiljala Police Station if they had to make a move via Court Order which i am stating below.

If you see the First Reply and the Answers we received against our raised RTI Application Vide No. 190/RTI/SED/23 Dated: 12/12/2023. The Officer In-Charge of the Tiljala Police Station states in his Answer No.1 that they produced the Criminal named, Nazia Ambreen Quraishi who is as well a mother of 2 minor children before the Ld. CWC, Kolkata on 06/05/2023. As I as a petitioner was physically present at the Tiljala Police Station on dated : 05/05/2023 having interactions with the Officer In-Charge of the Tiljala Police Station and as well with the I.O. of this case and other Police Officers at the Tiljala Police Station as well. It was because just a couple of days prior to the date 05/05/2023 the Hearing was conducted against the same with the Honourable Court of ACJM, Alipore, 24 Parganas and it was already 40 to 42 days passed with "0" (Zero) efforts or any move by the Office of the Tiljala Police Station. So, considering the same on the day of hearing which I am mentioning to in this Paragraph in particular, my Sr. Ld. Counsel underneath my validation prayed for CrPC 97 with the bench of Honourable ACJM in Order to the recovery of both my minor kids. The respected Magistrate on that day in the presence of I.O. of this case along with the C.D. of this case was present in the Court Room for the purpose of hearing against the same. It was then, the Honourable Magistrate gave strict written order to the Office of the Tiljala Police Station and scolded the I.O. in the Court Room and the conclusion statement

which the respected Magistrate made was, either you imply this written order by court and recover both the minor children and present them before the concerned authority or else on the next date of hearing i will Allow the pray of petitioner CrPC 97. If your good office go through the CD of my case and cross check my words in the above mentioned Time Line, your good office will certainly able to track and see the Court Order in writing.

It was then on 05/05/2023 I approached the Officer In-Charge of the Tiljala Police Station in physical, in person and furnished the Officer In-Charge of the Tiljala Police Station with the address of stay which i traced under my own capacity that to within a period of 24 hours of time. Something which the Tiljala Police Station and respected office of the Tiljala Police Station could not do in the duration of 40 to 42 days of time period approximately and during that 40 to 42 days of period I all together visited the Office of the Tiljala Police Station and asked the I.O. of my case in regards to the recovery of both my minor children, all the 3 times the concerned I.O. of the case informed me that they have all together given 3 attempts in order to search my kids but the Office of the Tiljala Police Station could not locate and Failed to Locate my minor children. As they were not on the address which we mentioned in our Filed Complaint Copy which is a permanent residential address of 2 local criminals booked under the FIR of this case of mine, named Md. Rashid and Syed Sagir Ahmed, resident of 16, Sapganchi, 1st Lane, Tiljala, Kolkata - 700039. Hence, when I was rest assured that, It makes No Difference if the Police is there or not, if it's my work, if they are my kids then i will only have to do something in order to search where actually both my minor children are, if I get the place, the pin point address of their stay and then if I provide the same to the Office of the Tiljala Police Station, might be then they take this pain to stand from their respective chairs and do at least some needful. As all these criminals already started to Play the game of Hide and Seek, it was quite normal and very obvious that they will not continue their stay at the residence of Md. Rashid and Syed Sagir Ahmed, address mentioned above and Filed Complaint Suit. Hence, I did what I thought needs to be done in order to Locate my minor children and the criminal named, Nazia Ambreen Quraishi. I was not surprised at all that i done something within 24 hours of time which the so called, Investigative Agency, the Tiljala Police Station and reputed office of the Tiljala Police Station could not do within a time duration of 40 to 42 days of time approximately, I under my personal capacity did the same within 24 hours of time and within that 24 hours I gave the Officer In-Charge of the Tiljala Police Station the exact, pin point address in writing within that 24 hours and the date was as i mentioned above 05/05/2023. It was then, the Officer In-Charge of the Tiljala Police Station asked the concerned officers of the Tiljala Police Station to get the team ready as we will now raid the place and will do the needful if we get what we want, on this particular address. At last, I too went along with the team of Police Officers and then they raided the place, recovered both my minor children and then happened any needful required. Now, here I want to bring under your kind notice that, we kept on urging the O.C. of the Tiljala Police Station time and again on the same day that kindly make an Arrest of the main accused named, Nazia Ambreen Quraishi as we traced her down with lots of efforts but the Officer In-Charge of the Tiljala Police Station did not made any Arrest of any accused given the fact that they have traced her on all together a different address where she kept herself hidden along with both my minor children and that accommodation was arranged for her by 2 local booked accused named, Md. Rashid and Syed Sagir

Ahmed and then a day came after 10 to 15 days of time duration, the Criminal named, Nazia Ambreen Quraishi along with both my minor children flee away from that address and eloped once again. Over here, we are not assuming but we are charging the Officer In-Charge of the Tiljala Police Station, that it is not at all possible, this is something next to impossible for them to again flee away and elope from that place of stay without informing, without the consent and without the help of the Officer In-Charge of the Tiljala Police Station. It is Impossible, simply impossible. Hence, the Officer In-Charge of the Tiljala Police Station made a way out, provided the criminals a safe passage and made them flee away and elope from that place of stay.

[Grave blunder but intentional by the office of the Tiljala Police Station, not making arrest of the primary criminal named, Nazia Ambreen Quraishi that too after knowing all the facts that how are they changing their place of stay and on 05/05/2023 when the team raided and traced her on to all together a different address where she was kept hidden along with both my minor children under the supervision of Md. Rashid and Syed Sagir Ahmed]

Why did the office of the Tiljala Police Station did not make an arrest of primary criminal named Nazia Ambreen Quraishi when she was traced under the circumstances discussed above?

Answer 2.) Counter to answer 2.

For this question i would again request the respected answering authority, the officer In-charge of Tiljala Police Station is doing Nothing, except in order to manipulate the petitioner or complainants of the case. We again make a request that prove it, that, my contentions are always based on Hypothetical situation or these queries of mine are hypothetical in nature. Bring both of my children in front of me and prove me wrong, further ahead make the statement that this is a hypothetical question. Hence, any further details been discussed in regards to the involvement of both my minor children are not accepted by us, we reject your answer as police are only trying to manipulate the mind of victim, the petitioner and every time the Officer In-Charge of the Tiljala Police Station while answering is using behavior from Epistemology and deceiving the receiver of the answer by every time using the Modus Operandi known as reverse reasoning.

Answer 3) Counter of reply received.

Again over here in reply copy received and answers furnished to us by the answering authority who is a Officer In-Charge of Tiljala Police Station but received the same from the Office of the Deputy Commissioner of Police, South East Division: Kolkata Police. In the very first place the answer received is vague, an ultimate vague. There is a very high probability that, the Officer In-Charge of the Tiljala Police Station did not go thoroughly to our Complaint Copy of our case or say, the FIR Registered by us vide FIR No. 71/23 dated: 24/03/2023. In our Complaint Copy submitted with the Honourable Court of the ACJM and the same set of Complaint Copy along with documented evidences, the Honourable Court forwarded the same to the office of the Tiljala Police Station along with the order to get the

FIR Registered and inform the same to the Honourable Court of ACJM. The Complaint Copy which we submitted this is a very first point which we have already mentioned that, the Criminal of this case of mine named, Nazia Ambreen Quraishi has filed a Fake Case or got registered a Fake FIR against me with the Tiljala Police Station vide FIR No. 265/22 dated 05/10/2022. I would request our Honourable Officer In-Charge of the Tiljala Police Station to kindly open the Case Diary once again of Case No. 71/23 dated 24/03/2023 and from that take the Complaint Copy in his hand and go through it thoroughly, if these details would be known earlier to the Officer In-Charge of the Tiljala Police Station then he would have that chance to escape from the embarrassment which he is going through while going through this Application. So, these information against my raised RTI Application and then the First Appeal, neither is it helping us nor is it of any benefit because all the Officer In-Charge of the Tiljala Police Station is trying to do is, taking a stand for the established Criminals, favouring and then defending the crimes done by the established Criminals.

As the very Honourable Officer In-Charge of the Tiljala Police Station has mentioned about the case number 265/22 dated 05/10/2022 with the Tiljala Police Station, which has got no relation to the question asked. But we know what the Officer In-Charge of the Tiljala Police Station is trying to do. The honourable Officer In-Charge of the Tiljala Police Station is only trying to make the petitioner Scared, to keep the petitioner of the raised RTI Application and then the First Appeal under regular frame of Fear so that the petitioner get scared and stop asking questions to the authorities and let the authority gain personal benefit out of the same. Now, when the Officer In-Charge of the Tiljala Police Station has unnecessarily dragged and mentioned the case with his Office of Tiljala Police Station vide case no. 265/22 dated 05.10.2022. Now i want these answers to the questions i am going to pose now.

1) Where is the Complainant of the Case No. 265/22 dated 05.10.2022 with the Tiljala Police Station?? Just in case if our honourable Officer In-Charge of the Tiljala Police Station forgot the name of the Complainant of case no. 265/22 which he has mentioned and has unnecessarily dragged in between out of no where for the question asked has got nothing to do with the answer provided, the name of the complainant of case no. 265/22 is Nazia Ambreen Quraishi, who was even then the Criminal when she was filing the fake FIR in order to get a safe passage to go to United States of America using the Passport of Republic of India which she obtained Fraudulently and which she came to know that her husband, who is me, Tabish Ehsan has come to know about their Crimes Conducted.

2) I want the officer in-charge of the Tiljala Police Station to answer this question of mine. Why your complainant of case no. 265/22 got herself Under Ground after getting her fake FIR Registered against me.

3) Md. Rashid and Syed Sagir Ahmed are the witness on the FIR NO. 265/22. Where did they Vanish sir??? Kindly answer.

4) Why did your so innocent Complainant of case no. 265/22 named Nazia Ambreen Quraishi and her relatives and the witness on that FIR named Md. Rashid and Syed Sagir Ahmed started to Play Hide and Seek when they threatened me to settle the matter outside

court or else they will kill both my minor children and I denied them on their face stating that, this will now only end in the Court of Law and as far as my minor children are concerned, if you think you will be left alive on this planet earth if you harm my children, then please proceed and show me what wrong and physical harm could not do to my children and if so happens then you will see that what wrong and physical harm will you have to go through.

5) After getting the case registered which our very Honourable Officer In-Charge of the Tiljala Police Station has referred to vide case no. 265/22, why did the Tiljala Police Station did not serve me with the Notice of 41A or any legal notice from the side of Tiljala Police Station? WHY?

6) Why did the Office of the Tiljala Police Station didn't made any move against the registered case which the honourable officer in-charge of the Tiljala Police Station is mentioning to, vide case no.265/22 dated 05.10.2022.

7) Why did the Complainant of the case No. 265/22 named Nazia Ambreen Quraishi and her parental relatives, who were the witness of the case referred to case No. 265/22 with the Tiljala Police Station, all 3 went underground and started to keep themselves hidden and play the game of Hide and Seek, since then?

8) Why did the Complainant named, Nazia Ambreen Quraishi of the case no. 265/22 did not take this move of objecting my Bail in particular and the office of the Tiljala Police Station in general even after knowing that my Legal Syndicate has filed the Bail petition against the same. Why was Legal entity who is an advocate of the complainant of the case no. 265/22 was not available in the Court Room where my Bail petition was being heard, why their advocate did not objected my Bail in particular, on the day when my Bail hearing was being heard by the Honourable Court?

9) If the Allegations I was charged with in the case no. 265/22 was so serious in nature along with the claim of killing my own child who was not born till date but my wife, the Complainant was at that period 8 months Pregnant and the Tiljala Police Station charged me not only under section 498(A) but also with IPC section 313. So, on such grave allegations where there was a threat of life of a kid who was still to born, then why did the Office of the Tiljala Police Station did not serve me with 41(A) Notice and then did not made any move in regards to Arrest me under such serious charges and based upon the seriousness of the said case no. 265/22 then Why did the Office of the Tiljala Police Station did not object my Bail on the day of hearing of my Bail Petition?

10) How come the Ld. Court approved my Bail in a single shot of hearing, on the very first date of hearing of my Bail Petition and allowed me Bail, stating in the Bail Order Copy that there's Not even single evidence against the accused of the case no. 265/22 named, Tabish Ehsan which do not even give a hint against the allegations he was charged with, Forget about proving the allegations on Tabish Ehsan to be honest and true.

11) On the Contrary on the day of hearing of my Bail Petition with the Honourable Court we proved via Documented Evidences that any and all allegations the Complainant and the Office of the Tiljala Police Station charged me with was entirely fake and false allegations

and the point to be noted that, the respected Ld. Magistrate himself gone through all the documented evidences which we put up with the Honourable Court in order to establish the fact that any and all allegations the Complainant and the office of the Tiljala Police Station charged me with was nothing but a Made-Up Story, hence which proves that the allegations put on the accused named, Tabish Ehsan is certainly False and Fake the honourable court was convinced and allowed me a Bail on the very first hearing.

As soon as my Legal Syndicate provided me with the Bail Order Copy from the Court of Law, without wasting even a single minute I, in person went to the Tiljala Police Station and submitted my Bail Order Copy to the I.O. of the case no. 265/22 and name of I.O. is Sri Raj Kumar and made him read that kindly go through the Bail Order Copy of mine and in front of me & he did that. Hence, I submitted that Bail Order Copy of mine to the I.O. of the case no. 265/22 dated: 05.10.2022

11) Kindly let me know via Commission that what investigation did the Office of the Tiljala Police Station did against the Registered FIR vide FIR No.265/22 dated 05.10.2022 and kindly make available to me the Certified Copies of Investigation Conducted by the Tiljala Police Station against the mentioned case.

12) I would even request to Honourable Officer In-Charge of the Tiljala Police Station to ask the I.O. of the case no. 265/22 and ask him to for the Bail Order Copy of mine which I submitted with the Tiljala Police Station in the hands of I.O. of the case, Sri Raj Kumar ji in person and then i suggest the O.C. of the Tiljala Police Station to go through the same thoroughly, if missed by him, then the O.C. of the Tiljala Police Station will come to know that how the Court of Law has Categorically Denied the Allegations I was charged with over the fake, false blames and a made up story by the complainant named Nazia Ambreen Quraishi and the office of the Tiljala Police Station without even connecting with me, asking me to visit the Office of the Tiljala Police Station, simply by saying that there is some serious complaints and allegations on you and it is being done from your wife's end, now as this marriage is of a 13 years of long period of married life between both of you, so we need to question you about the same and if you do not visit the Tiljala Police Station then within a 24 hours or maximum 48 hours of time this complaints will be registered as a FIR.

13) Why did the Office of the Tiljala Police Station has not yet filed the Charge-Sheet of the case no. 265/22 dated 05.10.2022 with the Honourable Court. As after filing the Charge-Sheet of the case by the Police Authority of the Tiljala Police Station then only my Legal Syndicate will be able to move to the High Court of Kolkata in regards to the quashing of this Fake FIR and for further petitions to be filed with the High Court of Kolkata only when we get this FIR Quashed and the honourable High Court of Kolkata gives a written verdict, that is, "NOT GUILTY" and then we have writ petitions ready against the Criminals named, Nazia Ambreen Quraishi, Md Rashid and Syed Sagir Ahmed but this only relates to the Case No. 265/22 dated 05.10.2022. This has got nothing to do with any other case or the case filed by us against these Criminals who are even a Terrorists.

14) I would like to bring under your kind notice of your good office that, if the commission and the Officer In-Charge of the Tiljala Police Station goes through the Complaint Copy of





the Case No. 265/22 dated : 05.10.2022, the Complainant of the case, in her Complaint Copy by herself declared that she is presently residing on the address, 16, Sapganchi 1st Lane, Tiljala, Kolkata - 700039 and this address is a permanent residential address of the 2 Local Criminals who are as well booked under the case we have registered vide case no. 71/23 dated 24/03/2023 with Tiljala Police Station and the name of those 2 local Criminals are Md. Rashid and Syed Sagir Ahmed who have active participation in any and all Crimes being Conducted for over 2 decades of time period and they are the Parental Relatives of the primary and all the other accused and Criminals booked under the FIR which we have got registered against them and the nature of Crime they are involved in for over 2 Decades of time period falls under "Cognizable Offences", Offences which are so serious in nature that it terms under Anti-Social and Anti-National Activities. They are connected with the Cross Border Terrorism and Human Trafficking.

Hence, I wish that the Officer In-Charge of the Tiljala Police Station will be able to defend himself, his Uniform and his Chair of Position. My question was about the well being of both my minor children and where are they presently residing but the Officer In-Charge of the Tiljala Police Station, Out of Frustration are furnishing answers which has got No Relation to the asked questions. We put up some straight forward strict questions in regards to the case in our raised RTI Application and then by raising First Appeal and as i mentioned that our Applications are under the the Parliamentary Language but yes with stern and strict words and sentences, which offended the Officer In-Charge of the Tiljala Police Station and out of that Frustration he got dragged another case in between which has got No relation with the question posed or asked. I am not saying that the O.C. could not mention any case or any details as per the requirements and demand of situation but over here we see No Use of dragging that case in his reply or answer for it has got No Relation with the asked question. Hence, the Officer In-Charge of the Tiljala Police Station did this alone and only to satisfy his Personal Ego and nothing more than that.

In Conclusion of this Application i will discuss the answer which the Officer In-Charge of the Tiljala Police Station has furnished us with, that is the Answer to the Question No. 3 in the reply copy of First Appeal with the office of the Deputy Commissioner of Police, South East Division, Kolkata Police.

Counter to Answer furnished against Ques.4 in the reply copy of First Appeal,:-

In the Answer the Officer In-Charge of The Tiljala Police Station has mentioned that the Tiljala Police Station did not made any Arrest, precisely to be named, The primary criminal named, Nazia Ambreen Quraishi and the Criminals who are as well a parental relatives of her named, Md. Rashid and Syed Sagir Ahmed.

Number 1) How come the Officer In-Charge of the Tiljala Police Station labelling the booked accused who are now a proven criminal under the category of Non FIR? We want an explanation over the same and would request the humble bench of the commission to take the answer from the Officer In-Charge of the Tiljala Police Station and satisfy me with that answer because I have a very solid argument against the same. So, either the Officer In-Charge of the Tiljala Police Station take his statement back and withdraw his answer.

Number 2) We want an Arrest of these 3 named criminals under the remand or under the Police Custody. The criminals of this stature does not come under the category of the one's whom the Police Authority just examined and again let them free to go and fly.. We want an explanation over the same from the answering authority who is the Officer In-Charge of the Tiljala Police Station under the First Appeal Raised with the Deputy Commissioner of Police, South East Division, Kolkata Police.

Counter to the Reply and Answer furnished against Ques.5 in the received copy of First Appeal.

Kindly if the respected Commission could take the answer and ask the Officer In-Charge of Tiljala Police Station to explain that why the office of the Tiljala Police Station did not made an Arrest of the named 3 criminals, Nazia Ambreen Quraishi, Md. Rashid and Syed Sagir Ahmed.

We want to know that who is that Authority who is barring the Officer In-Charge of the Tiljala Police Station from making an Arrest? Or IF the Officer In-Charge of the Tiljala Police Station got himself so suppressed out of the personal benefits so heavy that, now in this particular case of mine he lost his ability, capability and his integrity due to the personal benefit being so extra ordinary heavy that he is of No use any further for the petitioner instead of being an Officer In-Charge, an Authority in the Tiljala Police Station and the way he is protecting, defending and allowing the criminals safe passage under his supervision, that, even a blind or deaf or dumb a person could figure out very easily that what the officer In-charge of the Tiljala Police Station up to. Henceforth, the Officer In-Charge could not even dare to touch the criminals, forget alone about making an Arrest of those Criminals.

Counter to Answer against the Ques.6 in the First Appeal:-

The Reports of the Tiljala Police Station in regards to this case of mine is as useless for us as the Officer In-Charge of the Tiljala Police Station is, at least for us and for this case in Particular. I agree that any number of times I went to the Tiljala Police Station in regards to this case of mine, I was always treated cordially but as far as sharing of informations or report are concerned, I was only manipulated by the Officer In-Charge of the Tiljala Police Station as he used to say one thing but at the time of action he used to act something different. The Officer In-Charge of the Tiljala Police Station is not amongst the ones who keeps his words. Apart from showing couple of documents and then making statements which was nothing more than a Logical Fallacy and after that when I used to ask the Officer In-Charge of the Tiljala Police Station about his action, as it did not go the way you told me then he used to provide me with circular reasoning. In fact, there was the time when my Sr. Ld. Counsel asked certain questions in light of this case, the Officer In-Charge of the Tiljala Police Station told him all together something different and on the same point he gave me all together a different answer. Hence, he is not worthy a person to rely upon.

Counter to the Answer of Ques.7 in a reply copy of First Appeal: _

This is to bring under your kind notice that the Officer In-Charge of the Tiljala Police Station is not mentioning the charges against the primary accused named, Nazia Ambreen Quraishi

which has been proved as an established Crime. As discussed above, I am once again stating the same over here as the Officer In-Charge of the Tiljala Police Station trying to manipulate the mind of officials as well as mine and in a very clever manner hiding the established Crime and mentioning the one which is yet to be proved. The Officer In-Charge of the Tiljala Police Station has time and again emphasized on the allegation which states that the wife of the petitioner, the criminal, named Nazia Ambreen Quraishi, the main contention of the petitioner is that, his wife is a Bangladeshi National and this allegation falls under the FOREIGNERS ACT. Hence, time and again he is putting up only this particular crime but the Officer In-Charge of the Tiljala Police Station is not mentioning that the criminal named, Nazia Ambreen Quraishi is as well booked under the Passport Act. & the allegations against her as far as Passport Act is concerned it has been established that the Criminal named Nazia Ambreen Quraishi along with the help of 2 other accused named Md. Rashid and Syed Sagir Ahmed forged the papers then obtained other required documents fraudulently and last but not the least got herself Court Attested Affidavit in order to submit the same along with the Application of Passport of India and further ahead she successfully obtained the Passport of Republic of India which was issued to her in the month of June, 2020. As already mentioned and discussed above how the truth came in the light and then the Law Enforcement Agencies of Central Government of India investigated the whole case in regards to the contention made on her and she is as well booked under the Passport Act. The Law Enforcement Agencies on the order of Ministry of Home Affairs, Central Government and Ministry of External Affairs after investing submitted their report with the concerned Ministry Offices and it was then established that the Criminal named, Nazia Ambreen Quraishi obtained the Passport of Republic of India by submitting the fake documents, Fraudulently acquired documents and then getting the Court Attested Affidavit in which each and every self declaration she mentioned was a pure lie and false information's and further ahead suppressed the Information's, it was then the Ministry of External Affairs, Regional Passport Office, Kolkata cancelled and revoked the Passport of Republic Of India establishing the fact that she Cheated on with the Government of India, 1.5 billion of Law Abiding Citizens of India and going to the extent of Cheating the Court of Law, the Judiciary of India by obtaining the Court Attested Affidavit based on Lies and Frauds.

Secondary, while applying the Passport of Republic Of India for herself she gave a clean and clear declaration that she is a born and brought up citizen of India, somewhere in the State of Uttar Pradesh. Hence, she submitted her certificate of standard 10 which was of the year 2005 and standard 12 certificate of the year 2007 from some University of Uttar Pradesh, Deoria, Rampur Karkhana... So, while applying for the Passport of Republic Of India she declared that;- 1) She is a born and brought up citizen of India. 2) She holds the educational certificates from the State of Uttar Pradesh, Deoria, Rampur Karkhana issued to her in the year 2005 and 2007 respectively.

Now, within the time line of 2007 to 2009 she states under Self Declaration that she Travelled to Canada, took admission and got herself enrolled for higher studies with the George Brown College, the details of documented evidences are already submitted with the Office of the Tiljala Police Station and we have proved the fact that, the Criminal named,

Nazia Ambreen Quraishi travelled to Canada and got herself enrolled for higher studies with the George Brown College, Toronto, and it is now an established fact. Therefore, the question arised was, being a born and brought up citizen of India, holding educational certificates of India as stated above, she travel to Canada and returned back within a time line of 2007 to 2009. On the contrary, the Ministry of External Affairs, Regional Passport Office, Kolkata are making their Stand Clear that the Passport issued to the Criminal named Nazia Ambreen Quraishi in the month and year of June, 2020 and that, this passport which got issued to her was the Fresh and First Passport she obtained in India and before that the criminal named Nazia Ambreen Quraishi did not ever had the Passport of Republic Of India before this Passport.

Our concern is not that which country Passport did she used to travel to Canada and returned back from Canada, be that Passport of the country UGANDA, SOMALIA, KENYA, ZIMBABWE, PAKISTAN OR BANGLADESH. Henceforth, our contention against her under the Passport Act was that, 1) The criminal named Nazia Ambreen Quraishi obtained the Passport of Republic Of India by adopting illegal means by doing Fraud with the Government of India, 1.5 billion Law Abiding Citizens of India and going to the extent and cheated and did fraud and 420 nature of Crime with the Court of Law, directly cheating and doing fraud with the Judiciary of India. Further ahead, travelling to Canada, enrolling herself for study purpose with the George Brown College, Toronto and returning back and she did this within a Time Line of 2007 to 2009 when she did not even had the Passport of Republic Of India.

Therefore, at present she is liable to get arrested as the contention related to Passport and booked under Passport Act the mentioned contention related to her Passport Forgery is now an established Crime. Still, the Officer In-Charge of the Tiljala Police Station is not dareing to make an Arrest of the criminal named Nazia Ambreen Quraishi even after the Passport contention has already been proven as an established Crime.

It is really sad to state whatever the Office of the Tiljala Police Station is doing is an action of Shame and Humiliation for the Officer In-Charge of the Tiljala Police Station as he is trying his level best to hide the contentions which is now a established Crime orelse till date whatever contentions has already been proved as an established Crime and the action over this via Office of the Tiljala Police Station should have been making an immediate Arrest for it's a threat to the society for whatever the criminals did, named, Nazia Ambreen Quraishi, Md. Rashid and Syed Sagir Ahmed directly comes under the "Cognizable Offences" and the nature of Crime is straight forward Anti-Social and Anti-National.

Counter to the Answer furnished against Ques.7 in the reply copy of First Appeal;-

It's good and much appreciated move that after 10 months the Officer In-Charge of Tiljala Police Station wake up from his deep sleep and decided to Investigate overseas by forwarding Requisitions under Mutual Legal Assistance Treaty,. The office of the Tiljala Police Station has made this move on 10/01/2024 and i was barking like a dog at the office of the Tiljala Police Station to make this move since day 1 when my FIR got registered. Why did it took the Authority In-charge of the Tiljala Police Station a period of 10 months to move

the Treaty under Mutual Legal Assistance with international countries, to mention, Canada, Bangladesh and United States of America?

Counter to the Answer furnished against Ques.8 in the Reply copy of First Appeal.

At this present moment as per the investigation of the Tiljala Police Station is moving with in order to prove that the Accused named, Nazia Ambreen Quraishi is a Bangladeshi National and is an Illegal Immigrant in India and then once proved the Legal Process of Deporting her back to Bangladesh will be initiated. It's nice to hear this and we will certainly keep an eye over the same. As, this allegation on the accused named Nazia Ambreen Quraishi falls under the FOREIGNERS ACT. Hence, it's nice to know that the Tiljala Police Station is doing some needful in order to investigate the same, though be after a year of Complaint Registered the Office of the Tiljala Police Station after a year stood up to investigate the allegations which falls under Foreigners Act. We have that much of Common sense that once proved, the legal process of Deporting the accused named Nazia Ambreen Quraishi back to Bangladesh will be initiated.

Over here we are talking and mentioning about the allegations against her under the Passport Act. has already been proved and now it's an established fact that how did she Cheated the Government of India, the Law Abiding Citizens of India and went to the extent of Cheating the Court of Law, the Judiciary of India and which we have already described and discussed above and as every Government offices and Law Enforcement Agencies, be it of Central Government or be the office of the Tiljala Police Station that after the interference of the concerned Offices of Central Government of India and the investigation conducted by the Law Enforcement Agencies of Central Government of India, after establishing the fact that our allegations in regards to the Passport Act. is now an established Crime and Ministry of External Affairs, Regional Passport Office, Kolkata, therefore cancelled and revoked the Passport of the criminal named, Nazia Ambreen Quraishi. I repeat myself that the allegations which the Accused named Nazia Ambreen Quraishi was charged with under the Passport Act. is now a proven crime.

Henceforth, the proven criminal named, Nazia Ambreen Quraishi is liable to get arrested without any further delay and then the office of the Tiljala Police Station can surely wait for the reports from countries like, United States of America, Canada, Bangladesh. Hence, whenever the office of the Tiljala Police Station receives the reports from the mentioned foreign countries, then the Authority In-charge of the Tiljala Police Station can surely make further moves under the charges of Foreigners Act. and do the needful based on the received reports from abroad countries.

Secondly, the Passport of the criminal named, Nazia Ambreen Quraishi has already been cancelled and revoked. Henceforth, she do not have any valid passport or visa or any travel documents based on which she could still reside in India. This is to bring under your kind notice that the Central Government of India has already issued a letter along with the order of taking proper action and this order copy received by me from the Office of Ministry of Home Affairs, Central Government. I have forwarded the same to the Office of the Tiljala Police Station so they can be rest assured that, Nazia Ambreen Quraishi is no more a valid

Indian citizen as her Nationality along with other Identity Cards has been ordered to cancel and to take proper action against the same. Though it be the office of Election Commission of India in order to get her Voter Card cancelled, be the office of Income Tax Department in order to get her Pan Card cancelled, be it the office of UIDAI, Aadhar Card department and as already mentioned that her Passport has already been cancelled and revoked.

The Order Copy from Ministry of Home Affairs, Central Government are enclosed herewith for your reference. The Passport cancellation Letter and the report against the same in the same copy are as well enclosed herewith for your reference. Henceforth, the accused named, Nazia Ambreen Quraishi needs to get Arrested without any further delay

After so much of happening it was the mandatory duty of the office of the Tiljala Police Station to seize each and every document of the accused named Nazia Ambreen Quraishi along with the educational certificates which she acquired from India and submit the all with the Honourable Court of Law, where the case is being heard. Then, again the same question how could the office of the Tiljala Police Station do it as the respected office is heavily suppressed under the personal benefit and this is the reason why the Officer In-Charge of the Tiljala Police Station keeps changing his sayings and statements every day and for that reason, The Officer In-Charge of the Tiljala Police Station is not worthy enough to be trusted on. Like I discussed above that whenever I met him in regards to the case of mine, the maximum times he has changed his statements and at times he has lied to me Up-Front on my face. So, how could I trust him and his spoken words and that is the reason, he is now no more worthy enough to trust his words, sayings and statements as he himself turns his back on his own sayings.

Here, I as well proved that he suppress the contentions which have already been an established Crime against the allegations, the accused Nazia Ambreen Quraishi is charged with. He does this only to manipulate me and senior officials and then try to save the all booked accused in this entire case only because of some personal benefits. It's such a Shame and our Heads Bow Down out of shame and embarrassment thinking about the officer in-charge of this level is doing something and is getting involved in such a low class practices, alone and only just to gain some personal benefits. What a shame is this, what a shame, for the entire Law Department of the Government of West Bengal will have to experience this shame along with the head of State, our respected Chief Minister Smt. Mamata Banerjee.

Counter to Answer which is Ques.9

We are completely Sorry but the Officer In-Charge of the Tiljala Police Station, states in his answer that he will bring back the criminal and both my minor kids if she flee away to Bangladesh once again by adopting illegal means. But we could only laugh and laugh out Loud because the Law Enforcement Agency, which is the Tiljala Police Station, could not able to trace both my minor kids and the Criminal named, Nazia Ambreen Quraishi and stated me that they give it a try on address which is in the Complaint File Suit. By their body language and hesitation of words, i understood that the Office of the Tiljala Police Station did not made any single move in regards to the recovery of both my minor kids, hence every

word spoken to me by the I.O. of the case further ahead, the Officer In-Charge of the Tiljala Police Station was simply fake and Lie.

The Officer In-Charge of the Tiljala Police Station when could not trace my minor children who were at the distance of 5 minutes drive from the Tiljala Police Station that to in the time period of,40 days to 42 days after my Complaint got registered vide FIR No. 71/23 dated : 24/03/2023 with the office of the Tiljala Police Station, then bringing them back from Bangladesh to India, in order to face the Judicial proceedings is a Good Dream and an excellent answer to manipulate the petitioner, the higher rankings officials of Law Enforcement Agency of Government Of West Bengal and to the extent of manipulating the Court of Law, The most respected Judiciary of India.

What an Irony it is. At one end the Office of the Tiljala Police Station is not getting any reverts and replies even after forwarding the Requisitions under Mutual Legal Assistance Treaty with the overseas countries, to mention, United States of America, Canada and Bangladesh which the Officer In-Charge of the Tiljala Police Station forwarded on 10/01/2024 as per the Report submitted by the Office of the Tiljala Police Station with the Learned Court on 20/01/2024 being the date of hearing with the Honourable Court of ACJM. Then, the same Officer In-Charge of the Tiljala Police Station when replying to the First Appeal Raised by us Vide Memo No: SEDR/40/RTI/24 Dated - 03/02/2024 with the Office of The Deputy Commissioner of Police, & Appellate Authority. South East Division, Kolkata Police. In the Reply Copy of raised First Appeal, the Officer In-Charge of the Tiljala Police Station being the Date of Receipt 23/02/2024 for above mentioned Memo No. by himself stating that the "REPORTS from the CONCERNED AUTHORITIES ARE STILL AWAITED". So, Treaty raised with above named Foreign or Abroad Countries dated 10/01/2024 and the Reply Copy against the raised First Appeal dated : _ 23/02/2024 and the Reports are still awaited from the concerned authorities of Foreign Countries be it, United States of America, Canada and Bangladesh. I would request the respected Officer Incharge of the Tiljala Police Station to take the Calendar in his hands and calculate each and every date, May be then you might feel ashamed of yourself for the wrong you are doing with the victim of this case, the petitioner of this case when you are addressing the Ques.9 of raised First Appeal and then you mention there that, I quote your reply or say your answer under Inverted commas, here comes your answer, " If it is once proved that the accused Nazia Ambreen Quraishi is a Bangladeshi National, then all out efforts will be made to bring her back to this country to face the Judicial proceedings if it is found that she has returned to Bangladesh by illegal means". This is your answer, respected sir, the Authority In-charge of the Tiljala Police Station. I want to ask you that, with this answer of yours whom are you trying to make a Fool of? Are you trying to make a Fool of your own self, or if you are trying to make a Fool of me, or the Law Enforcement Agency and the entire Law Department of the Government of West

Bengal, or if you are trying to make a Fool of the Government of West Bengal and the head of the State, our respected Chief Minister, Smt. Mamata Banerjee or if you are trying to make a Fool of and deceive directly the Court of Law, the Judiciary of India, in a very same way as the booked Criminals in registered FIR have done Previously. I want to know this from the Officer In-Charge of the Tiljala Police Station that does he want himself to stand as an accused along with the other booked accused in the Registered FIR Vide FIR No. 71/23.

Hence, take my words that you and the entire law enforcement agencies of the government of West Bengal will not be able to bring her back from Bangladesh to India and not even both my minor children. Yes, dreams are for free so you can keep seeing dreams of getting them back to India. If this dream of yours make you feel good from inside and give reason to be happy thinking about the same, then I would personally suggest you to please continue and keep watching this dream ,].

With all due respect to the Officer In-Charge of the Tiljala Police Station, i want to inform you that, I don't know what are your plans or what are you trying to do or what are you trying to establish by providing support, help and safe passages to these booked Criminals or what relation do you have with these booked Criminals in our registered FIR. Hence, I want to make my point very clear that NO CONFUSION Left Behind. I am not going to spare the one who has done wrong and cheated my beloved country India, the Government of India, the innocent Law Abiding Citizens of India and of course with me. Neither am I going to spare the booked accused in our registered FIR and to name in specific, Nazia Ambreen Quraishi the primary proven criminal, nor I will spare the ones who help them or who so ever are helping them in a present scenario. Who so ever are helping them in this given present scenario then they do not know what they will have to go through under the boundaries of Law and Judiciary. I will do it all under the boundaries of Law and Judiciary in order to make the life, the whole family life vulnerable

As dreams are for free and the spoken words of an authority holds no value, be the authority of any given office or department, then the society and the law abiding citizens of India can certainly sit and give a good laugh on their own fate.

At this very point, if the criminal named, Nazia Ambreen Quraishi has gone to Bangladesh along with 2 minor children of mine. In this scenario in particular, the Officer In-Charge of the Tiljala Police is only stating the hypothetical situation, that, they can do this and that and by doing this and that they will able to bring the accused along with,2 minor children of mine back from Bangladesh to India. Which is nothing but a Logical Fallacy

Now I Counter the answer furnished to us against Ques.3 in the copy of First Appeal:_

How on the earth could the Officer In-Charge of Tiljala Police Station say that, they will not tell me where both my minor kids are that i being a biological father and legal guardian of

both my minor kids I hold every Right to know that where my kids are residing at present. Till date even the divorce have not taken place and there is No Court Order either to the Tiljala Police Station or to the criminal named, Nazia Ambreen Quraishi who is only hiding along with both my minor children. No section in the RTI or under the IPC states that a biological father of minor kids could not meet his children. Yeah, once the divorce case is over and even the verdict against Custody of children has been announced by the Honourable Court, till then. At this moment I do not even need any permission to go to my kids and see them and see for their Well Being.

There's a simple line or statement, The Office of the Tiljala Police Station will disclose to me where both my minor children are.

An Illegal Immigrant, couple of Foreign citizens along with the help of 2 local criminals, will come out of Nowhere and will deprive me from my Fundamental and Constitutional Rights and washes off any and all rights of mine and i will just sit and keep watching that what is happening. So, kindly know this that, I will not let that happen.

The officer in-charge of the Tiljala Police Station alone knows that what personal sympathy does he have with the booked criminals and the fundamental and constitutional rights of criminals are being safe guarded by none other then the officer in-charge of the Tiljala Police Station.

I want to put up a request in front of the commission that if so is the scenario that the Officer In-Charge of the Tiljala Police Station are not able to protect the Fundamental and Constitutional Rights of Law Abiding Citizen of India, which even includes me, then I would request commission to ask the Officer In-Charge to give me the same in writing that, The Officer In-Charge of the Tiljala Police Station In particular and whole of the Tiljala Police Station in general are not able enough, are not capable enough, does not have the resources enough to defend and protect the Fundamental and Constitutional Rights of the petitioner and complainant, hence the petitioner can himself under his own capacity if want, then the petitioner can defend, protect and safe guard his Fundamental and Constitutional Rights on his own and if possible for petitioner then the petitioner can also take his both minor children along with himself under his own capacity. As the Officer In-Charge of the Tiljala Police Station is busy defending the Fundamental and Constitutional Rights of the Criminals, which means he himself wants to get counted along with the criminals and to do so, it's his own will and decisions.

Then, after writing this the Officer In-Charge of the Tiljala Police Station give that one cop to me and I will get the needful done within 48 hours of time.

There's a lot more to say and discuss in the presence of Commission and that will be done from my end on the day of hearing against this Second Appeal being raised.

Over here, I want to mention something which I have already discussed above and that is;

Under the Passport Act the accused named, Nazia Ambreen Quraishi, she has been found guilty and the Office of the Tiljala Police Station is trying hard to suppress this by not

Second Appeal against : Refusal of information by the FAA

Deemed refusal of information on part of PIO, even first appellate authority did not hear my first appeal; in this way I was not given a chance of being heard under RTI Act.

Brief facts leading to appeal:

The PIO and First appellate authority have not paid heed towards my RTI application and first appeal respectively, in this way I feel aggrieved and my fundamental right of Information is being suppressed by the negligence of SPIO of **COMMISSIONER OF POLICE, SOUTH EAST DIVISION, KOLKATA**

The FAA has given me a casual reply that e obtained from the SPIO wherein the SPIO has given irrelevant and partial reply and skipped the crucial points saying that it will jeopardise the investigation process, but he didn't enumerate how that would jeopardise his investigation process, he can't deprive me of my fundamental rights by merely saying that it will jeopardise or hamper the investigation process he has to give proper justification to substantiate his claims otherwise it will be treated as refusal without any proper reasons.

As per Section 8 (2) of the RTI Act

Sub-section (2) notwithstanding anything in the Official Secrets Act, 1923 nor any of the exemptions permissible in accordance with sub-section (1), a public authority may allow access to information, if public interest in disclosure outweighs the harm to the protected interests.





presenting his argument in order to pass CRPC 97 as petition was filed with the same Honourable Court of ACJM and this was the 3rd hearing where Tiljala Police Station even after knowing the whole case and the sensitivity of the whole case didn't even moved an Inch to think something over the same and Authority In-charge being the head of Tiljala Police Station was doing nothing even in the regards of recovering at least 2 minor kids. On that hearing date Honourable Court of ACJM scolded the Investigation Officer who was present in the court on that hearing date and as we were present at the court room we as normal law abiding citizen & as well being a complainant also got scared and every entity who was present in the court room at that time heard and seen the way Honourable ACJM scolded over the negligence and avoiding the seriousness of the case, the much respected our Honourable Court of ACJM, gave Tiljala Police Station last warning in written order to do the needful as far as recovering of kids are concerned and present the children in front of the concerned authority within next date or on the next date I will accept the prayer of complainant and pass the order of CRPC 97. It was then the authority of Tiljala Police Station had to show some movement only because of the strict written order by the Honourable Court of ACJM. As per Investing Officer of this case they already took 3 chances in order to recover the kids but couldn't find them on the address we mentioned. I know that I.O. of the case and Authority In-charge of Tiljala Police Station are providing with fake and false statements which they used in regards of recovering both my minor children. I know that they didn't search at all even for once. Still on the contrary I accept and believe that yes Tiljala Police Station have tried to recover my minor kids and just imagine in a hypothetical situation that they went to the address and that address is a permanent residential address of Accused number 1 and 2 named Md. Rashid

On our complaint suit file so, why did your Authority In-charge of the Tiljala Police Station made NO arrest of Md. Rashid S/O, Syed Sagir Ahmed and Syed Sagir Ahmed S/O, Lt. Eqbal Ahmed a permanent resident of 16, Sapganchi, 1st Lane, Tiljala, Kolkata-700039 as these two mentioned named are the accused number 1 and 2 in the mentioned FIR vide 71/23 and if you go through my complaint a copy which is very available in the Case Diary of registered FIR vide 71/23 alongside a copy of the same is submitted and safe and secured with the Honourable Court of ACJM. In that complaint copy each and every minute details is mentioned which I have to keep repeating writing in any and all the written applications or if any letter I write to any Authority of



Government or Public Office. Under such serious charges the accused number 1 and 2 as their names mentioned above are freely moving as and any where they feel like.

Now, I want to draw your attention on the dates as it has great significance which establishes the fact that how careless, ignorant and how negligent the Authority In-charge of Tiljala Police Station is in particular and I.O. and the whole Tiljala Police Station in general. As you see my mentioned FIR vide number 71/23 got registered on 24/03/2023 and in the reply against the RTI Application filed, Tiljala Police Station, themselves are stating the date on which both the minor children along with their mother who is the primary accused and miscreant in this entire case named Nazia Ambreen Quraishi D/o, Lt. Aftab Ahmed Quraishi were produced to Ld. CWC, Kolkata on 06/05/2023. I would request you give a kind attention to what I am going to mention now. The Tiljala Police Station or the Authority In-charge of Tiljala Police Station gave verbal statement to me for 3 times that we made an effort to recover your kids but we could not find your kids, hence we are sorry for that and we are still searching. When I understood that though be the I.O. of this case or the Authority In-charge of Tiljala Police Station is only providing me with fake and false statements, it was then I understood how incapable our Law Enforcement Agency is, in whole of the West Bengal in general but my case is under the jurisdiction of Tiljala Police Station so the Tiljala Police Station along with the concerned authority in-charge of Tiljala Police Station are good for nothing, it was then I decided to take the initiative of searching my children under my own capacity to track where my children are so that I could furnish the same with the Authority In-charge of Tiljala Police Station and then they might take this pain of going to that exact location and pin point address, if I could furnish them the same as I mentioned. I did whatever needed to be done using my sources and resources in particular and did something which should have been done by Tiljala Police Station. I cracked the location and exact address within 24 hours. I did something which so called Law Enforcement Agency and that too which comes under your control, in specific, Tiljala Police Station along with the Authority In-charge could not do the needful in a period of 40 to 42 days approximately, I on myself under my personal capacity did it in a duration of 24 HOURS and then I went to Tiljala Police Station, met the Authority In-charge in person and furnished his office the required details in order to recover my minor children and it was then, the Authority In-charge in particular and the Tiljala Police Station in general took that pain, sent the required team and I was

available along with the team and in my presence they then, recovered both my minor children and produced them along with their mother before the Ld. CWC, Kolkata. Henceforth, as I mentioned above that it took approximately 40 to 42 days to the Authority In-charge of Tiljala Police Station in particular and the Tiljala Police Station in general in order to just to recover my minor children. Your good office could even take this in a way that, which the Authority In-charge of Tiljala Police Station or whole of the Tiljala Police Station which comes under direct control of yours could not do the needful even in 40 or 42 days since my FIR got registered till the date my children were produced before Ld. CWC, Kolkata I did the same within 24 hours of time. I only feel sad for Tiljala Police Station, for Authority In-charge of Tiljala Police Station, for the Law Enforcement Agencies of West Bengal in general and last but not the least, I feel SAD and I PITY on you in person thinking that, the position, the designation and most importantly the chair you are sitting on and in this I include Authority In-charge of Tiljala Police Station as well and leave on to you to think that are you or the Authority In-charge of Tiljala Police Station are capable enough to hold on to that designation you are blessed with and the Chair on which you sit including Authority In-charge of Tiljala Police Station, are you capable enough, are you competitive enough to sit on that Chair as that is not merely a Chair, what you need to understand is "THAT CHAIR IS OF GRAVE RESPONSIBILITY". I am using this statement only out of the state of dispare. Henceforth, I do not accept the answer provided to me by any of your concerned authority and to state also to bring under your kind notice that, the answering authority did not state anything new in his answer which I didn't knew. I would request your much respected office to kindly sit and take a Calendar in your hand and then calculate that how many number of days and how many number of months has been passed and gone since my 2 minor children were produced before the Ld. CWC, Kolkata and what are the probabilities of anything bad happened with both my minor kids.

NOTE:- [If your concerned office wants to know that what negative and what cruelty a mother a own biological mother can do with her kid, then kindly refer the very recently occurred murder case of a 4 year minor kid of Bangalore, how his own biological mother killed and murdered her own innocent and such a small kid of 4years, may be that could open your eyes and guide you on right path and to take correct and needful decisions on time and execute the same ASAP. before anything goes wrong]

If you go through my RTI Application raised with your department against which I received only so called Technical and Political correct reply, which I do not accept, under any given circumstances, I have mentioned in that RTI Application of mine that, how is Ministry of Home Affairs, Central Government, Ministry of External Affairs, Central Government, Regional Passport Office, Kolkata, Foreign Registration Office, Central Government, Vigilance Commission of Central Government, PSP Division, Intelligence Bureau and Intelligence Bureau of Immigration, Central Government and Of Course The Homes and Hill Affairs, State Government are involved in this case. How they investigated the matter, how they submitted the reports against the same directly to concerned Ministries and based on that Ministry of External Affairs, Regional Passport Office, Kolkata cancelled and revoked the Passport of main accused the miscreant named Nazia Ambreen Quraishi. RTI Applications forwarded to Ministry of Home Affairs have sent the reply to me and it clearly states that, Central Government have sent the files along with the Ministry Letters to various concerned authorities of Government and Public Offices to take proper action against the same and then report back to the Ministries as per the concerned Offices and departments out of which Ministry of External Affairs, Regional Passport Office, Kolkata have already cancelled and revoked the Passport of a primary accused, the miscreant named Nazia Ambreen Quraishi as already mentioned above. The Copy of Reply from Ministry of Home Affairs, Central Government have been enclosed herewith for your reference.

Passport revocation and cancellation letter from Ministry of External Affairs, Regional Passport Office, Kolkata has been enclosed herewith for your reference.

This is just to bring under your kind notice that we have already shared the required documents with Authority In-charge of Tiljala Police Station along with forwarding letter, though it be the Document from Ministry of External Affairs, Regional Passport Office in which Ministry and Passport Office clearly states that the said Passport of Nazia Ambreen Quraishi, issued to her in the month of June, 2020 has been cancelled and a letter again from Ministry of External Affairs, Regional Passport Office, Kolkata is asking the accused to surrender that cancelled Passport back to the Regional Passport Office, Kolkata and both the documents have been submitted with the Authority In-charge of Tiljala Police Station along with my forwarding letter. The concerned letter where Ministry of External Affairs, Regional Passport Office, Kolkata is asking to surrender the

cancelled passport and the document issued by Ministry of External Affairs, Regional Passport Office, Kolkata has been enclosed herewith for your reference.

No accused by himself or herself goes to the Regional Passport Office to surrender that passport which the ministry has cancelled on their own after an investigation conducted by the Law Enforcement Agencies of Central Government, for they all know the intensity and seriousness of the case filed against them. It is then the duty of concerned Authority In-charge of the Police Station to confiscate the documents one and all and once the Police Station confiscate all the original documents, though it be Passport of the accused, Voter Card, Pan Card or Aadhar Card and then report the same to Honourable Court of ACJM and then surrender all the seized documents and Nationality Cards before the Honourable Court, though it be any court where the matter is being heard by Ld. Magistrate or respected Judge and it will be kept deposited with the Honourable Court itself until any verdict issued against the same. Like, in my case, Authority In-charge of Tiljala Police Station should have seized all those documents of the primary accused named Nazia Ambreen Quraishi and should have informed the Honourable Court of ACJM and surrender the same, the seized documents to the Honourable Court of ACJM. But then, I believe why would the Authority In-charge of Tiljala Police Station needs to take so much of pain, so let it be how it is, because those minor children are neither the children of the Authority In-charge of the Tiljala Police Station nor of the Deputy Commissioner of Police of South East Division: Kolkata Police. So yeah, take it easy and be cool and relax for both the Authorities have their Chair allotted by the Government of West Bengal., my pray for you is kindly sit on those respected chairs and Relax... No issues...

So, like I mentioned above that me and my Syndicate of legal advisor and above all my Lawyer who stands in the argument for me respected senior Ld. Counsel. Reject this reply of yours. The way concerned authority has answered the very 1st question of mine which is a question No.1 in my raised RTI Application, that answer itself establishes the fact that how childish and careless attitude of the Tiljala Police Station including the Authority In-charge of Tiljala Police Station and the answering authority of my raised RTI Application has hardly have any knowledge of Law and Judiciary. The answer starts with "**NO SUCH INFORMATION RECEIVED BY THE P.S. TILL NOW**". Then I assume that one fine day a random phone call will be received by Tiljala Police Station stating that, "I AM A GARBAGE PICKER and I am calling from this area and location and while

picking up the garbage I found 2 dead bodies and looking those bodies, it seems that these, 2 dead bodies are of small kids.

I am wondering that how big and special will it be as they recovered both my minor children, No issues if they are dead but the point of proud will be that, they recovered both minor kids of Tabish Ehsan, so distribute sweets to whole of the Tiljala Police Station and how could the Authority In-charge miss on to the Office of the much respected office of the Deputy Commissioner for South East Zone: Kolkata as Tiljala Police Station comes under the control of respected Deputy Commissioner as i mentioned above. So, the Tiljala Police Station which comes under the direct control of respected Deputy Commissioner, South East Division will receive a packet of sweets sent by the Authority In-charge of Tiljala Police Station out of success they achieved and the happiness would be the result of success of recovering 2 dead bodies of minor kids of Tabish Ehsan. I wish if could also be available on this success of yours, I would as well Clap, sing and dance to express my happiness on your success.

On that day, I will feel like the King of some Dynasty and will tap the back shoulders of all the officers of Tiljala Police Station in general and will do the same for Authority In-charge of Tiljala Police Station as they were able to crack down the case and recover both my minor children, it's only that, they are dead, only that part will make us feel a sad couple of times but yeah the truth could not be changed and truth is, highly capable, highly appreciable and in action so quick and fast that how could any Law Enforcement

Agency could make such a quick movement and come in action within No time and execute their duty without even losing fraction of second. At last, I give them an applause and then this time me and my lawyer would do a proper Press Conference inviting all the National Media Houses and we will make sure that one very National Media Houses apart from telecasting the Press Conference they need to keep showing the Head Lines over each and every National Media Houses, broadcasted over the Television and Of Course our media conference. We will try to get our press conference telecasted in a time frame when maximum population sees and hear the news. After all, it my duty to let the world know how efficient our Law Enforcement Agencies are in general and Deputy Commissioner office, South East Division: Kolkata Police and Tiljala Police Station along with the Authority of Tiljala Police Station. How could I not Thank them for what they did to me and for me. Last time media involvement we kept it a bit low profile and did the needful only with India Today but still all the leading media houses reported published the case in print media & News Papers and gave television interview only to Aaj Tak Bangla, so, that 10 mins. Interview was telecasted only on Aaj Tak Bengali and both me and my lawyer gave our statement in Bengali itself but if necessary, this time we will take proper care of everything so that a mass majority across the globe should know that how good and how efficient our Law Enforcement Agency is, Tiljala Police Station in particular and obviously Deputy Commissioner of South East Division, : Kolkata Police by default will be addressed.

This is to bring under your kind notice that, the place, the location and the address of the home from where Tiljala Police Station recovered 2 of my minor kids and the primary accused named Nazia Ambreen Quraishi, Just after the production of both my minor children along with the primary accused named Nazia Ambreen Quraishi, they left that flat, they moved out from that flat and at this present time I do not have any idea that where both my minor children are but I know where ever they are, they must be with the primary accused and miscreant named Nazia Ambreen Quraishi. Since both my minor children are in the hands of Criminals like this, I fear their life, only if they are alive and not murdered by primary accused named Nazia Ambreen Quraishi along with the help of Md. Rashid and Syed Sagir Ahmed, accused number,1 and 2 in my complaint copy. As soon as i came to know that they have left the place I rushed to the Ld. CWC, Kolkata and informed the respected lady who is also a chairperson of Ld. CWC, Kolkata. She was least interested even to hear what am I saying and after

pleading and requesting when she agreed to listen to me, I informed her that both my minor children along with the accused named Nazia Ambreen Quraishi have left the house and some new family is residing there. Now, on 06/05/2023 when both my children along with the accused was present there, I informed her that it's very dangerous to leave the children with her and I prayed before her that kindly take the children from her and for the time sake let both my minor kids stay in the house of Ld. CWC, Kolkata so that at least they will be safe but then she convinced me that you do not have to worry for an authority from Ld. CWC, Kol. Will keep visiting on every alternate day to the place where your kids are residing and this is how we will take care of your kids until any verdict comes against the FIR you registered against Nazia Ambreen Quraishi and she also promised me that I will have a talk with Authority In-charge of Tiljala Police Station to atleast send the I.O. twice every week just to keep a check for the well being of your children. Now, that day when I went to meet the authority who is a respected lady at Ld. CWC, Kolkata in regards of informing her that my children and the accused named Nazia Ambreen Quraishi are no more in that home and that they have changed the place of stay with the help of Md. Rashid and if you could help me with where both my minor children are then she replied that it's not our concern, it has everything to do with Tiljala Police Station where your FIR is already registered and again file a diary or get new FIR register stating as Minors Missing Complaint. It was then I rushed to the Tiljala Police Station and wrote complaint diary sitting in the passage area and it was just a normal diary for the 2 minors missing complaint. As one of the officer took a written complaint to register the diary, the concerned I.O. of case asked me that what is it about and then I told him everything from top to bottom including the conversation I had with the concerned authority of Ld. CWC, Kolkata and i informed my I.O. that the concerned authority of Ld. CWC, Kolkata has asked me to register a diary related to 2 minor children missing and I am the biological father and guardian of both my minor children. The I.O. of my case denied and said to me that we can't register this case or register diary against the same as we have once recovered both your children and produced them at the Ld. CWC, Kolkata, I told my I.O. that the concerned authority from CWC has only directed me to register a missing FIR or at least missing diary for both the children. Still, my diary concerning the missing of both my minor children was not entertained, hence not registered. Then at that very moment I met the Officer In-Charge of Tiljala Police Station and told him

everything from start to end but I was not surprised with the kind of reaction he gave over this information and only told me that, you informed us, we will see to it and now, don't worry and go home. These were the 2 authorities who took me in confidence, at first the respected authority of Ld. CWC, Kolkata and she is a chairperson in that office and took me in confidence assuring me that we will keep proper watch and surveillance over the well being of both your minor children. In fact she was the one who relaxed me and took me in confidence that she will have a talk with Authority In-charge of Tiljala Police Station to keep a check over both the minor children by asking the I.O. of this case to give a physical visit along with a lady officer twice a week in order to confirm the safety and security of both my minor children.

I feel sad for whole of the society in general after seeing with my own eyes and experiencing in person that how do Authorities sitting on a chair and that chair means a grave responsibility and lie to the victims on face just to safeguard their designation and chair they are holding. I feel SHAME, MY HEAD BOWS DOWN and I only feel pity on the authorities who are holding chairs of designation but i doubt that they hardly know anything or even the meaning of responsibility and today I agree with my senior Ld. Counsel who put up the argument from my end in the Honourable Court of ACJM and on the last hearing date which crossed was on 20/01/2024 in the presence of the Investigative Officer of this case of mine, even addressing the Authority In-charge of Tiljala Police Station that it's almost 1 year approximately, we come in the Honourable Court on every date which respected ACJM orders. At this very moment every ground is clear and certain allegations are established facts over the documented evidences but the Authority of Tiljala Police Station has not made even a single arrest till date. The authority In-Charge of Tiljala Police Station has every ground clear to at least make an Arrest of at least 3 accused namely:- 1) Md. Rashid, 2) Syed Sagir Ahmed and 3) Nazia Ambreen Quraishi but the bitter fact is Authority In-charge of Tiljala Police Station has yet done nothing apart from making fake and false statements and promises to the complainant who is a biological father and a senior guardian of both the minor children and he is only concerned about the well being of his 2 minor children. Hence, apart from helping him the Tiljala Police Station has only made the life of the complainant miserable and vulnerable always by calling him to come to Tiljala Police Station in order to interrogate and ask questions alone to him, a complainant. It feels like the complainant who is Mr. Ehsan has made a crime by getting this case registered. Ask

Counter Reply for question 2)

What answer can we expect for our question 2? The concerned authority when is not capable enough to Answer the question No.1 then there is not zero, in fact negative % and negative expectations from our end that the answering authority have this ability, capability and audacity to answer this question no. 2. When for the last 1 year approximately, the authority in-charge of Tiljala Police Station could not move even for single arrest instead of having clear ground and documented evidences which establish the fact of the part of the crime these accused named in the FIR Copy vide 71/23 and also in our complaint copy, in which we have discussed the details, every minute details about all the 6 accused in the registered FIR, in our complaint copy where we discussed in detail that which accused was used for which illegal activities and crime done by every single accused. I would request you to kindly go through our complaint copy once again and you will come to know everything in details about each single accused, being the total number of accused is 6. You will get to know everything about each individual and the crime conducted by every single individual accused.

Q3) If both my minor children are still alive and not yet supplied to any terrorist organization or Begging Mafia, then on which address and in which particular home are they residing at this very moment in a real time scenario. Kindly furnish me with the proper address and home where both my minor children are residing

till date, (i.e. date of receipt of application). Only if both my minor children are alive or if yet not supplied to any terrorist organization or Begging Mafia of Bangladesh and Pakistan.

Neither do I know nor do I care, be your Investigation in progress and keep doing it. Over here the answering authority could not think of anything so simply wrote whatever came in his mind along with some technical details and fancy words so that the individual who has Raised the RTI Application and asked some questions from the authority of Law Enforcement Agency would fear and will get scared reading this answer against the question one has asked and then that individual person would take his / her stance back and out of fear that individual won't ask any further questions anymore. Unlikely, see the fortune that this time the individual who is standing, who is a father of 2 minor children is not just someone. He is all together a different kind of person with all together different mind set-up, so you could be rest assured that until I get both my minor children back to me after an Arrest of minimum 3 accused out of 6. By name Md. Rashid, Syed Sagir Ahmed and Nazia Ambreen Quraishi. The permanent residential address already mentioned above which is 16 Sapganchi, the complete address is already mentioned above and also mentioned in title suit of our complaint copy along with many other documents as an evidence against the allegations we put up. One set of file was delivered to Tiljala Police Station and one set of file submitted with the state, at the Honourable Court of ACJM. Md. Rashid and Syed Sagir Ahmed are the one's who's been helping them in their illegal activities and crime for more than 2 decades and the primary accused named Nazia Ambreen Quraishi is getting help under the supervision of Md. Rashid and Syed Sagir Ahmed. Md. Rashid, Syed Sagir Ahmed are also a close relative of primary accused, Nazia Ambreen Quraishi and her family and in the very initial stage when this whole case started that time both my minor children and primary accused, Nazia Ambreen Quraishi stayed in the home of Md. Rashid and if you want to cross check the same which I am mentioning then kindly cross check the same as the proof and self testimony is registered and it is available in the Tiljala Police Station, FIR vide no. 265/22 and the Investigating officer is Raj Kumar. Kindly order to bring a C.D. along with the complaint copy of FIR No. 265/22 and in that complaint copy you will find that the testimony self declared by the primary accused named Nazia Ambreen Quraishi and the witness of that FIR which I mentioned vide

265/22 witness of the testimony is Md. Rashid and Syed Sagir Ahmed. Since, they came to know, that, we have got to know about the frauds and illegal activities and crime they are involved in, since that day with the help of Md. Rashid the primary accused named Nazia Ambreen Quraishi started playing hide and seek along with 2 minor children of mine. As mentioned in my RTI Application sent to you and even to other Concerned offices of both Central Government and State Government that they, I mean all the accused and involved in the Anti-National Activities which as well include "Cross Border Terrorism". I know it's not easily possible or should I say next to impossible to investigate that, but I have information via authentic source that Ghaiyyur Quraishi from America and Faisal Quraishi from Canada keep transferring funds to the Extremist and Terrorist organizations in order to execute their Anti-National Activities and in India mainly Ghaiyyur Quraishi from USA keep sending funds to Md. Rashid, Syed Sagir Ahmed and his own sibling who is primary accused, even to hear but via help of Western Union, MoneyGram and other firms as well to transfer the funds to India and then in just a day or should I say within seconds or maximum a minute hundreds of innocent children, father, mother died and we could do nothing and I say this in a state of dispare.

Q4) Did the Tiljala Police Station arrested any of the accused yet, by name, Md. Rashid, Syed Sagir Ahmed and Nazia Ambreen Quraishi who are present under the jurisdiction of Tiljala Police Station, and interrogated and questioned them as per the complaint registered by us in writing, these accused also need to be questioned about their involvement in the Anti National Activities and Cross Border Terrorism.

This is an answer we have received against this question number 4. Ok, can anyone in your respected office please tell me that what is restraining you from making an arrest of at least these 3 accused named, Md. Rashid, Syed Sagir Ahmed and Nazia Ambreen Quraishi. Instead of having clear ground and documented evidences which proof that many of our Allegations is proven as a established fact. Still, the Authority In-charge did not move for the arrest of at least these 3 accused. May we please know the reason that who is barring you and restricting you from making an arrest of these 3 accused

and safely handover both my minor children to me. Let me guess, see, in the first place Authority In-charge of Tiljala Police Station have very powerful documented evidences and I have recently received some more replies against the RTI Application we filed with MHA, Central Government and I have even forwarded the most efficient and effective Reply to the I.O. when only we 3 person was available. You asked me to share the scanned copy in pdf format of that reply letter, I did it instantly. You already have the letter of Ministry of External Affairs, Regional Passport Office, Kolkata which is a letter of cancellation and revocation of the Passport of the primary accused and miscreant named Nazia Ambreen Quraishi. You have a report copy of the FRO & a couple of more authentic documented evidences. So, even after having so much of material what is that thing which is restricting you of making an arrest of at least 3 accused as above mentioned. Md. Rashid and Syed Sagir Ahmed doing what in order to help them as well as Anti National Activities, which is something to argue about. At present the primary accused named Nazia Ambreen Quraishi is under the supervision of Md. Rashid and Syed Sagir Ahmed how he kept her in his house that i have already explained above and at present when so much has happened they are left with No option except to play hide and seek and Md. Rashid is trying to keep her safe so that police could not trace her. Appeal against : Refusal of information (Please vide RTI reply letter Memo No. **SED1-4424/HA, Dated- 28-12-2023**)

The SPIO has provided partial information, and for rest of information he has refused to provide. I am not satisfied with the reply received. I need progress report of my complaint.

I have been provided with just incomplete and partial information.

Hence I am not satisfied with the vague reply.

Please provide me the complete information as soon as possible.

Description of RTI application:

Background Content:-

This is in regards to the FIR Registered with Tiljala Police Station, Kolkata vide FIR No. 71/23 dated 24.03.2023 and the hearing for the same is going on with Honourable Court of the Additional Chief Judicial Magistrate, Alipore, 24 Parganas. A copy of the FIR is enclosed herewith for the reference.

As stated, the above mentioned FIR are in regards to the FOREIGNER's ACT, PASSPORT ACT & FORCEFUL ABDUCTION OF MY 2 MINOR CHILDREN.

In the very first place I want to mention that Tiljala Police Station once recovered my children at certain location from a specific home, then the primary accused and miscreant in the FIR named, Nazia Ambreen Quraishi was presented before the Child Welfare Commission along with my 2 children. Since then, both my minor children were under the jurisdiction and protection of Authority In-charge of Tiljala Police Station and under the watch and guidance of Child Welfare Commission. Now, being under such a protection of Tiljala Police Station and as well under the watch of Child Welfare Commission, the accused as named above Nazia Ambreen Quraishi, has again escaped and eloped from the above mentioned place and the home taking both my minor children along with herself and I could not find them at the place and the home from where the Tiljala Police Station rescued both my minor children.

Furthermore, the allegations which I claimed in the FIR, we have established the fact with documented evidences that accused named Nazia Ambreen Quraishi who falsely claimed to be the citizen of India, holds an educational qualification certificate issued to her in Deoria, Rampur Karkhana, Uttar Pradesh in the year 2007 and she declared the same with the Regional Passport Office, Kolkata in order to obtain the Passport of India and the Regional Passport Office, Kolkata as well issued her the Fresh Passport of India in the month of June, 2020.

Furthermore, the accused named Nazia Ambreen Quraishi herself declares that she has travelled to the Canada in the year 2007 for getting higher education and in Canada she took an admission with George Brown College, Toronto. Her student Enrollment Number and the department she took admission in with the mentioned college in Canada has already been drafted in the complaint copy of my FIR along with the copy of E-Mail the accused exchanged with authority of George Brown College with certain concerns of her own related to her studies and also provided with the photographs of her's where it shows her presence in Canada along with photographs with her physical presence in front of George Brown College and even along with her international friends group and that as i mentioned above that she herself have declared even the return time line back from Canada which is somewhere in the mid year of 2009.

Now, we have established the fact that she was present in Canada in the mentioned time line and in the mentioned time line she has declared herself to be the citizen of India but in the mentioned time line when she travelled to Canada, took admission in Canada in the college above mentioned and then again returned back by mid of 2009

she did not had the Passport of India as Ministry of External Affairs, Regional Passport Office has submitted the report with the concerned authorities that the Passport issued to the accused named Nazia Ambreen Quraishi in the month of June, 2020 is completely a First & Fresh Passport. So, the question is on which country's Passport did the accused named Nazia Ambreen Quraishi travelled to Canada in the year 2007 as she declared that she is a born citizen of India but did not had the Passport of India when she travelled to Canada, took admission in the above mentioned college in Canada and then finally returned back from Canada and all this in a time line of 2007 to 2009.

Henceforth, apart from the FIR i got registered with the concerned authority of Tiljala Police Station on the order of the Honourable Court of Additional Chief Judicial Magistrate Alipore, 24 Parganas, Kolkata implying the section 156 of CRPC vide FIR No. 71/23. I have also put up the complaints with the office of MINISTRY OF HOME AFFAIRS, CENTRAL GOVERNMENT, MINISTRY OF EXTERNAL AFFAIRS, DELHI, REGIONAL PASSPORT OFFICE, KOLKATA & other concerned Government and Public Office like Vigifance Commission of Central Government, Intelligence Bureau and many more.

Therefore, after the investigative movement from certain offices and Law Enforcement Agencies of Central Government the Ministry of External Affairs, Regional Passport Office, Kolkata, after receiving the investigation reports from concerned Law Enforcement Agencies, and recording my official statement in their respective offices the concerned office and the authority revoked and cancelled the Passport of India which was issued on June, 2020 to the accused named Nazia Ambreen Quraishi. The Authority In-charge of Tiljala Police Station have every information about the movement of Home Department of Central Government and Offices of External Affairs, Central Government and the mentioned offices of Central Government as well have exchanged the reports with the Authority Incharge of Tiljala Police Station.

I have as well informed some later known serious and dangerous concerns to the Authority In-charge of Tiljala Police Station that there are serious concerns relating to the CROSS BORDER TERRORISM and involved are the once who are accused in my registered FIR vide No. 71/23 with Tiljala Police Station. I have also informed about the same via written information to the concerned Offices and Departments of Central Government as it relates to the National Integrity and Social Security of our beloved

In my Registered FIR vide No. 71/23 with Tiljala Police Station, we have already mentioned in our complaint copy that the accused named Nazia Ambreen Quraishi along with the help of other named accused are planning to leave the country and flee away to Bangladesh again to escape the Law, Judiciary, Legal Trial and getting deported back to Bangladesh via Law and Judiciary and that they are planning to flee away by adopting illegal means along with both my minor children. Still, the Authority Incharge of Tiljala Police Station is least bothered and completely ignorant over such serious concerns.

It feels real Sad to see that, our Law Enforcement Agency, over here we want to mention that we are addressing to the Tiljala Police Station for the FIR Registered is with the mentioned Police Station and that accused have been residing under the jurisdiction of Tiljala Police Station and the mentioned Tiljala Police Station, the respected Authority In-charge is not taking any proper and strict action to stop and put an end to any and all illegal and cognizable offences and crimes so serious in nature, committed by the accused and other involved in the same and that all the accused are continuing with the same. It is simply a state of despair to mention that this attitude of Tiljala Police Station is a Straight Forward and Up-Front Negligence, henceforth, Compromising Over the National Security & Social Integrity of our Beloved Country, INDIA.

In view of the above, below are the Queries, which I request your good office to answer and provide for the certified documents related to the complaints made and action taken against the same, so that, we could put up the same with the Honourable Court of Additional Chief Judicial Magistrate as mentioned above.

Queries;-

1) Are both my minor children murdered and are dead by now?

- 4) Did the Tiljala Police Station arrested any of the accused yet, by name Md. Rashid, Syed Sagir Ahmed and Nazia Ambreen Quraishi who are present under the jurisdiction of Tiljala Police Station, and interrogated and questioned them as per the complaint registered by us?
- 5) Did the Tiljala Police Station yet presented any of the single accused before the Honourable Court and asked for the Custody in order to interrogate and question for the same, though be Md. Rashid, Syed Sagir Ahmed or Nazia Ambreen Quraishi?
- 6) Have the Authority In-charge of Tiljala Police Station yet received any reports from any office of the Central Government and if received, then kindly let us know what action has the Tiljala Police Station taken till date?
- 7) As mentioned, it's a established fact that the primary accused named Nazia Ambreen Quraishi travelled to Canada and returned back within a timeline of 2007 to 2009. Which country Passport did she used to travel to Canada? For Ministry of External Affairs, Regional Passport Office has confirmed that within the time line of 2007 to 2009 the named accused did not had the Passport of Republic of India. Kindly furnish the details that named accused travelled to Canada on which country Passport because she claimed to be the citizen of India in the mentioned time line.
- 8) Now that, the Passport and Nationality of the primary accused named Nazia Ambreen Quraishi has been cancelled by the concerned authorities and offices of India and she holds no legal Passport and Valid Visas or any other travel document which could favour her stay in our beloved country India or to continue her stay in our country India any further, has the Authority In-charge of Tiljala Police Station Officially involved the High Commission of Bangladesh in Kolkata, India and informed the said office about the same and the Authority In-charge of Tiljala Police Station started with the official

So, kindly furnish me with any and all certified copies related to this case of mine as discussed above, so that we could put up the same with the Honourable Court as details discussed above in order to the Justice to Prevail.





With reference to the above this is to inform you that in this instant petition the petitioner has sought to get certain information, the reply of which is point wise given bellow:

Q1. Are both my minor children murdered and are dead by now?

A. The petitioner has referred to a hypothetical situation. Presently there is no expressed Order of Ld court of Law upon the Police to take away the minor kids from their mother and hand them over to the petitioner (their father).

The main contention of the petitioner is that his wife is a Bangladeshi National and hence liable to be arrested. Investigation of the case is in progress in this regard and if sufficient evidence come to the forth which prima facie reveals that his allegations are true then appropriate legal action will be taken against his wife.

Q2. Are both my minor children have been supplied to any extremist and terrorist organisation or begging mafia of Bangladesh or Pakistani.

A. This is also a hypothetical question. This aspect has already been discussed in the reply to the previous question.

Q3. If both my minor children are still alive and not yet supplied to any terrorist organisation or begging mafia, then on which address and in which particular home are they residing at this very moment in this real time scenario. Kindly furnish me with the proper address and home where both my minor children are residing till date (i.e date of receipt of application). Only if, both my minor children are alive or if yet not supplied to any terrorist organisation or Begging Mafia of Bangladesh or Pakistan.

A. By this question the petitioner has basically wanted to know the exact present address of his wife and minor kids. His wife is an accused of this case while she is the complainant of another case lodged against the petitioner being Tiljala PS Case No. 265/22 dated 05.10.2022 U/S: 498A/406/506/34/313 IPC r.w 3 & 4 D.P. Act, It

is clear that she has not revealed her location to the accused. Neither has she given any expressed consent to police to reveal her location to her husband.

In this regard it appears that the nature of the information may fall within the category of information covered under Section 8(1) (j) RTI Act.

Q4. Did Tiljala Police station arrested any of the accused yet, by name Md. Rashid, Syed Sagir Ahmed and Nazia Ambreen Qureshi who at present under the jurisdiction of Tiljala Police Station, and interrogated and questioned them as per the complaint registered by us?

A. No. The non FIR named common relative of the petitioner and his wife has been examined and the Case Diary will reflect the progress of investigation.

Q5. Did the Tiljala Police station yet presented any of the single accused before the Honorable court and asked for the custody in order to interrogate and question for the same, though be MD Rashid, syed Sagir Ahmed or Nazia Ambreen Qurashi?

A. No.

Q6. Have the authority in-charge of Tiljala Police Station yet received any report from any office of the Central Government and if received, then kindly let us know what action has the Tiljala Police station taken till date.

A. The investigating agency has time to time submitted progress report of investigation before the Ld. Court. In such report, the Court was apprised of different replies and reports, collected by the investigating agency and those replies and reports have been kept in case diary for the perusal of the Ld court. It appears that though represented by his lawyer on court dates, the petitioner is unaware of the content of the reports and wants to know the same by means of this RTI petition. But as the investigation is in progress and sub judice the contents cannot be shared to the petitioner in this fashion which may jeopardise the investigation. However the petitioner has been always treated cordially whenever he arrived at this PS and progress of investigation was also shared with him.

A As the investigation of Tiljala PS Case No. 71 Dt. 24/03/23 U/S 120B/465/467/471/363 IPC r/w 14 A (b) Foreigners Act and 12 of Passport Act is going on, so furnishing such information at this stage may impede the procedure of investigation. This refers to section 8 (1) (h) of RTI Act. In this case the primary allegation is that the petitioner's wife is a Bangladeshi national and that she had married the petitioner by suppressing such fact. Thereafter she allegedly kidnapped the two minor children, born out of the wed-lock between the petitioner and her. The Police are investigating each and every aspect of the allegations, both in India and abroad. In addition to seeking some answers by means of this RTI application, the petitioner also labelled some allegations against the investigating agency.



4. Following the principles of natural justice, a Show Cause Notice was issued vide letter no 17(341)23/ PSK/RPO/KOL dated 12/06/2023. The show Cause Notice was dispatched to her address and also forwarded to the email address mentioned in the her passport application asking her why her passport no. U5604977 should not be revoked under Section 10(3) (b) of Passports Act, 1967. Stipulated time period (21 days) was given for response. The Section 10(3) (b) relevant to the instant case is as follows:-

10. Variation, impounding and revocation of passports and travel documents

(3) The passport authority may impound or cause to be impounded or revoke a passport or travel document,-

(b) if the passport or travel document was obtained by the suppression of material information or on the basis of wrong information provided by the holder of the passport or travel document or any other person on his behalf;

5. However, no response was received from the passport holder and the stipulated time is over.
6. From the facts mentioned above, it is affirmed that genuine attempt was made by this office so that the passport holder has sufficient opportunity to counter the charges made against him, but she failed to make use of the same.
7. In view of above, the passport no. U5604977 of Smt Nizia Ambreen Quraishi is hereby revoked under the provisions of Section 10 (3) (b) of the Passports Act, 1967.


