6. The grounds for appeal:

I: For that I, Shri Tanaji Das was posted at Cooch Behar District as Inspector MPB. Now retired on Superannuation dated 30.11.2024. I was joined at Police Training College, Barrackpore on 22.02.1993 as Cadet Sub-Inspector, Batch No.44/93 and after completion of my basic training I was posted to undivided to undivided Midnapore District. I was promoted to the rank of Inspector (UB) in the year 2012 and posted at Circle Inspector, Garchumuk, Uluberia, Howrah Rural District on 12.09.2012 (.). On 03.10.2024 a notification was circulated from Police Service Cell, Writer's Buildings, Kolkata, Government of West Bengal, Home and Hill Affairs Department, vide No. 1876-PS

CELL/HR/0/3P-50/2014 (Pt) dated 30.09.2024. Where 52 numbers of Inspector (Unarmed Branch)) have been promoted to rank of Deputy Superintendent of Police (Unarmed Branch) as in situ promotion; but I have not been promoted to the rank of Deputy Superintendent of Police (Unarmed Branch) on that list even though according to the seniority list. I was for this promotion as I could not know that caused for non enlisting in the aforesaid list.

II. For that an application under the Right to Information Act, 2005 was submitted before the State Public Information Officer, West Bengal Police Directorate and the Inspector General of Police (O), West Bengal under the RTI Act, 2005 on 30.11.2024, wherein I prayed before him to furnish the following information:

You are requested to inform me about it as on what ground of non-selecting on promotion to Rank of Deputy Superintendent of Police (Unarmed Branch) even though as per seniority list.

The photo copy of the RTI application dated 30.11.2024 is annexed herewith and marked as annexure "A" for your ready reference.

III. For that with reference to the RTI application dated 30.11.2024, it is hereby intimated by the State Public Information Officer, West Bengal Police Directorate and the Inspector General of Police (O), West Bengal that the information in connection with my RTI Application dated 30.11.2024 as received from the Deputy General Inspector of Police (Personnel) West Bengal with the copy of Letter No. 1808 – CELL/HR/O/3P-50/2014 (Pt) dated 23.09.24 to the Government of West Bengal, Home and Hill Affairs, Police Service Cell is sent herewith – which is self-explanatory.

It is pertinent to mention that there was no reason intimated to me for non-selecting me for promotion in the Rank of Deputy Superintendent of Police (Unarmed Branch) although I was eligible for the said promotion according to the seniority list/gradation List of Inspector of Police (Unarmed Branch) prepared by the authority concerned.

The photo copy of the Reply to the RTI Application dated 30.11.2024 is annexed herewith and marked as annexure "B" for your ready reference.

IV. For that the State Public Information Officer, West Bengal Police Directorate and the Inspector General of Police (O), West Bengal informed me that if I wish to appeal against the reply to the RTI Application, I can appeal within 30(thirty) days to the 1<sup>st</sup> Appellate Authority i.e. The Addl. Director General and Inspector General of Police (A), West Bengal is the 1<sup>st</sup> Appellate Authority of West Bengal Police Directorate from the date of receipt of reply and accordingly I filed the 1<sup>st</sup> Appeal before the 1<sup>st</sup> Appellate Authority on 25.01.2025.

V. Thereafter the 1<sup>st</sup> Appellate Authority was pleased to pass an appellate order in the following terms:

"Appellate Order

Perused RTI application dated 30.11.2024 and all related records:

RTI application dated 30.11.24 along with a court fee of Rs.10/- addressed to the SPIO, WBPD had been received at this office on 03.12.24 from Shri Tanaji Das. The applicant sought information regarding ground of not selecting on promotion to the rank of Dy.S.P.(UB) in West Bengal Police.

Assistance was asked from the DIGP (Personnel), WB vide this office Memo No. 489-ADM/RTI dated 09.12.24 by the SPIO, WBPD.

After receiving reply from the DIGP (Personnel), WB, information was sent to the applicant vide this office Memo No. 510-ADM/RTI dated 23.12.24 by the SPIO, WBPD within stipulated statutory period.

The petitioner preferred an appeal petition dated 25.01.25 with a court fee of Rs.20/- which was received on 27.01.25. It is clarified that fees for an Appeal petition is not required.

I perused all the records. I heard the view of the SPIO, WBPD in person.

After careful application of my mind judiciously, I conclude that the reply to the RTI application dated 30.11.24 of Shri Tanaji Das is satisfactory and as per the letter and spirit of the RTI Act, 2005. It is also clarified that explanation regarding reason does not come under the purview of section 2(f) of the RTI Act, 2005 as only recorded information is/are provided as per the RTI Act, 2005.

Hence, the appeal petition dated 25.01.25 is disposed of.

The Appellant may prefer appeal before the West Bengal Information Commission, "Khadya Bhawan", 11A, Mirza Ghalib Street, Kolkata - 700087, if he is not satisfied with this order." And being aggrieved by and dissatisfied with the order passed by the 1<sup>st</sup> Appellate Authority and hence the instant 2<sup>nd</sup> Appeal.

The Photocopy of the order of the 1<sup>st</sup> Appeal is annexed herewith and marked with letter 'C' for ready reference.

7. Particulars of the information :-

(I) Nature and subject matter of the information required:

On 03.10.2024 a notification was circulated from Police Service Cell, Writer's Buildings, Kolkata, Government of West Bengal, Home and Hill Affairs Department, vide No. 1876-PS CELL/HR/0/3P-50/2014 (Pt) dated 30.09.2024. Where 52 numbers of Inspectors (Unarmed Branch)) have been promoted to rank of Deputy Superintendent of Police (Unarmed Branch) as in situ promotion; but I have not been promoted to the rank of Deputy Superintendent of Police (Unarmed Branch) on that list even though according to the seniority list/Gradation list, although . I was eligible for the said promotion but I could not know the caused for non enlisting my name in the aforesaid list of promotion for the rank of the Deputy Superintendent of Police (Unarmed Branch).

You are therefore requested to furnish the information to me the reason behind non-selecting me for promotion in the rank of Deputy Superintendent of Police (Unarmed Branch) in terms of the Seniority list/Gradation list of Inspectors of Police (Unarmed Branch) prepared by the authority concerned.

8. That the information sought for does not fall within the exemption contained in section 8 and 9 of the Right to Information Act 2005 and to the best of my knowledge it pertains to your office.

9. I am enclosing the fixed Court fee of Rs.20/- as appeal fees as per provision contained in the Right to Information Act, 2005.
