- ii) Whether any candidate namely, Suma Barui (Roll no. 0405754) D/o Amerandra Barui, resident of Vill + PO -Dostipur, PS- Falta, Dist- S-24 Pgns, PIN- 743504 under OBC-B category, appeared in such examination for recruitment of ICDS Supervisor in 2019?
