





I hereby request you to provide information as per the rules of RTI Act 2005, information and particulars on the points listed below:

- 1) Kindly supply me a certified copy of information about my service tenure from the date of joining to date of retirement/till date with my basic pay, dearness allowance and increments made annually.
- 2) Kindly supply me a certified copy of information about my promotion, demotions, effect of Career Advancement Scheme and any others special allowances in my entire service life from the date of joining to date of retirement/till date.
- 3) Kindly supply me a certified copy of information regarding the manner/formula of deduction of the provident fund from salary and what are the rules/basis for calculating interest on it. Also provide me year wise balance sheet statement with @ of interest of my provident fund account for my entire service life from the date of joining to date of retirement/till date.
- 4) Kindly provide me a certified copy of information regarding the formula for calculation of my gratuity as applicable in CTC/WBTC. Also, last year as per Government memorandum no-5315 (P2)/FA/N/2M/50/23(N:B) dated 14/09/2023 ceiling on gratuity was enhanced payable under payment of gratuity act 1972 is hereby up to Rs -20,000,00/00 (Twenty Lakh) and this circular was implemented and made effective in WBSTC which is a constituent part of WBTC Ltd. in this context, kindly inform me as to why the above mentioned order of finance department (Audit branch) which is applicable to all is not binding upon WBTC Ltd. As a whole has not yet been made effective for CTC employees, taking into account that a copy of the said order was sent to our CTC also from the Finance department, audit branch Government of West Bengal and CTC/WBTC officials not been in action till date.
