

Re.: **Second Appeal under the provisions of the RTI Act/ Pollution --- Tibetan Delight**


I had filed an application with the Public Relations Officer and SPIO, West Bengal Pollution Control Board, Paribesh Bhawan, 10A Block LA, Sector III, Bidhan Nagar, Kolkata 700 106 for information under the RTI Act w.r.t. pollution/ inspection/ effluent sample of Tibetan Delight vide my application dated 25/4/24. I had 4 queries which were very clear and factual. They merited a simple answer. The SPIO gave me a very irrelevant, evasive answer which did not answer any of my questions. This tantamounts to refusal to give me information.

I filed a first appeal with the Appellate Authority vide letter dated 5/6/24, and sent a copy to the SPIO. The Appellate authority did not give me any reply or response whatsoever even though more than a month has passed.

Even though the statutory period for giving a reply has passed, I am yet to get the Information sought or response from the first appellate authority. This is against the provisions of the RTI Act, hence this second appeal.

Please therefore look into this matter and kindly ensure that I get the information sought at the earliest.

- 4] If yes, please let me have a copy of the report, along with the date of collection and the name/ designation of the official who collected the effluent sample.



Re.: **First Appeal under the RTI Act, 2005/ Tibetan Delight (restaurant) , 66/1 Chowringhee Road, Kolkata 700020.**

I had made an application dated 25/4/24 re the above unit to the SPIO, WBPCB. The SPIO responded vide his letter dated 16/5/2024 by giving a very vague reply, which did not reply my queries at all. This tantamount to refusing to give me a reply. A copy of my application and reply are enclosed for ready reference.

As you can see to in reply to all my 4 ( four) questions the SPIO has given a blanket reply and said "*Green Category industries having minimum pollution potential do not require any environmental inspection and as per the order of the State Board, officials shall carry out inspections as per instructions issued therein*".

The SPIO was meant to reply in the affirmative or negative to my question nos (1) and (3) due to the nature of the simple questions. To my question no. (2), he was meant to inform the number of times, the unit was inspected. He should have given a numeral like zero, one, two, etc., which he did not do: The question no. (4) merited giving me a copy of the report if inspection had taken place. However, he refused to answer this as well. Hence this First Appeal.

You are thus requested to consider my this **First Appeal**, and do the needful so I get the information sought at the earliest.

You are thus requested to kindly look into this matter and do the needful at the earliest. Awaiting your kind intervention in the matter and to getting the information sought soon.
