

Details of Information required by this complainant

Through his RTI Petition Dated 05/2/2024, this complainant namely Sri Krishnendu Banerjee wanted the certified copy u/s 2 F of RTI Act of all the relevant documents from State Vigilance Commission WB regarding Vigilance File No 'O'-691/2023 pertaining to Krishnendu Banerjee Vs ADJR Durgapur namely Sri Santanu Pal. . **(Please see Annexure 1/ Page no 1)**

Reason for this complaint

The concerned replying officers of State Vigilance Commission (WB) communicated with me & provided misleading information to me in response to my RTI Petition dated 05/2/2024. But, those concerned officers did not comply with the Section 2 F of RTI Act 2005. They did not provide any certified copy of the documents as per my requirement. They even did not ask for any requisite fees @/Rs 2 Per Page for obtaining the desired certified copies u/s 2 F of RTI Act. Literally those concerned officers intentionally bypassed my demand of certified copies u/s 2 F of RTI Act by virtue of providing me misleading, irrelevant information. **Therefore, this complaint is raised against SPIO & 1st Appellate Authority of State Vigilance Commission WB, Bikash Bhavan, Salt-Lake, Kolkata 700091**

- v. Being aggrieved this complainant, through his Application Dated 9/4/2024 preferred 1st Appeal before West Bengal Police Directorate because this complainant was not provided particular information about the concerned 1st Appellate Authority. **(Please see Annexure 5/ Page no 6)**
- vi. Subsequently, the same First Appeal Application Dated 9/4/2024 has been forwarded to First Appellate Authority of State Vigilance Commission WB from IGP (O) of West Bengal Police Directorate vide his Memo No-177/ ADM RTI/ADM/RTI-81/24 Dated 25/4/2024. **(Please see Annexure 6/ Page no 7)**
- vii. 





Reason for this 1st Appeal as well as reason for being Aggrieved

Through my RTI Petition dated 5/2/2024 & as per Section 2 (f) of RTI Act 2005..... I requested certified copies of all the documents that are related to my complaint dated 18/8/2023 against Sri Shantanu Paul who is Addl. District Sub Registrar Durgapur (Dist Paschim Bardhaman, Pin 713216) & my such complaint has been numbered by concerned Officer of State Vigilance Commission WB as being Vigilance File No "O" 691/2023. (Regarding this complaint, the Anti-Corruption Inspector of Vigilance (Paschim Bardhaman) called Sri Sujoy Ghosh has recorded my written statement on 15/9/23)

But, in total disobedience to Section 2(f) of RTI Act, neither the required documents are given to me nor requisite fees for documents collected from me by the above-said Dy Secretary & SPIO of State Vigilance Commission WB. His Memo Dated 1/4/2024 contains improper, wrongful, false, misleading information that is related to my another complaint dated 23/11/2023 which is not at all required by me in my RTI Petition dated 5/2/2024. **THEREFORE, I AM AGGRIEVED** because my citizen right is infringed for the illegalities as stated above.
