F.A.A. Passed materially in fructuous order despite my contentions in appeal hearing to supply 'authenticated xerox copy' instead 'attested copy' of deeds available from N.W.O xerox copy existing with SP10 duly catalogued & indexed to be collated in very short time as deeds have been acted upon in very short time - Period M.N cases and the few deed is still running to be acted upon in new MN case.

For Point No-2 - Specific information sought as to Mohan's name and ID in MN cases - but misconceived as non-specific.

For Point No-3 - though directed to deliver in 10 days but no response from SP10 till date - even after my fresh prayer through email from my husband's mobile dt 09.7.24 but of no avail.

8. Prayer or relief sought - Passing order with direction to provide all the information as sought in line with provision of RTI Act setting aside any mechanical technicalities.
9. Grounds for prayer or relief - Low cost information in collated small size - easily and comfortably receivable from one source (SP10) as per RTI Act without any hazard or embarras to the very old feeble bodied Sr citizen lady.
10. Other important information in light of provisions of RTI Act relevant to the appeal -
 - i) Information sought is not personal or private information, it is of intestated ancestral property in which myself as well other owners as successor as warish has share, title interest to the property.
 - ii) not refusible to disclose by Coowner third party in allowance of unrestricted veto to refuse as per Sec 11 (1)
 - iii) not exempted u/s 8 (1)(j), not in fiduciary custody of SP10
 - iv) Practice of unwarranted invasion of others' Property by Coowner third party in illegal and fraudulent manner is considered criminal offence under sections of I.P.C. the disclosure of which has Larger Public Interest.
 - v) As the moment MN cases get granted it does not remain confined to personal or private activity, it enters into the space of Public activity by SP10
 - vi) To contain Corruption, Proactive and Spontaneous role for redressal including disclosure of illegal and wrongdoing of its own - all this lead to greater transparency and accountability the very objective of RTI Act

vii) R.T.I has an overriding effect,







You are competent enough to supply xerox copy from xerox copy of deeds retained with you with authentication slip as vividly deposited in Appeal hearing. You have supplied sister deed no 242/2005 but severance of its mother deed no 6631/1992 is questionable..

Additional information as request to collect from ADSR is nothing but unscrupulous dodging to refuse to supply ,not tenable in RTI Act.as RTI has overriding effect .

More so, practice of unwarranted invasion of others' property by co-owner third party in fraudulent manner ,making prey the PIO itself, considered as criminal offence in multiple sec of IPC. The disclosure of which has larger public interest. While MN cases gets executed by PIO itself it does not remain confined to private activity for others' personal information.

Spontaneous redressal incuding disclosure of wrong doing seeded by third party in his personal capacity but thumped by PIO in public capacity leads to contain corruption, larger transparency and accountability, the very objectives of RTI Act..

So in light of proven ,once more fervently requested ,in aspiration, not in direction, to supply information as sought setting aside any mechanical technicalities in word meaning as RTI. has overriding effect not withstanding any contents in other provisions of Law in manner or procedure.


