

6a) remark on SPIO response : SPIO not considered my first five pointwise seeked information as any type of information, held by his office, as per as SPIO points are not any type of information but these are seeking elaboration & explanation on a memo, but if director instructed after perusal of documents on records as mentioned in said memo so I wanted to know whether director seeked any Xerox volumes, digitised volumes, scanned volumes or original volumes of said cs khatians, then why word perusal of documents on records mouza wise is used by director in his said memo. If one seek information on what is base documents for such instruction by director of connected dte question of seeking elaboration, explanation does not arise, I want information regarding documents on records as mentioned in said memo, but SPIO does not give my desired information's.

9) Nature of response by 1st appellate authority first appellate authority
unlawfully transferred my petition to DL&LRO paschim midnapur by passing order vide memo no
3/15/131/2/IC /2024 dt 02/05/2024 holding that seeked information is connected with Office of
ADM & DL&LRO paschim midnapur ,but I seeked information regarding supportive documents and in
which formats these documents on records analysed by Director of land records & survey before
issuing direction vide said memo of his dte.

9a) Remarks I seeked some information regarding cs records
which was mentioned by Director of Directorate of land records & surveys west bengal in one of his
office memo no 210/405/C/16 dt 13/03/2019 issued by this Director, point wise i seeked
information wether any digitised ,Xerox or original volumes of said cs records is examined or
persued before issuing such memo ,I also seeked what kind of cs records these are (wether they are
first published records or continuous updated records as that like kb khatians on cs records),also in
light of letter no 384 LP dt 02/02/2021, issued by govt of west bengal it mentions if land is
transferred by recorded tenant then no previous chain deeds is required so it means if one name of
tenant or raiyat is found to be entered in cs records this entry is unchallenged and taken to be
absolute correct no previous chain deeds is required to establish bonafide transfers since first
publication of records for preparation of LR records of five khasmahal mouzas of paschim midnapur
as mentioned in said memo,so to prevent any systemic corruption by willfully entering a desired
name in that cs record in collusion with corrupt officials,so to know if any measures taken by
authority to prevent any willfully tempering of said cs records,and wether any digitised ,scanned or
any authentic volumes of said cs khatians consulted by officials to prepare LR records is kept
preserved for future reference in case of any dispute or allegation of corruption,and the cs records
which is used by authorities for preparation of LRROR is not given in public domain either it's
Xerox,or digitised or scanned or original volumes are available for people,so I filed rti to know all
details of said cs khatians as mentioned in said memo consulted by officials for preparation of new
LR records started after government notification 313 LP ,but SPIO not taken my first five queries as
any information ,in response of 6th point only informed me vide memo no 7/11/IC//2023 dt
10/01/2024 that cs records are available with district magistrate and collector but in reply of one rti
adm LR and DL&LRO (district magistrate & collector)appellate authority informed cs records is
available at Records room of District magistrate and on finding same at records room i only found
first published records of year 1945,but officials are not linking chain deeds upto 1945 they are
taking last entered name in said cs khatians as last bonafide tenant,which is not available for
common people for inspection,also in reply of my one rti BL&LRO kharagpur 1 vide his office memo
no 1632/kgp-1/2022 dt 04/07/2022 Informed me that BL&LRO is not coustodian of original cs
records csror khatians only a copied volume(Xerox) supplied to them from higher authority that is
restored in SDL& LRO kharagpur office ,so.I filed one rti to SDL&LRO kharagpur on 29/08/2022
seeking information regarding any type of cs records or csror khatians of kharagpur khasjungle

mouza is available at his office and allow me to inspect same ,but SDL&LRO kharagpur vide his office memo no 2007/SDL(KGP)/RTI/11/2022 dt 29/09/2022 informed me that his office is not the coustodian of csror or cs records of connected mouza,. So after so much contradictory replies on cs records as mentioned in said memo by district authorities,so to know details of said cs khatians and cs records of said five khasmahal mouzas including kharagpur khasjungle mouza as mention in memo no. 210/405/C/16 I filed rti to director DLR&S ,and later 1st appeal and the finally this 2nd appeal to WBIC.

10) Relief sought a) please let me know in which format(Xerox,scanned,digitised,or original volumes) said cs records is perused and investigated by Director as mentioned in memo no 210/405/C/16 and please let allow me to inspect same for my desired khatians numbers.

b) let me know if any digitised or scanned copies of said cs records and khatians as mention in memo no 210/405/C/16 dt 13/03/2019 is kept saved for future reference.if kept please provide me the copy of same for my desired khatian numbers.

c) please let me know who is coustodian of original volumes of said cs khatians as mentioned in memo no 210/405/C/16 dt 13/03/2019 issued by Director of DLR&S.

d) As the Director of DLR&S in his memo no 210/405/C/16 dt 13/03/2019 mentioned that on perusal of documents on records mouza wise so please let me know what is the source of such documents and which authority provided such documents to DLR&S .

(delivered to me on 13/01/24 via speed post) SPIO informed me that your questions does not comes under the defination of information under RTI act 2005, rather you are seeking explanation and interpretation of a memo issued by DLR&S, also informed that CS records are with District magistrate- collector.

4) Reason for Appeal: Being unsatisfied by reply of SPIO i preferred this appeal

5) Facts leading to appeal

a) As in memo no 210/405/C/16 dt 13/03/2019

DLR&S himself admitted that on perusal of documents on records mouza wise for said five khasmahal mouzas of paschim midnapur and after that action was proposed for preparation of ROR that means DLR&S had seen studied analysed the cs record , and any direction by senior authorities to junior authorities must be clear and carry specific directions and it should be free of ambiguity.

5.b) It is very clear that from submission by DLR&S that complete information regarding cs khatians of khasmahal mouzas is available with DLR&S and after examining the cs recotd thereafter said memo is issued by the then DLR&S. So I seeked information regarding type of cs records wether each khatians have only starting names or it is a kind of a kb khatians on cs records also reflecting status of post cadastral settlement era till 1975-77.

5. c) DLR&S mentioned that on perusal of records mouza wise and then action regarding preparation of LR records was proposed in said memo, so I wanted to know wether original volumes or any type of Xerox or digitised volumes were studied and analysed by the then DLR&S so point of explantion and interpretation on said memo does not arises ,the seeked information is already with DLR&S and please share the same.

Jai prakash sharma

That cs records means the records first published in 1945 for said five khasmahal mouzas with first starting names on each khatians which is preserved at District records room and that volumes of cs records can't be edited and any type of new entries or court orders etc can't be reflected in those khatians in any way, but other similar volumes were made available with local revenue officer who later became JLRO for updating the cs khatians and cs ROR, to collect the revenues and update the amount of revenue, to solve dispute in ownership or similar matters, to reflect any type of court orders or to produce as exhibit in court proceedings etc work after cadastral settlement and other day to day needful entries were reflected in said cs khatians, those khatians can also be called as kb khatians or serving the purpose of kb khatians reflecting names of new bonafied owners after cs settlement, but the SPIO not mentioned anything regarding said KB khatians which is also a part of cs records and hence not disclosed complete information of cs records cs khatians of khasmahal mouzas and information regarding cs records of said five khasmahal mouzas, and this information was already available with the DLR&S so I wanted to know what type of cs records and khatians is mentioned in said memo.

5.e) As in Notification no 313 LP dt 29/01/2019 it is clearly mentioned that 30 years lease expires in 1975 so it begun in 1945 and said kb khatians of cs records were operational and active till 1975 despite of RS settlement during 1955-60, also RS modified khatians were not prepared after RS settlement and that said kb khatians of cs records continued till 1977, then later in early eighties LR operation started during cpm regime.

5. f) DLR&S himself mentioned that on perusal of documents on records mouza wise and then action proposed regarding settlement which started after notification no 313 LP, it means documents were carefully examined, studied by DLR&S so I seeked information that whether original volumes of cs records is pursued and examined or digitised copies were pursued and examined so no point of interpretation or explanation seeked rather these informations were already available with DLR&S.

5.g) obviously if any documents which were pursued before recent LR settlement and ROR is prepared after consulting that said cs records obviously it should not be destroyed after publication of names it must had been kept safe for future purpose and scrutiny, so I seeked information that if any digitised copies is kept safe for future reference so point of manufacturing, interpretation, explanation on memo does not arise and seeked information is already available with DLR&S.

5.i) As the contents in letter no 384LP dt 02/02/2021 by government of West Bengal is such that to know recorded tenant it is required to consult cs khatians if land is transferred by recorded tenant or their successors then no previous chain deed is required so obviously to prevent any tempering on said cs khatians DLR&S must had been given any direction, if no steps taken by

&S then answer can be given in no but question does not arise of explanation or manufacturing of information.

5.j) SPIO only informed that CS records is available with District magistrate and collector but at district records room of DM one will only find the volumes of cs records which was published in 1945 for connected khasmahal mouza's with first starting names on each khatians that is showing status of 1945 of cadastral survey and SPIO seriously ignored facts regarding KB khatians of CS records which was lastly managed by revenue officer and later JLRO 's for these five khasmahal mouzas, till 1977.

So under above mention facts, legal points and submission made by the then DLR&S in memo no 210/415/C/16 dt 13/03/2019, complete CS records connected with the said five khasmahal mouza's is first published cs khatians kept at District records under coustody of DM &Collector which is uneditable and another volumes of CS records and khatians connected with said five khasmahal mouza's are the KB khatians started since 1945 on similar volumes of CS khatians and which was lastly managed, maintained and updated by the then JLRO till 1977 Please upheld my this RTI appeal and direct SPIO to disclose complete details on complete CS records connected with said five khasmahal mouzas as seeked in my RTI prayer dt 15/12/2023 and disclose if same had been digitised and kept safe for future purpose and details of its present coustodians.





With reference to above, a note was forwarded to L&LR and RR&R Department regarding the above mentioned subject matter and on getting due approval from the Department, same is communicated to him for guidance of the field level functionaries engaged in the preparation of RORs.

On perusal of documents on records Mouza-wise status of the mouzas and proposed action to be taken are herein under:

1. LR work of the five mouzas should be done through amalgamation of stages. Necessary order has already been passed vide Department's notification no: 635/LP/IL-130/18GE(N) dated 27.2.2019.
2. During recording of above noted five Mouzas, CS record may always be consulted. Non agricultural tenant recorded in CS Khatian or their legal heirs and subsequent transferees who are in possession will be recorded as raiyat as per notification dated 29.1.2019. published by the Government.

It has been clarified that non agricultural tenant guided by NAT Act 1949 has become raiyat who had been in continuous occupation of the land for 12 years prior to coming into force of NAT Act 1949 as per provision of Sec 3A of the WBLR Act 1955 w. e. f. 9.9.1980.

Other occupiers may not be treated as raiyat and their possession may be regularized through term lease.

Sir,

I am directed to refer to your Memo No.5794/E/PK(Khasmahal)/2016 Dated 01/12/2020 addressed to the DLR&S, WB on the above subject and to prescribe the following in disposal of the cases mentioned in the memo under reference.

- (1) Occupier having notarial documents/unregistered documents may be given the same weightage as of registered indenture and record may be corrected where transferor concerned is found fit as a raiyat in terms of this Department's Notification No.313-LP Dated 29/01/2019. Such notarial / unregistered document for the settlement should be made prior to the date of issuance of Notification No.313-LP Dated 29/01/2019. The onus of authenticity of such document shall lie upon the applicant concerned.
- (2) Where the land is found to have transferred from the recorded tenant, who is eligible to be raiyat in terms of this Department's Notification No.313-LP Dated 29/01/2019, previous chain is not mandatory for establishing his/her right on the land but his possession/ occupation is important.
- (3) All leases whether subsisting or discontinued on such land should be dispensed with immediate effect declaring lessees as raiyats and such application may be



which formats these documents on records analysed by Director of land records & survey before
issuing direction vide said memo of his dt.

(9a) Remarks

I sought some information regarding cs records
which was mentioned by Director of land records & surveys west bengal in one of his
office memo no 210/405/C/16 dt 13/03/2019 issued by this Director, point wise I sought
information whether any digitised, Xerox or original volumes of said cs records is examined or
perused before issuing such memo, I also sought what kind of cs records these are (whether they are
first published records or continuous updated records as that like kb khatians on cs records), also in
light of letter no 384 LP dt 02/02/2021, issued by govt of west bengal it mentions if land is
transferred by recorded tenant then no previous chain deeds is required so it means if one name of
tenant or riyat is found to be entered in cs records this entry is unchallenged and taken to be
absolute correct no previous chain deeds is required to establish bonafide transfers since first
publication of records for preparation of LR records of five khasmahal mouzas of paschim midnapur
as mentioned in said memo, so to prevent any systemic corruption by willfully entering a desired
name in that cs record in collusion with corrupt officials, so to know if any measures taken by
authority to prevent any willfully tampering of said cs records, and whether any digitised, scanned or
any authentic volumes of said cs khatians consulted by officials to prepare LR records is kept
preserved for future reference in case of any dispute or allegation of corruption, and the cs records
which is used by authorities for preparation of LROR is not given in public domain either its
Xerox, or digitised or scanned or original volumes are available for people, so I filed rti to know all
details of said cs khatians as mentioned in said memo consulted by officials for preparation of new
LR records started after government notification 313 LP, but SP10 not taken my first five queries as
any information, in response of 6th point only informed me vide memo no 7/11/IC//2023 dt
10/01/2024 that cs records are available with district magistrate and collector but in reply of one rti
adm LR and DL&RO (district magistrate & collector) appellate authority informed cs records is
available at Records room of District magistrate and on finding same at records room I only found
first published records of year 1945, but officials are not linking chain deeds upto 1945 they are
taking last entered name in said cs khatians as last bonafide tenant, which is not available for
common people for inspection, also in reply of my one rti BL&RO kharagpur I vide his office memo
no 1632/kgp-I/2022 dt 04/07/2022 informed me that BL&RO is not custodian of original cs
records csor khatians only a copied volume (Xerox) supplied to them from higher authority that is
restored in SD& LRO kharagpur office, so I filed one rti to SD&LRO kharagpur on 29/08/2022
seeking information regarding any type of cs records or csor khatians of kharagpur khasjungle

mouza is available at his office and allow me to inspect same, but SD&LRO kharagpur vide his office memo no 2007/SDL(KGP)/RTI/11/2022 dt 29/09/2022 informed me that his office is not the custodian of cs records or cs records of connected mouza. So after so much contradictory replies on cs records as mentioned in said memo by district authorities, so to know details of said cs khatians and cs records of said five khasmahal mouzas including kharagpur khasjungle mouza as mention in memo no. 210/405/C/16 I filed rti to director DLR&S, and later 1st appeal and the finally this 2nd appeal to WBIC.





(delivered to me on 13/01/24 via speed post)SPIO informed me that your questions does not comes under the defination of information under RTI act 2005,rather you are seeking explanation and interpretation of a memo issued by DLR&S, also informed that CS records are with District magistrate- collector.

4) Reason for Appeal: Being unsatisfied by reply of SPIO i preferred this appeal

5) Facts leading to appeal

a) As in memo no 210/405/C/16 dt 13/03/2019

DLR&S himself admitted that on perusal of documents on records mouza wise for said five khasmahal mouzas of paschim midnapur and after that action was proposed for preparation of ROR that means DLR&S had seen studied analysed the cs record , and any direction by senior authorities to junior authorities must be clear and carry specific directions and it should be free of ambiguity.

5.b) It is very clear that from submission by DLR&S that complete information regarding cs khatians of khasmahal mouzas is available with DLR&S and after examining the cs recotd thenafter said memo is issued by the then DLR&S. So I seeked information regarding type of cs records wether each khatians have only starting names or it is a kind of a kb khatians on cs records also reflecting status of post cadastral settlement era till 1975-77.

5. c) DLR&S mentioned that on perusal of records mouza wise and then action regarding preparation of LR records was proposed in said memo, so I wanted to know wether original volumes or any type of Xerox or digitised volumes were studied and analysed by the then DLR&S so point of explantion and interpretation on said memo does not arises ,the seeked information is already with DLR&S and please share the same.

That cs records means the records first published in 1945 for said five khasmahal mouzas with first starting names on each khatians which is preserved at District records room and that volumes of cs records can't be edited and any type of new entries or court orders etc can't be reflected in those khatians in any way, but other similar volumes were made available with local revenue officer who later became JLRO for updating the cs khatians and cs ROR, to collect the revenues and update the amount of revenue, to solve dispute in owner ship or similar matters, to reflect any type of court orders or to produce as exhibit in court proceedings etc work after cadastral settlement and other day to day needful entries were reflected in said cs khatians, those khatians can also called be as kb khatians or serving the purpose of kb khatians reflecting names of new bonafied owners after cs settlement, but the SPIO not mentioned any thing regarding said KB khatians which is also a part of cs records and hence not disclosed complete information of cs records cs khatians of khasmahal mouzas and information regarding cs records of said five khasmahal mouzas, and this information was already available with the DLR&S so I wanted to know what type of cs records and khatians is mentioned in said memo.

5.e) As in Notification no 313 LP dt 29/01/2019 it is clearly mentioned that 30 years lease expires in 1975 so it begun in 1945 and said kb khatians of cs records were operational and active till 1975 despite of RS settlement during 1955-60, also RS modified khatians were not prepared after RS settlement and that said kb khatians of cs records continued till 1977, then later in early eighties LR operation started during cpm regime.

5. f) DLR&S himself mentioned that on perusal of documents on records mouza wise and then action proposed regarding settlement which started after notification no 313 LP, it means documents were carefully examined, studied by DLR&S so I seeked information that wether original volumes of cs records is persued and examined or digitised copies were pursued and examined so no point of interpretation or explanation seeked rather these informations were already available with DLR&S.

5.g) obviously if any documents which were pursued before recent LR settlement and ROR is prepared after consulting that said cs records obviously it should not be destroyed after publication of names it must had been kept safe for future purpose and sructiny, so I seeked information that if any digitised copies is kept safe for future reference so point of manufacturing, interpretation, explanation on memo does not arises and seeked information is already available with DLR&S.

5.i) As the contents in letter no 384LP dt 02/02/2021 by government of West Bengal is such that to know recorded tenant it is required to consult cs khatians if land is transferred by recorded tenant or their successors then no previous chain deed is required so obviously to prevent any tempering on said cs khatians DLR&S must had been given any direction, if no steps taken by

.&S then answer can be given in no but question does not arise of explanation or manufacturing of information.

5.j) SPIO only informed that CS records is available with District magistrate and collector but at district records room of DM one will only find the volumes of cs records which was published in 1945 for connected khasmahal mouza's with first starting names on each khatians that is showing status of 1945 of cadastral survey and SPIO seriously ignored facts regarding KB khatians of CS records which was lastly managed by revenue officer and later JLRO 's for these five khasmahal mouzas, till 1977.

So under above mention facts, legal points and submission made by the then DLR&S in memo no 210/415/C/16 dt 13/03/2019, complete CS records connected with the said five khasmahal mouza's is first published cs khatians kept at District records under coustody of DM & Collector which is uneditable and another volumes of CS records and khatians connected with said five khasmahal mouza's are the KB khatians started since 1945 on similar volumes of CS khatians and which was lastly managed, maintained and updated by the then JLRO till 1977 Please upheld my this RTI appeal and direct SPIO to disclose complete details on complete CS records connected with said five khasmahal mouzas as seeked in my RTI prayer dt 15/12/2023 and disclose if same had been digitised and kept safe for future purpose and details of its present coustodians.




With reference to above, a note was forwarded to L&LR and RR&R Department regarding the above mentioned subject matter and on getting due approval from the Department, same is communicated to him for guidance of the field level functionaries engaged in the preparation of RORs.

On perusal of documents on records Mouza-wise status of the mouzas and proposed action to be taken are herein under:

1. LR work of the five mouzas should be done through amalgamation of stages. Necessary order has already been passed vide Department's notification no: 635/LP/IL-130/18GE(N) dated 27.2.2019.
2. During recording of above noted five Mouzas, CS record may always be consulted. Non agricultural tenant recorded in CS Khatian or their legal heirs and subsequent transferees who are in possession will be recorded as raiyat as per notification dated 29.1.2019. published by the Government.

It has been clarified that non agricultural tenant guided by NAT Act 1949 has become raiyat who had been in continuous occupation of the land for 12 years prior to coming into force of NAT Act 1949 as per provision of Sec 3A of the WBLR Act 1955 w. e. f. 9.9.1980.

Other occupiers may not be treated as raiyat and their possession may be regularized through term lease.

Sir,

I am directed to refer to your Memo No.5794/E/PK(Khasmahal)/2016 Dated 01/12/2020 addressed to the DLR&S, WB on the above subject and to prescribe the following in disposal of the cases mentioned in the memo under reference:

- (1) Occupier having notarial documents/unregistered documents may be given the same weightage as of registered indenture and record may be corrected where transferor concerned is found fit as a raiyat in terms of this Department's Notification No.313-LP Dated 29/01/2019. Such notarial / unregistered document for the settlement should be made prior to the date of issuance of Notification No.313-LP Dated 29/01/2019. The onus of authenticity of such document shall lie upon the applicant concerned.
- (2) Where the land is found to have transferred from the recorded tenant, who is eligible to be raiyat in terms of this Department's Notification No.313-LP Dated 29/01/2019, previous chain is not mandatory for establishing his/her right on the land but his possession/ occupation is important.


