2. Brief facts leading to appeal.

1st Appellate Authority refused to answer the query no.3,4,5 and 6 made in application dated 19.12.2023 by citing the provision of 2(f) and 2 (d) of the RTI Act. But the provisions of getting such information are available and there is no statutory bar since the Act is a beneficial legislation and an example of welfare state.

The Appellate Authority failed to realise that the Act is a procedural law hence the 1st Appellate Authority has disobeyed by not giving reply to Appeal.

Since the Appellant is an enlisted contractor is competing against other enlisted contractors for the sake of transparency the appellant is entitled to get information.
