9. **Authority to whom the first appeal was made with address:** The Learned Additional District Magistrate (General), Hooghly, being the Learned First Appellate Authority under the Right To Information Act, 2005, having Office at New Administrative Building, P.O. Chinsurah, Hooghly, Pin: 712101.
10. **Decision of the 1st Appellate Authority, if any, including number and date of the order:**
- Yes. A hearing was fixed on 11/07/2024 at 12 P.M. before the Office of the Learned Additional District Magistrate (General), Hooghly, being the Learned First Appellate Authority under the RTI Act, 2005, having Office at New Administrative Building, P.O. Chinsurah, Hooghly, Pin: 712101. The date of hearing was notified vide a Notice bearing Memo No. 1751(2)/L.A. dated 02/07/2024 which was received by the appellants herein.
 - The appellants being Nos. 1(c) and 1(d) were personally present along with their Learned Advocate. They were represented and after hearing an Order dated 11.07.2024 vide Memo being No. 1901/L.A. dated 16.07.2024 was communicated vide an email dated July 16, 2024 from the Office of the Learned Additional District Magistrate (General), Hooghly, being the Learned First Appellate Authority under the RTI Act, 2005.
 - In the said email dated July 16, 2024, the appellants were supplied with the scanned copies of the relevant Gazette Notification, List of Award Holders and Possession Certificate in connection with the said land.
 - However, no documents relating to Map/Sketch Map showing acquired portion/s of the said land was supplied in connection with the RTI Appeal, that is, the 1st Appeal under Section 19(1) of the said Act of 2005. It was only stated that the relevant desired map is not readily available.
11. **Grounds for 2nd appeal and the relief sought (specify):**
- FOR THAT the respondent authority had failed and/or neglected to provide the Map/Sketch Map showing acquired portion/s of the said land in question of which the appellants are the owners.
 - FOR THAT the respondent authority is under a statutory obligation to provide the information and documents as sought for by the appellants as those are not under any restriction as per law.

- III. FOR THAT the respondent cannot just simply state that the relevant desired map is not readily available in connection with the RTI appeal dated 24/06/2024 as filed by the appellants herein.
- IV. FOR THAT the respondent authority could not have denied the right of the appellants from exerting his rights secured under The Right To Information Act, 2005.
- V. FOR THAT the respondent authority has failed and/or neglected to discharge its statutory obligation to provide the information and documents as sought for by the appellants herein which is a deemed refusal thereby causing absolute injustice to the legal rights of the appellants.
- VI. FOR THAT the conduct of the respondent authority is highly against the spirit if the Right To Information Act, 2005.
- VII. FOR THAT the Map/Sketch Map indicating the portion/s which has/have been acquired by the State is a vital piece of document which is required by the appellants herein as the State is under an obligation to demarcate the acquired portion keeping the non-acquired portion/s, undisturbed and free to be used by the owners (being the appellants herein).
- VIII. FOR THAT the respondent is under a statutory obligation under the said Act of 2005 to provide the relevant documents as sought for.
- IX. FOR THAT the respondent authority has acted in a manner so as to infringe the appellants' valuable rights under Article 300A of the Constitution of India by not providing the relevant map showing the portion/s acquired by the State which is why the appellants are not in position to use rest of the lands in the manner they wish to.
- X. FOR THAT the appellants are losing their vital rights over their own property due to the inaction and/or non-action on the part of the State machineries due to want of clear information as to which portion/s of the said land has been acquired.
12. If 2nd appeal is filed after 90 days from the date on which the decision of the 1st Appellate Authority was received or after 135 days from the date of filing of the 1st appeal, explain the reasons for the delay along with supporting documents: Not Applicable.







6. Particulars of the decision:

By the said memo, dated 27.2.2024, she was informed that 0.03 acre of plot no. 220 of Mouza: Hakimpur (J.L. No. 41) under P.S. Singur had been acquired in L.A. Case No. I-31/1959-60 and that Suresh Chandra Batabel, Dhiren Chandra Batabel, Kanai Chandra Batabel, all sons of Krishna Chandra Batabel; and Parul Bala Batabel, wife of Sudhir Chandra Batabel, received the award. 





Heard learned counsels for the parties.

The notice issued upon the petitioners under Section 10(1) of the West Bengal Highways Act, 1964 on 1st February, 2024 and a subsequent reminder issued thereto on 23rd February, 2024 are assailed in the writ petition.

The primary grievance of the petitioners is that the notice was issued without demarcation of the portion of the plot in question claimed to be acquired by the State respondents.

The order passed on 9th May, 2024 records that the State respondents submitted before this Court that notice was issued without demarcation of the portion of the plot

in question though the said portion was acquired by the State sometime in 1959-1960.

Learned counsel for the 9th respondent submits that the GAIL has decided to lay the pipe line through the middle of the road without touching upon the plot in dispute.

It is not in dispute that notice under Section 10(1) of the 1964 Act was issued without the portion of plot in question being plot no.220, J.L. No. 41, Mouza Hakimpurgram, L.R. Khatian no. 98 being demarcated by the respondents.

In view of the above, this Court is inclined to hold that since a portion of plot no. 220 has been acquired as submitted on behalf of the State respondents, it was incumbent upon the State respondents to demarcate the acquired portion of the land before coming to a conclusion that such land was encroached upon/illegally occupied by the petitioners.

Accordingly, the notices impugned issued on 1st February, 2024 and 23rd February, 2024 respectively are set aside/quashed.

The Block Land & Land Reforms Officer, Singur, being the 7th respondent herein, is directed to demarcate the acquired portion of the plot in question upon service of notice to all concerned including the petitioners and submit a report to that effect before the 4th respondent within one month from date. Upon receipt of such report, in event encroachment upon Government land or any

portion thereof is found, the 4th respondent shall take necessary steps for removal of the same, in accordance with law.

On prayer of the petitioners, liberty is granted to approach the concerned authority under the Right to Information Act for furnishing relevant documents with regard to the acquisition of the plot in question.

With the aforesaid observations and directions, the writ petition is disposed of.

There shall however, be no order as to costs.

Since no affidavit is invited, the allegations contained in the petition are deemed not to have been admitted.




