Sir/Madam,

We beg to draw your kind notice that the below mentioned plots of land are purchased by us under two mouza which was recorded previously in the name of the vendor in the R.S/ L.R. khatian Nos. prepared under the W.B.L.R. Act, 1955. Thereafter we produce the purchase deeds to B.L. & L.R.O Salboni and pray for correction of record of rights in our names. The Ld. BL & L.R.O. Salboni after hearing and verifying the said plot Nos and deeds and other records has mutated/recorded our names in the present settlement operation. Therefore we are the legal owner of the said land stated in our R.T.I. application with regard to the schedule of land. But suddenly it appear to us that most illegally and without adhering due process of law, our Land has been vested to the state for which we are suffering unprejudiced.

Thereafter we filed an R.T.I. application on 27.02.2024 before the Learned S.P.I.O. & B.L. & L.R.O Salboni where he denied to



give any information on the ground of vested land and private individuals.

We are not any private individual and as per R.T.I. Act, we have every right to get proper information as sought for our said R.T.I. application made on 27.02.2024 before the S.P.I.O. of the B.L. & L.R.O Salboni, the authority concerned and therefore order No.4748-LP/SM-41/23 (P-11), dated 23.11.2023 of Deputy Secretary, Government of West Bengal is not applicable in the fact and circumstances of our case.

Therefore, we prefer an appeal U/S-19(1) of the R.T.I Act. before A.D.M. (L.R.) Paschim Medinipur and the Learned A.D.M. (L.R.) heard the matter but passed no order till to day after expiry of 30 days.

Being aggrieved this, the Appellants prefer this appeal U/S-19(3) of the R.T.I. Act, 2005.

The particulars are given below.

1. Name of the Applicant – (1) Smt. Mahuya Ghosh wife of Sri Samit Ghosh (2) Samit Ghosh, Son of Late Nalini Kanta Ghosh.

 - 1) Under which provisions the land is vested to the state ?
 - 2) Under which proceedings the land is vested to the state, either under the W.B.E.A Act, 1953 or under the provisions of the W.B.L.R., Act, 1955 ?
 - 3) The name of the Raiyat/Raiyats exceeding whose ceiling limit in the proceeding, if any ?
 - 4) Supply the retained land schedule and vested land schedule, if any after disposal of the vesting proceeding.
 - 5) As to whether the land is recorded under the khation No.1 belonged to the Government of West Bengal, Particulars to be given above the vesting proceedings ?

- 6) If the land is vested since long ago, then how the name of vendor namely Bhusan Ghorai was recorded for long years, as Raiyat ?
- 7) If the land is vested land, then how and why the then B.L. & L.R.O. Saboni allowed the purchase deed of the appellants and after hearing and after proper enquiring the names of the Appellants were recorded in the present settlement operation?
- 8) Whether such type of recording as Raiyat and thereafter suddenly declared as vesting is motivated purported arbitrary and illegal or not ?
- 9) Whether the disputed land should be corrected record of rights again in the names of the Appellants, if the land is vested erroneously ?
6. have you received any response /information ? If, so, attached a self attested copy of the same:-

The S.P.I.O, & B.L.& L.R.O. Salboni, response as vested land but the Learned 1st Appeal Authority had ^{- no -} ~~not~~ response after long days.

10. Grounds for 2nd Appeal and the relief sought (Specify) :-

GROUND

- I) For that the Appellants purchased the said disputed plots of land after searching everything from the concerned B.L. & L.R.O. Salboni.
- II) For that before purchasing the said plots of Land, why the same was not declared as vested to the state.
- III) For that, if the suit land is vested land then how and which procedure, the names of the Appellants were recorded/

mutated in the present settlement operation by the B.L. & L.R.O. concerned.

- IV) For that it may be any erroneous vesting.
- V) For that the vendor of the land had been cultivating the said land since 52 years continuously and this names were recorded as "Rayat".
- VI) For that the Appellants made R.T.I. Application before the le S.P.I.O. & B.L. & L.R.O. and being aggrieved by his order 1st Appeal was made before the Learned A.D.M. (L.R.), Paschim Medinipur, where he is silent till to day.
- VII) For that the Appellants purchased the disputed plots of land and this names are also been recorded after hearing everything in details and after observing the valid deed of purchase.

In the circumstances, stated above the Appellants believe that it must be erroneous vesting , therefore pray for correction of the same as soon as possible after cancelling the said impugned vesting order.

- Or* 11. This 2nd Appeal is filed within ¹¹⁹~~90~~ days. because both the Appellants were seriously ill for long days and therefore pray for condonation of delay of one month due to illness ground.
