1 16.05.2024	<p>Whereas it appears from the appeal petition dated 22.04.2024 submitted at this end on 29.04.2024 that one Mohua Parui, a resident of the 18, Amrit Lal Munsai Lane, Uttar Para-Hooghly filed the instant petition - which has been numbered as 43 of 2024 - on being aggrieved by the event of not-supplying the information as sought in her RTI petition dated 11.03.2024 by the SPIO & Dy. DL&LRO despite received the petition on 12.03.2024. Whereas it also appears from the office records that the said RTI petition was transferred to the end of BL&LRO, Burdwan-I as it appears that the matter is related to his jurisdiction vide this office Memo No. 354(95)/399/E/24 dated 12.04.2024 with a copy to Mohua Parui being the petitioner.</p> <p>D/A is asked to issue notice fixing the date of hearing at 12.00 noon on 31.05.2024 at the chamber of the undersigned.</p> <div style="text-align: right;">  Appellate Authority u/s 19 (1) of R.T.I Act 2005 & Additional District Magistrate and District Land & Land Reforms Officer Purba Bardhaman </div>	
2 31.05.2024	<p>The Case is taken up for hearing today.</p> <p>The appellant is present.</p> <p>None from the o/o the SPIO & BL&LRO, Burdwan-I is present.</p> <p>The Appellant's case in brief is that on being aggrieved by the event of not-supplying the information as sought in her RTI petition dated 11.03.2024 by the SPIO & Dy. DL&LRO, the appellant filed the instant appeal.</p> <p>Now, on verification of the office records, it appears that the said RTI petition was transferred to the end of BL&LRO, Burdwan-I as the matter is related to his jurisdiction vide this office Memo No. 354(95)/399/E/24 dated 12.04.2024 with a copy to Mohua Parui being the petitioner.</p> <p>But, the appellant submitted that she was not still provided the information as sought for and was not aware of the transfer of the RTI application to the end of BL&LRO, Burdwan-I. Regarding unawareness of the transfer of the application, it is stated that the copy of the Memo No. 354(95)/399/E/24 dated 12.04.2024 addressed to the Mahua Parui was sent through India Post.</p> <p>At the same time, it is felt that the SPIO & the BL&LRO did not respond/reply the original RTI application dated 11.03.2024 transferred to his end vide Memo No. 354(95)/399/E/24 dated 12.04.2024.</p> <p>Under the facts and circumstances, it is held that the instant appeal is allowed and it is ordered that the SPIO & the BL&LRO, Burdwan-I is directed to respond/inform the appellant with regard to his RTI application dated 11.03.2024 within 2 (two) weeks from the date of communication of today's order.</p> <p>Thus, the instant appeal is disposed of.</p> <div style="text-align: right;">  Appellate Authority u/s 19 (1) of R.T.I Act 2005 & Additional District Magistrate and District Land & Land Reforms Officer </div>
