



it. It is seen that she has been adequately replied.

7. On query, SPIO replied that the result of the Recovery Agent Exam Interview was not

published in the public domain. Sh. Shakil Ahmed, Managing Director, Minorities

Development and Finance Corporation is recommended under section 25 RTI Act to

publish on WBMDFC Website the result of a public recruitment exam. It should have

names of the successful candidates and the cut off marks in each category. The case is

closed.
