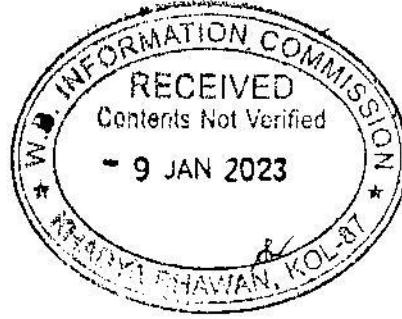

Kindly Provide Me The Detail Under, RTI Act 2005.

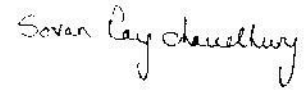
