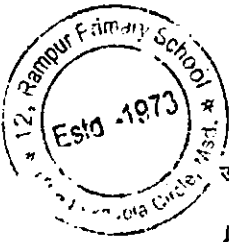
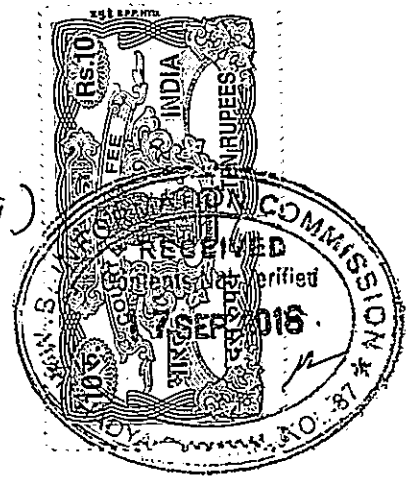

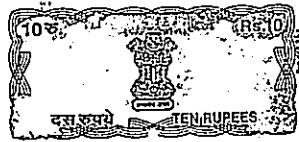

Hence, you are requested to dispose my request by way of providing informations as per Sec. 7 of Right to Information Act, 2005.

Informations Required.

That I made allegations against the Sub-Inspector of Schools, Bhagwangola Circle, at & P.O. Bhagwangola, Dist. Murshidabad, PIN-742 135, namely Sri Jayanta Haldar s/o Haridas Haldar of village & P.O. Debipur P.S. Jiaganj Dist. Murshidabad, PIN-742 113 against his all illegal acts in regard to putting "Ashok Emblem" in 5 consecutive letters to me, false statements in angering of My RTI Application dt. 2.1.2017, two days pay cut of mine for 28.11.17 & 29.11.17 in name of general Strike though I presented myself in School for those days and the last day was my 'onduty day' for my Asst. Teacher's retirement as because 30.11. 17 was Alocal Holiday namely 'Akheri Chahar Sumba'. So question of pay cut does not arise at all. You have received my all allegations-letters vide dt. 2.3.2017 on 3.3.2017, dt. 9.3.2017 on 10.3.2017 and lastly RTI Application dt. 27.4.2017 through S.D.O., Sadar, Berhampore on a week latter you have called a Hearing on 21.6.2017 at 1 p.m. and I was there that time in your 'august house' and you directly request me not to proceed in matter of "Ashok Emblem" used by said SIS, Bhagwangola - 1 Circle, my two days cut pay will be given after a few day. Hon'ble S i r , 3 months were gone, SIS gets promotion as AIS in Hoogly District and I have got nothing. So I am taking the opportunity of RTI Application requiring following informations such as :

- 1) Supply me the certified informations what is the consequence of said Hearing dt. 21.6.2017 was
- 2) What action/taken against said SIS, Bhagwangola Circle namely Sri Jayanta Haldar in regard to his "Ashok Emblem" putting in 5 letters to me illegally, by you?
- 3) What action is/was taken by you against said SIS for his false answer against my RTI Application dt. 2.1.2017 in regard to number of day of pay cut in name of general strike dt. 28.11.2016?
- 4) Supply me the correct informations whether the said Sub-Inspector of Schools, Bhagwangola Circle namely Sri Jayanta Haldar has/had taken proper steps sothat I can get said two days pay for dates 28.11.2016 & 29.11.2016 with interest? or have I got said 2 days pay in the mean time ?

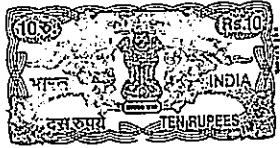

I seek following informations as per Sec. 6 of Right to Information Act, 2005.

Hence, you are requested to dispose my request by way of providing informations as per Sec. 7 of Right to Information Act, 2005.

Informations Required.

a) That your erstwhile Sub-Inspector of Schools, Bhagwangola Circle, P.O. & P.S. Bhagwangola Dist. Murshidabad, W.B., PIN - 742 135 (home address s/o Haridas Haldar at & P.O. Debipur P.S. Jaganj Dist. Murshidabad, W.B., P I N = 742 113) now A.I. of Schools cut my 2 days pay illegally in name of General Strike dt. 28.11.2016 though I presented myself in School 28.11.2016 to 29.11.2016 and I made allegations on 2.3.2017 & 9.3.2017 and you have got the on 3.3.2017 & 14.3.2017 respectively. He illegally created two false Medical Certificates without Doctors' Registration number one by Letter Head " London Mission Hospital " and there he showed that my Muslim Teacher namely Sadrul Islam was admitted in said Hospital on 29.11.2016 to 30.11.2016 and later he supplied me a xerox copy of Medical Certificate as if given by Dr. B. Mitra dt. 1.12.2016 in name of said my Asst. Teacher namely Sadrul Islam as he was under treatment by this Doctor on 29.11.2016 & 30.11.2016 (and 1.12.2016 he was fit for work). That Sub-Inspector of Schools cut my Income Taxes this year disregarding my protest and better particlers in secret manner. He cut my pays in name of said strike in secret manner so my Service Book may be created bad. In my RTI Application he gave false answer on behalf of Govt. of W.B., he said that he cut only my one day pay in name of Bandh. He did cut my 2 days pay in name of "Bandh" but when the questions are coming to return back my two days pay with interest accrued there upon in highest interest, he says that it will be possible when DIS(PE), MSD will order him to do so. He sent me 5 separated letters with "Ashok Emblem" in letter heads illegally (supro : Judgement dt. 14.7.2011 by Hon'ble Calcutta High Court, vide Kamal Day -vs- Union of India (Prohibition of Improper Use) Act, 2007 and State Emblem India, 2007 Act & Rules. He will be punished by Jail & fine both in using Ashok Stambha & false answer purposely in RTI Application. He could not make fear & awe in my mind by using Ashok Stambha & false answering to show his artificial power.

b) That on 13.12.17, in name of Sub-Inspector of Schools, Bhagwangola Circle one unknown male face went to my school i.e. 12, Rampur Primary School, at & P.O. Rampur P.S. Bhagwangola Dist.
