



Being aggrieved by the reply of SPIO, I am filing the first appeal which is as follows:-

**FACT:**

I filed an application under the RTI Act 2005 before the SPIO, Purulia District Police, seeking footage of all the CCTV cameras of Neturia Police Station but the SPIO denied to provide the desired information by rejecting my application under Section 8 of the RTI Act 2005.

**Ground of Appeal**

On 11-10-23 my son and his friends were arrested by Neturia Police Station, during the arrest human rights and child rights guidelines were violated by the police personnel. Since the matter involves violation of human and child rights as well as life and liberty of individuals, the desired information should be provided. I am quoting here the decision of the Central Information Commission in the case of Shri Jasprit Singh
