





12. 2nd Appeal is being filed after more than 119 days after the filing of 1st Appeal as: The appellant had filed 1st appeal on 12.09.2023 which was received on 14.09.2023. For lack of actual truth of investigation the Midnapore Medical College and Hospital authority is changing the SPIO several times to deliberate and delay in replying of the RTI information. This has compelled the appellant to knock the doors of the esteemed SIC. It is therefore humbly requested to consider this request and direct the authorities to supply the requested information. The appellant wishes the Hon'ble West Bengal Information Commission would take the matter sympathetically and accept the applicant's fervent request. Under your cordial co-operation and early action can save Govt. Money against the corrupt Assistant Superintendent who was absent from 01.04.2022 to 31.05.2023 but draw her salary without performing her duties at Midnapore medical college and hospital and also she signed the attendance register later. The authorities of Midnapore Medical College and Hospital trying to save her.
