

With due respect I Sri Subhasish Dutta, permanent resident of Chowdhurypara, Kundu Bari Lane, P.O - Krishnanagar, P.S- Kotwali, Dist. - Nadia, Pin-741101, State-West Bengal and also a citizen of India like to draw your kind attention that I sought some query under R.T.I act 2005 u/s 6(1) from S.P.I.O and District Inspector of School (primary) vide my letter ref No.SD/RTI/JULY2/2023 Dated 21<sup>st</sup> July 2023, and after more than 60 days without having any reply I made an appeal u/s 19(1) of R.T.I act to the 1<sup>st</sup> Appellate Authority (Ref No. SD/RTI/SEP/2-2023, Dated-27<sup>th</sup> September 2023) and Commissioner of School Education on 27<sup>th</sup> September 2023. The Honourable Appellate Authority transferred my R.T.I to Appellate authority and District inspector of Schools (PE), Nadia, Siksha Bhawan, College Street, P.O.- Krishnagar, Nadia, 741101 (Memo. No. 163-SC/AIS/RTI/AIS/RTI/Appellate/1/2023(Pt-I), Dated -13/10/2023. The Appellate Authority and District inspector of Schools (PE), Nadia Transferred my said R.T.I again to The SPIO, Nadia District Primary School Council, Office at Bana Parichay Bhaban, College Street P.O.- Krishnagar, Dist.-Nadia, 741101. At last as per instruction of 1<sup>st</sup> Appellate Authority, The SPIO, Nadia District Primary School Council replied my queries raised to the 1<sup>st</sup> appellate Authority in my letter dated 27<sup>th</sup> September 2023.
