

In reply to the appeal dated 25.09.2023 ( filed on 29.09.2023 ) by Sri Sahin Reza before the First Appellate Authority u/s 19(1) of the RTI Act , 2005, this is to inform him that as per guideline No. 9 issued by the Department of Personnel & Training , Government of India vide OM No. 1/3/2008-IR dated 25.04.2008 on the RTI Act , 2005 ( may be searched from Google ), only such information is required to be supplied under the Act which already exists and is held by the public authority or held under the control of the public authority. It is beyond the scope of the Act to create information ; or to interpret information; or to solve the problems raised by the applicants ; or to furnish replies to hypothetical questions.

The applicant has made an RTI application dated 27.07.2023 under the RTI Act , 2005 submitted by the applicant before the SPIO & D.R. , Murshidabad. The applicant has stated in his appeal that he has not received any reply from the concerned SPIO & D.R. , Murshidabad and being aggrieved the applicant has made his appeal before the First Appellate Authority .

The SPIO & D.R. , Murshidabad is directed to follow the provisions of the RTI Act , 2005 meticulously and take necessary action as per provisions of the RTI Act , 2005 only and to help the applicant for getting the accessible information immediately if the applicant approaches his office on previous payment of requisite government fees through proper procedure for the purpose.

With the above direction , the appeal stands disposed of.
