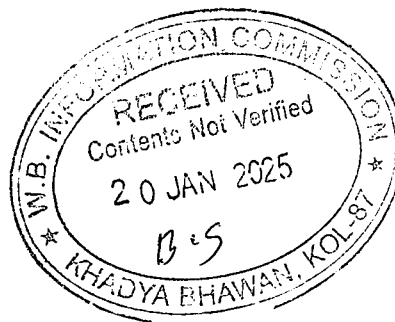

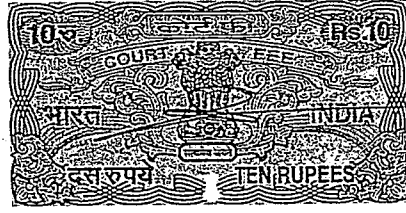



Hence, the appeal petition is hereby disposed off.



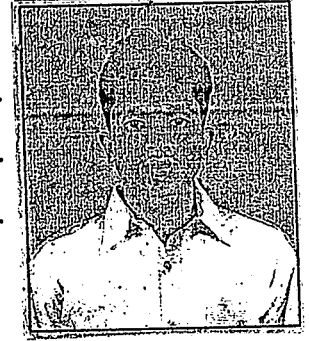

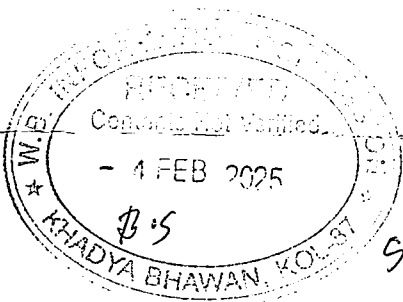
