6. Decision with reason:	<p>1) The reply of PIO appears in line with the RTI Act. The said reply letter is attached for his ready reference. He is advised to act in accordance with the reply of PIO, WBPDCCL.</p> <p>2) Though queries of the appellant are related to 3rd party information and on perusal of the same, it does not seem that larger public interest warrants the disclosure of such information.</p>

WRITTEN SUBMISSION ON BEHALF OF THE APPELLANT

INTRODUCTION

1. The present written submission is being filed in support of the above appeal under Section 19(3) of the Right to Information Act, 2005.
2. The Appellant seeks the Hon'ble Commission's intervention due to illegal, incomplete, evasive, and non-speaking replies furnished by the CPIO in response to a lawful RTI application.
3. The impugned reply defeats the very object of the RTI Act, which is to promote transparency, accountability, and informed citizenry.

Brief Background

1. The Appellant filed an application under **Section 6(1)** of the Right to Information Act, 2005 seeking specific information relating to *records/documents/actions* maintained by the Public Authority.
2. The information sought was **clear, specific, and record-based**, requiring no creation of new information or interpretation. As per submitted RTI dated 30/07/2023, From tender ID :- 1) **2015_WBPDC_60677_1 & NIT No- WBPDC/STPS/NIT/E1020/15-16,** Name of Work :- "Annual Service contract for the job for BOBR Unloading job at CHP , STPS for unit # 5 and unit #6 under CHP(Oprn.) dept, Santaldih T.P.S ."
2) **2016_WBPDC_66121_1 & NIT No- WBPDC/STPS/NIT /E1045/15-16.** Job Name-" Annual

Mechanical Maintenance contract of Coal Handling Plant of Unit #5 & 6 , under CHP(M/M) dept, Santaldih T.P.,WBPDCCL.”

3. Qualified requirement of McNally Bharat Engineering Company Limited is correct one & existing contractor for both jobs, But, Asoke Sahababu was one of the sub contractor of the same job & same place & same work order & he was also participated in the newly published NIT procedure being Number mentioned above 1 &2, where No any condition mentioned in the NIT that sub contractor can be participated in this tendering procedure, suddenly **Asoke Sahababu** participated in the tendering procedure and considered as Technically qualified & selected as L1 bidder & continuing the job from 2015 to 2026 with unlawful QR documents where original QR holder participated in the same tender procedure, surprisingly both of parties considered as technically qualified with a same main work order issued from the WBPDCCL. Here, a line of questions are raised in such a way that,

A. How did a Agency namely **Asoke Sahababu** got this work order as Sub contractor despite of there was no such provision of sub contract in said NIT being Nos- WBPDCCL/STPS/NIT/E1020/15-16 and WBPDCCL/STPS/NIT/E1045/15-16.

B. How did **Asoke Sahababu** technically qualified in this NIT when both of the bidders had submitted the same work order as QR documents respectively.

4. The CPIO furnished a reply which is:

- incomplete,
- evasive,

- and contrary to the mandate of the RTI Act.
5. Aggrieved by the said reply, the Appellant prefers this written submission highlighting **statutory violations, settled legal principles, and mala fide denial of information.**
-

2. Nature of Information Sought

1. The RTI application sought **existing records, documents, and official information** as defined under **Section 2(f)** of the RTI Act.
 2. None of the queries required:
 - opinions,
 - justifications,
 - or explanation beyond what is already on record.
 3. Hence, the information squarely falls within the scope of disclosure.
-

3. Deficiencies in the CPIO's Reply

The reply of the CPIO suffers from the following serious legal infirmities:

(a) Non-application of mind

- The reply is generic and mechanical.
- There is no point-wise response to the queries raised.
- Such replies defeat the very purpose of transparency envisaged under the RTI Act.

(b) Deemed refusal under Section 7(1)

- Providing incomplete or misleading information amounts to **deemed refusal**.
- The Hon'ble CIC has repeatedly held that *partial disclosure without justification is equivalent to denial*.

(c) **Failure to invoke valid exemptions**

- No specific exemption under **Section 8** or **Section 9** has been cited.
- A bald denial without quoting statutory provisions is illegal and unsustainable.

(d) **Violation of Section 7(9) (misuse)**

- If the Public Authority claims inconvenience or burden, it must justify the same.
 - Mere administrative difficulty is **not a ground for denial**.
-

4. Legal Position (Settled Law)

1. **Section 2(f)** – Information includes records, documents, files, notes, emails, and data held by or under the control of a public authority.
2. **Section 4(1)(a)** – Public Authorities are duty-bound to maintain records properly and facilitate access.
3. **Section 7(1)** – Time-bound, reasoned, and complete response is mandatory.
4. **Burden of Proof (Section 19(5))** – Lies on the Public Authority to justify denial.
5. **Maxim:** *“Disclosure is the rule, secrecy is the exception.”*

Numerous CIC decisions have held that:

- Information cannot be denied due to poor record management.
 - RTI applicants are entitled to **certified copies of records**.
 - CPIOs cannot shift responsibility or give evasive replies.
-

5. Mala Fide and Administrative Lapses

1. The conduct of the CPIO shows **lack of diligence and statutory compliance**.

2. Such replies frustrate the citizen's fundamental right to information under **Article 19(1)(a) of the Constitution of India**.
 3. Repeated non-compliance undermines public accountability.
-

6. Reliefs Sought

In view of the above, the Appellant respectfully prays that the Hon'ble Commission may be pleased to:

1. **Direct the CPIO** to provide complete, point-wise, and certified information as sought in the RTI application.
 2. **Invoke Section 19(8)(a)** to ensure compliance with the Act.
 3. **Consider penalty proceedings under Section 20(1)** for denial without reasonable cause.
 4. **Recommend disciplinary action under Section 20(2)** if deemed fit.
 5. Grant any other relief deemed just and proper in the interest of transparency and justice.
-

7. Conclusion

The present case is a classic example of how RTI requests are diluted through evasive replies. Unless corrected, such practices erode the spirit of the RTI Act. The Appellant therefore seeks the Hon'ble Commission's intervention to uphold transparency and rule of law.
