





The show cause notice of the SPIO is returnable within 4 (four) weeks from the date of issue of this order otherwise penal action on the SPIO will be imposed as per provision of the RTI Act, 2005.

3. The appellant filed an RTI application on 03.10.2023 before the SPIO seeking two points of information regarding marks obtained by him in the recruitment for the post of Tuberculosis Health Visitor – 2022 as well as the detail marks of selected – 1 & Waiting - 2 candidates. Not getting any reply, the appellant filed 1st appeal before the 1st Appellate Authority on 28.11.2023 and then filed 2nd appeal before the Commission on 05.02.2024.

4. On perusal of the case record it appears that as yet no reply from the SPIO of the case has been furnished to the appellant. The appellant wanted to know his own marks obtained by him in the said examination and he also wanted to know the marks of selected – 1 & Waiting - 2 candidates As per RTI provisions, the appellant can get information regarding his own marks but the information relating to marks of selected – 1 & Waiting - 2 candidates cannot be provided under Section 8(1)(j) of the RTI Act, 2005 as it is personal information of 3rd party. 


