 - ii) Does the Governor of West Bengal enjoy the authority for the appointment of the Board of Directors, Chairman and Vice Chairman of the Board of WBTDC as per MOA & AOA of the aforesaid company or does he just appoint the Chairman, Vice Chairman and Directors as per the advice of the State Government?
 - iii) Does the post of Principal Secretary, Department of Tourism Government of West Bengal is "Director" of WBTDC by default without the sanction or approval or appointment by the Hon'ble Governor of West Bengal ?


- iv) If the present incumbent Ms. Nandini Chakraborty, Principal Secretary, Department of Tourism Government of West Bengal was appointed "Director" of WBTDc by Hon'ble Governor of West Bengal then please provide particulars of such appointment.
- v) Does the Principal Secretary, Department of Tourism, Government of West Bengal is empowered to control the affairs of the above said company undermining the position of the Managing Director of WBTDc and Board of Directors, who are supposedly appointed by the Governor of West Bengal as per MOA & AOA of the aforesaid company?
- vi) Do the affairs of the company WBTDc are managed as per MOA & AOA of the company WBTDc or according to the wishes and/or directions of the Principal Secretary, Department of Tourism, Government of West Bengal under any other special Act/Legislation/special Powers accorded by the Governor of West Bengal or any other authority?
- vii) If answers of the queries (5 & 6) above are 'yes' then please provide the details of such Act/Legislation or Special Powers accorded to the Principal Secretary superseding the Companies Act '2013.
- viii) As per the MOA & ASA of the company WC, the appointment of the Managing Director is for a Whole Time Director. How the Erstwhile Managing Directors were appointed by Governor of West Bengal holding the dual positions of Managing Director as well as the Director of Tourism in the Department of Tourism Government of West Bengal as per the Notifications issued from "Nabbana", under the administrative control of the Principal Secretary, Department of Tourism, Government of West Bengal, which is in direct contravention to Companies Act'2013 and also MOA & AOA of the company WBTDc?
- ix) As per MOA & AOA of the company WBTDc only the Governor of West Bengal is empowered to appoint or remove the Director/Managing Director of WBTDc. What was the direct or indirect role of Governor of West Bengal in the removal of the erstwhile Managing Director Sri R. N Basu Roychoudhury of WBTDc?
- x) Can, Principal Secretary, Department of Tourism charge, who was just one of the Directors on the Board of WBTDc, issue Show Cause Notice to the Erstwhile Managing Director of WBTDc for insubordination and for the decisions taken by him

as Managing Director of WBTDC, who was acting and in his post with the appointment by the Hon'ble Governor of West Bengal and the powers delegated to him by the Board of Directors of WBTDC as per MOA & AOA of the company attached herewith?

2. Ground for second appeal was non-response of the SPIO and relief sought is to provide the information.
3. i) The SPIO & Dy. Secy., Governor's Secretariat, WB submitted an action taken report vide memo. no. 51-SP/RTI-54/23 dated 21.01.2026 that the RTI application has been transferred to the Department of Tourism, W.B. as the matter appears to be closely related to this office - vide memo. 50-SP/RTI-54/23 dated 21.01.2026.

Deliberation and Decision

4. The appellant was absent despite the option of virtual hearing. He has neither sent any information nor any representative. The SPIO, Tourism Department, Government of West Bengal was also absent. Shri Suman Paul, Dy. Secretary, O/o the Governor's Secretariat, Lok Bhawan was present virtually.
5. It is seen that the SPIO, Tourism Department, Government of West Bengal was contacted over phone by the Registry, WBIC to remind her about today's hearing. But the SPIO, Tourism Department is absent today.
6. The next date-of-hearing is fixed on 09-3-2026 at 1130 hrs. The SPIO, Tourism Department is directed to reply.
