The Subsequent order for release of the food materials (SNP & SABLA), utensils, medicine kits or any other materials which are related to ICDS is issued to him. He will not receive or issue any food materials or other articles and store in the godown earmarked for the Chakdaha ICDS Project without the written order of the CDPO, Chakdaha ICDS Project failing which he will be penalized for the noncompliance of the deed of agreement.

2. The Agent will have to maintain a stock register whose format will be approved by the CDPO, Chakdaha ICDS Project, Nadia. The Stock book balance and physical balance of the food materials (SNP & SABLA) and other articles will have to be verified by the agent regularly, and the same is to be inspected by the CDPO, Chakdaha ICDS Project, Nadia or his/her representatives. The Agent will have to give a monthly statement showing the monthly receipt and issue of food material and opening balance and closing balance of individual food article.

3. The Agent will issue the food articles & other articles to the authorized person or agency as will be authorized by the CDPO, Chakdaha ICDS Project, Nadia. He /She will not refuse any authorized person for issuing food materials on plea of weather condition, odd hours of the day, holiday etc. Similarly, he/she will not be allowed to \_ refuse to receive the consignment. However, he/she will have to verify the sample of the food articles which will -be given to him/her by the CDPO, Chakdaha ICDS Project, Nadia. Food items will be necessarily received in presence of C.D.P.O, Chakdaha or his representative.

4. As the food materials stored will be used for consumption by children below 6 years of age, he/she should keep vigilance so that any poison, chemical or insecticides etc. are get mixed with the food materials. He/She will be held responsible for any adulteration, pilferage, theft or any kind of loss/damages occurred at the godown. He/She will have to compensate the amount lost or damaged in this way otherwise the same will be recovered from his out-standing bills or security money.

6. The rate duly approved for this 'STORING CUM CARRYING AGENT' by the District Level Tender Committee of the Department of Women & Child Development and Social Welfare, Govt. of West Bengal is as follows :-

7. He/ She will not be allowed to claim any additional amount or revision of rate on the plea of hike in market price or any such kind of reason.

8. The Agent will not be allowed to keep any other materials other than the materials authorized by the CDPO, Chakdaha ICDS Project within the godown.

9. The Agent will be agreement bound to reconstitute the bags and packets of food grain if it is found damaged, torn or leaking in whatsoever form due to handling and storing/carrying of the same and for the same he/she will not be allowed to claim any charges or fees or money whatsoever it is necessary for the same.

10. The Agent will be agreement bound to obey the terms and conditions as was agreed upon at the time of submission of tender vide No. 50/ICD/Chak/dt -31-01-2018

11. The Agent will be responsible for transportation of food materials from Project Godown to the different Anganwadi Centres situated at different locations of different gram Panchayets and Municipality of Chakdaha Block as per order of the CDPO, Chakdaha ICDS Project, Nadia.

12. Allocation of food materials and other ICDS articles for each anganwadi centre to be transported will be notified by the CDPO, Chakdaha ICDS Project, Nadia in the dispatch instruction and the contractor will strictly adhere to this instruction. He/She will in no case alter the centre or alter the amount of materials to the targeted centres as per his/her own will or interest for which he/she may be penalized.

13. The Contractor will be duty bound to carryout the full amount of food materials as mentioned in the dispatch instruction as will be issued by the CDPO, Chakdaha ICDS Project, Nadia from time to time within 10 (Ten) days from the receipt of the instruction, irrespective of the weather condition or other local problem. In case of failure to comply the instruction within stipulated time Government will be at liberty to make alternative arrangement (subject to the approval of the chairman, PLTC) by other agency to carry the food materials to the anganwadi centres at the rate to be decided by the government and in that case if any excess expenditure is required to made by the government that amount should be deducted from the contractor either from his/her outstanding bills or from the security money deposited by him/her.

14. The Agent will be agreement bound to dispatch full amount of food articles and other ICDS articles to the anganwadi centre as will be mentioned in the dispatch instruction and lifted from Project Godown. No transit loss or any other kind of loss due to theft, pilferage or any other unavoidable circumstances will be allowed to the agent. For this purpose the receipt statement of anganwadi worker will be final. The contractor will be agreement bound to submit a report to the CDPO, Chakdaha ICDS Project, Nadia on transportation of food materials supported by the challans duly signed by the anganwadi workers as receipt of materials within 15 (Fifteen) days from the receipt of dispatch instruction. Basing on these receipted challans his/her claim for transportation of food materials or other ICDS articles will be cleared and if any amount is found short the value .of the food materials and other ICDS articles short will be deducted from his/her outstanding bills or security money.

15. He/ She will not be allowed to receive the materials during night.

17. The Agent will be agreement bound to undertake the work of transportation throughout the agreement period at the rate as has been accepted in this deed of agreement. No prayer for consideration or modification of rate will be accepted within the agreement period. Among the A.W. Centres, C.D.P.O., Chakdaha, if required, may instruct the agent to supply the materials according to some preference considering the urgency of the centre's feeding position.

18. Delay in carrying out the order of the Office or violation of any clause stipulated in the contract Deed will be treated as a breach of contract and in such cases the authority reserves the "RIGHT" to terminate the contract within "SEVEN DAYS".

20. Bills of Storing Cum Carrying must be submitted to the C.D.P.O. Chakdaha, Nadia or his representative within 2(two) months of every delivery order.

21. The CDPO, Chakdaha ICDS Project, Nadia reserves the right to cancel the tender in whole or partially at any point of time without assigning any reason whatsoever.




