



For registering and filing the second appeal cum complaint under the Right to Information Act 2005, Shri Sarvodaya Kumar Saha {WBCS (Exe) Office of the District Magistrate, 1st floor, New Administrative Building, Barasat, North 24 – Parganas, West Bengal, Pin – 700124}, Mr. First Appellate Authority {Home & Hill Affairs Department (Election Branch), Annex Office Building of Balmer Lawrie & Co. Ltd (2nd & 3rd floor), 21 N S Road, Kolkata – 700001} and the concerned public servants are bound and compelled because –

1. To get the information, an information complaint was sent under the Right to Information Act 2005, a copy of which is attached, but the information has not been provided as per the R. T. I. Application, due to which the first appeal has been filed, however, the information has not been provided till date as per the information requested, i.e. The information received is zero, hence the complete information sought is desired.
2. The concerned public servants have been appointed and posted due to political and special acquaintance, hence they voluntarily carry out public work, irregularly and unconstitutionally, but even after registering and filing a complaint against such voluntary public work, the action is void because the concerned Share the benefits received by public servants with higher officials therefore, the action taken against the concerned public servant is void as he has proved incapable of providing the information as per the requested information.

Sir, to accept my second appeal under the Right to Information Act 2005, if possible, only after getting the entire grammar, script, sentence i.e. each point thoroughly checked and inspected by the personnel posted in the Central Information Commission, my second appeal will be accepted. Accept the appeal, otherwise send it back mentioning some error or the other as before, which I am bound to accept, otherwise ensure that you are not able to provide the requested information. Since such irregular and unconstitutional public work is being done under the patronage of high officials in return of which private institutions and companies are getting benefits in various ways and the said Commissions work in coordination with the officials of the Central Government departments, I am sure that Please try to execute my appeal only after informing.
