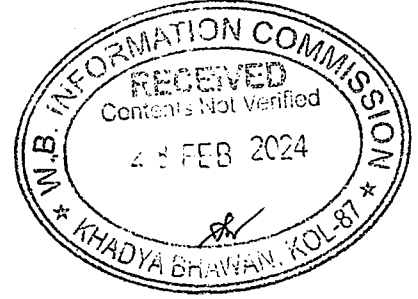

5. **Gist of the information sought for :**  
The appellant by an application under Section 6(i) of the Right to Information Act, 2005 sought for the following information :

"Please provide an electronic copy of CCTV footage of the front passage between the room of Officer-in-Charge and Duty Officer's room of Kalna Police Station for the time commencing from 4 p.m. of 7<sup>th</sup> October, 2023 till 1 a.m. of 8<sup>th</sup> October, 2023 which is urgently required for my defense in Kalna Police Station Case No. 1175 of 2023 dated 07-10-2023 under Sections 341 / 323 / 325 / 326 / 379 / 384 / 506 / 34 of IPC, in which I have been made an accused at the instance of the Officer-in-Charge namely Mr. Debasish Nag and Mr. Biswanath Das, Sub-Inspector of Police, Kalna Police Station."

First Appeal dated 16-12-2023 under Section 19(1) of the Right to Information Act, 2005 was served upon the Additional Superintendent of Police (Head Quarter) and 1<sup>st</sup> Appellate Authority under Section 19(1) of the Right to Information Act, 2005 through registered post on 16-12-2023 vide Consignment No. RW664754800IN and the same was served upon the addressee on 21-12-2023.

4. Authority to whom the first appeal was made and address :

The appeal was made to the Additional Superintendent of Police (Head Quarter) and 1<sup>st</sup> Appellate Authority, Purba Bardhaman, Burdwan Police Line, Sialdanga Stop, P.O. - Sripally, P.S. - Burdwan, Dist. - Purba Bardhaman, PIN - 713101.

Self attested copy of the aforesaid First Appeal under Section 19(1) of the Right to Information Act, 2005 along with all its annexure and proof of service is annexed herewith and collectively marked as Annexure - "B".

5. Decision of the 1<sup>st</sup> Appellate Authority, if any, including number and date of the order (A self attested photocopy of the order of the 1<sup>st</sup> Appellate Authority should be attached) :

The First Appellate Authority under Section 19(1) of the Right to Information Act, 2005 has issued Memo No. 7565/DEB/RTI dated 29-12-2023 thereby informed that reply has already been sent to the appellant vide his office Memo No. 7192/DEB/RTI dated 06-12-2023 and send a photo copy of said memo. Self attested photocopy of aforesaid Memo No. 7565/DEB/RTI dated 29-12-2023 is annexed herewith and marked as Annexure - "C".

6. Grounds for 2<sup>nd</sup> appeal and the relief sought for (specify) :

Being aggrieved by and dissatisfied with Memo No. 7565/DEB/RTI dated 29-12-2023 issued by the First Appellate Authority enclosing Memo No. 7192/DEB/RTI dated 06-12-2023 issued by the S.P.I.O. & Dy. S.P. (HQ), Purba Bardhaman, the appellant begs to move this instant Second Appeal on the following amongst other grounds :-

- I. For that there are errors apparent on the facts and circumstances of the case;
- II. For that the alleged ground of refusal to provide information that CCTV footage is not available at Kalna PS is not tenable in the eye of law, rather the alleged ground is not to disclose the illegal activities and malpractice of concerned Police Personnel of Kalna Police Station;
- III. For that the First Appellate Authority, by issuing Memo No. 7565/DEB/RTI dated 29-12-2023 in connection with First Appeal under Section 19(1) of the Right to Information Act, 2005 against non-supply of information under Section 6(i) of the Right to Information Act, 2005, has acted in contravention of the said act and the First Appellate Authority failed to appreciate that non-disclosure of such information tantamount to refusal of answer which is not tenable in law and fact;
- IV. For that both the replies furnished by the First Appellate Authority as well as the concerned State Public Information Officer are evasive in nature in supplying the information, as sought in the application under Section 6(i) of the Right to Information Act, 2005;
- V. For that both the First Appellate Authority as well as the concerned State Public Information Officer failed to appreciate that the information sought under query No. 1 of the application under Section 6(i) of the Right to Information Act, 2005 definitely pertain to the office of Kalna Police Station and alleged non-availability of such information is only for the purpose of safeguarding concerned police personnel of Kalna Police Station to carry on their arbitrary, illegal and mala-fide activities beyond the powers vested upon them by the statute and as such there is

no reasonable cause for not providing the information within the statutory time period;

- VI. For that the First Appellate Authority failed to appreciate that the alleged reply given by the State Public Information Officer was never served upon the appellant, as alleged and content of the same is baseless as disclosure of CCTV footage of the particular time and dates, as sought by the appellant in the application under RTI Act, was very much available, rather the impugned communications made by the SPIO as well as the First Appellate Authority is lacking transparency only for the purpose of not to bring concerned police personnel's illegal activities into the light;
- VII. For that both the First Appellate Authority as well as the concerned State Public Information Officer failed to appreciate that in point No. 1 of the original application under Section 6(i) of the Right to Information Act, 2005 the applicant i.e. the appellant herein has specifically requested to provide CCTV footage of Kalna Police Station for particular times and dates, for the period of which there is no such ground prohibited under Section 8 and / or 9 of the RTI Act and such information definitely pertains to the office of Kalna Police Station and by not providing such information both the SPIO as well as the First Appellate Authority have flouted the aim of legislature in enacting the provisions of Right to Information Act, 2005;
- VIII. For that both the First Appellate Authority as well as the concerned State Public Information Officer failed to appreciate that there is no such public interest

involved in the application under Section 6(i) of the Right to Information Act, so that the same cannot be supplied to the applicant / appellant, rather due to non-supply of such information larger public interest would be defeated at the instance of the concerned State Public Information Officer;

- IX. For that both the First Appellate Authority as well as the concerned State Public Information Officer failed to appreciate that supply of information, as sought in only point of the original application under Section 6(i) of the Right to Information Act, 2005, is not restricted under Sections 8 and / or Section 9 of said Act and non-disclosure of such information will seriously prejudice the appellant's fundamental right, as guaranteed under the Constitution of India;
- X. For that the replies of both the First Appellate Authority as well as concerned State Public Information Officer is evasive and without any cogent reason and from the said replies it appear that there is no transparency of public documents in the office of Kalna Police Station which vitiates the aim of the Right to Information Act, 2005;
- XI. For that the First Appellate Authority as well as the SPIO are otherwise bound to disclose the information as sought for under The Right to Information Act, 2005;
- XII. For that the refuge taken by the concerned State Public Information Officer as well as the First Appellate Authority under the guise of request for information is willful, deliberate and mala-fide refusal of supply of information and such action is not permissible under the Right to Information Act, 2005;

XIII. For that the information sought for, very much involve the applicant's interest and the State Public Information Officer as well as the First Appellate Authority cannot avoid disclosing such information only for the purpose of not to bring their abuse of power by illegal activities into the light;

XIV. For that the First Appellate Authority failed to appreciate that the impugned reply (never supplied by SPIO) of the concerned State Public Information Officer is otherwise harrasive in nature and liable to be set-aside to set the wrong right;

XV. For that actions of both the First Appellate Authority as well as the State Public Information Officer are otherwise bad in law and as such the same deserves to be set-aside;

XVI. For that until and unless this instant Second Appeal is allowed and the relief(s), sought for, are granted by this Hon'ble Commission, the appellant will suffer irreparable loss and injury;

**7. Relief(s) sought :**

Under the aforesaid facts and circumstances, the appellant most humbly prays for the following reliefs :

- a) An order setting aside impugned Memo No. 7565/DEB/RTI dated 29-12-2023 issued by the First Appellate Authority enclosing Memo No. 7192/DEB/RTI dated 06-12-2023 issued by the S.P.I.O. & Dy. S.P. (HQ), Purba Bardhaman;

- b) An order directing the Appellate Authority and / or the State Public Information Officer to provide an electronic copy of CCTV footage of the front passage between the room of Officer-in-Charge and Duty Officer's room of Kalna Police Station for the time commencing from 4 p.m. of 7<sup>th</sup> October, 2023 till 1 a.m. of 8<sup>th</sup> October, 2023 which is urgently required for the appellant's defense in Kalna Police Station Case No. 1175 of 2023 dated 07-10-2023 under Sections 341 / 323 / 325 / 326 / 379 / 384 / 506 / 34 of IPC, in which the appellant has been made an accused at the instance of the Officer-in-Charge namely Mr. Debasish Nag and Mr. Biswanath Das, Sub-Inspector of Police, Kalna Police Station, to the appellant immediately without any further delay;
- c) An order directing the State Public Information Officer and Deputy Superintendent of Police (Head Quarter), Purba Bardhaman to show cause as to why penalty in terms of Section 20 of the Right to Information Act, 2005 shall not be imposed upon him, because of non furnishing of information as sought by the appellant in application dated 03.11.2023 under Section 6(i) of the said Act;
- d) Any other or further order or orders as this Hon'ble Commission may deem fit and proper;
8. If 2<sup>nd</sup> Appeal is filed after 90 days from the date on which the decision of the 1<sup>st</sup> Appellate Authority was received or after 135 days from the date of filing of the 1<sup>st</sup> Appeal explain the reasons for the delay :
- This instant second appeal is filed within the statutory period as prescribed under Section 19(3) the Right to Information Act, 2005.

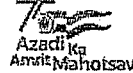
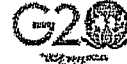

8. Grounds for such prayer or relief : I. For that the refusal to supply information by the State Public Information Officer is not tenable in law and fact;
- II. For that inaction of the SPIO in supplying the information is evasive in nature and as such the same is required to be interfered by the appellate authority;
- III. For that the information sought for under query No. 1 of the application definitely pertain to the office of the Officer-in-Charge, Kalna Police Station and the SPIO, by not supplying the information within the specified period, has flouted the provisions of the Right to Information Act, 2005;
- IV. For that by not supplying the information, the SPIO has proved his departmental biasness towards the concerned officers of Kalna Police Station who have misused their powers by over acting against the appellant and others and such inaction of the concerned SPIO is evasive in nature and without any proper reason;
- V. For that by not supplying the information the SPIO has refused to provide the information, as the same will reveal the actual truth to be brought into light;




