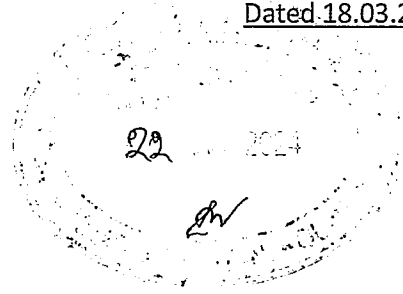

The SPIO & District Registrar, Murshidabad under his office Memo No. 168/DR(MSD), dated 05.02.2024 informed for question No. 15 & 16 stating inter alia that "no such copy cannot be provided as a matter of official privacy." This reply is incorrect, illegal, contrary to provisions and spirit of the RTI Act.

Thereafter, I submitted first appeal on 24.02.2024 before the Joint Inspector Genl. of Registration, W.B. who directed the SPIO to take necessary action for getting accessible information immediately, if the applicant approaches his office, on previous payment of requisite Government fees, vide Memo No. 649, dated 04.03.2024.

It is to be noted that the first appellate authority has not commented regarding incorrect or misleading reply of the SPIO. The First appellate authority tactfully directed the SPIO to take necessary action, on previous payment of requisite govt. fees. I know nothing that how many pages will supply and the pages are A4 size or legal size. So, it is not possible to pay the fees of information at the time of applications. I will must pay the fees of information on demand by the SPIO.



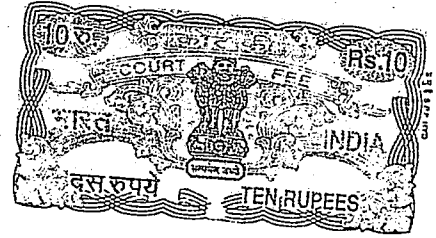



In reply to the appeal dated 24.02.2024 filed on 27.02.2024 by Sri Aish Mohammad before the First Appellate Authority u/s 19(1) of the RTI Act , 2005, this is to inform that as per guideline No. 9 issued by the Department of Personnel & Training, Government of India vide OM No. 1/3/2008-IR dated 25.04.2008 on the RTI Act, 2005 (may be searched from Google), only such information is required to be supplied under the Act which already exists and is held by the public authority or held under the control of the public authority. It is beyond the scope of the Act to create information; or to interpret information; or to solve the problems raised by the applicants; or to furnish replies to hypothetical questions..

In reply to the application dated 20.11.2023 under the RTI Act , 2005 submitted by the applicant before the SPIO, Law Department , W.B., the said SPIO has then transferred the said application to SPIO & D.R. , Murshidabad vide his Memo No. RTI-10-L/LW/O/RTI-84/2023 dt. 11.01.2024.

After that the SPIO & D.R. , Murshidabad has send his reply to the applicant under the RTI Act , 2005 vide his Memo No. 168/DR(MSD) Dated:. 05.02.2024.

But the applicant is not satisfied with the said information received from the said SPIO & D.R. , Murshidabad and being aggrieved , the applicant has made his appeal to the Jt. I.G.R., W.B. & First Appellate Authority.

However, the SPIO & D.R., Murshidabad is directed to take necessary action as per provisions of the RTI Act, 2005 only and to help the applicant for getting the accessible information immediately, if the applicant approaches his office, on previous payment of requisite government fees through proper procedure for the purpose.

With the above direction, the appeal stands disposed of.

However, if aggrieved, the party concerned may prefer second appeal before the State Chief Information Commissioner, West Bengal, Khadya Bhawan , 11A , Mirza Ghalib Street, Kolkata – 700087.

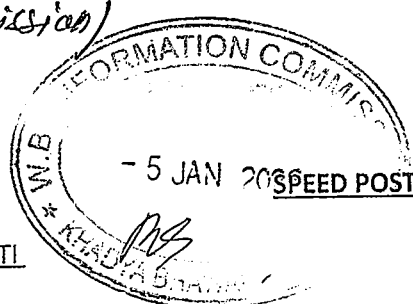
