


GROUND OF APPEAL

- I. For that the Respondents are in intentional wrong and in malafidy action for supplying the informations as sought for in the R.T.I. Application dated 30/12/2023 and in the First Appeal dated 15/02/2024.
- II. For that the Respondents with malafide intentions have knowingly avoided and neglected to supply the informations as sought for by the Appellant and failed to supply the information and explanation within the Statutory Limit under R.T.I. Act, 2005 and also denied to supply information with malafide, hypothetical, arbitrary attitude and as such the Appellant is entitled to pray for the penalty and damage against the Respondents and please pass such other Order / Orders as Your Sir, may deem fit and proper; as per the statutory Order / Orders of R.T.I. Act, 2005.

As such, Your Honour would be graciously pleased enough to pass Order / Orders (a) for the disclosure to supply the information with explanation as sought for by the Appellant at Free of Cost and Fees, (b) to please impose penalty and damages against the Respondents as per R.T.I. Act, 2005, as Your Sir, deem fit and proper.






I do like to draw your kind attention about L.R. Appeal No. 198 of 2021 and its order and the said file is retained with your office.

The matter is mere a succession case wherethere two daughters of Late Srinarayan Roy namely Smt. Ila Ghosh and Smt. Nandarani Hazra, both are since deceased, has been dishonestly deprived by the sons and grandsons of Late Srinarayan Roy after his sad demise in the year 1974.

An application vide Misc. Case No. 50/2011 was lodged before B.L. & L.R.O., Khanakul - II and the said case was disposed off and rejected on 05/11/2012. Here the said B.L. & L.R.O. denied to supply the said documents of rejection of the said case.

Thereafter, R.T.I. application was made before the learned D.L. & L.R.O., Hooghly. Smt. Ayesha Rani, I.A.S. on 07/02/2013. She ordered accordingly the the then B.L. & L.R.O. to supply the R.T.I. documents as sought for but the the then B.L. & L.R.O. did not pay any heed to the order of the said D.L. & L.R.O.. After that on 22/07/2021 the L.R. Appeal being No. 198 of 2021 U/S 54 of W.B.L.R. Act was lodged before the Hon'ble D.L. & L.R.O. Hon'ble Smt. Bandana Pokhriyal, I.A.S.. By this time, one Partha Sarathi Roy, the grandson of Late Srinarayan Roy has made an appeal before the D.L. & L.R.O., Hooghly on 16/08/2022 for the rectification of a part and/or portion of the said alleged property during the pendency of the said appeal being No. - O.A No. 1156 of 2022 (L.R.T.T.) and on the same alleged property which is in question.

Now, it is the perplex and hegemony to me how and by which way, a portion of the all alleged properties was rectified wherethere the whole alleged property's rectification was denied and rejected by the D.L. & L.R.O., Hooghly, Hon'ble Smt.





Thus the case disposed of.




