Sir,

In reply to my application seeking some information under the RTI Act-2005 to the SPIO, Office of the DI/S(SE), Purba Medinipur on 26/12/2023, an Assistant Inspector of schools (Secondary Education), Purba Medinipur informed me in his letter '....there is no access from DI Login to the said transfer application'.

It is just an attempt to suppress the real truth, to mislead by concealing information and to evade responsibility for the wrongdoing.

However, in government notification [no. 707/SE/S/1S-04/95(Pt), dtd. 8th Sept., 2021] related to transfer of teachers, it is mentioned -

'Rule 6. Procedure for submission and consideration of the application:

(3) District Inspector concerned upon receipt of application with the NOC from school, shall

(a) verify the service records and other information as furnished by the incumbents;

(b) take the views of the Chief Medical Officer of Health (CMOH) on transfer application related to medical grounds as reported by the doctor of the SMC;

(c) forward transfer application to Central commission along with his/her view'.

Therefore, in that case it is normal to keep the verification report in the office regarding required distance and medical report (nature of illness) for recommending transfer application of Mr. Radhamadhab Das (as the Headmaster from Bichunia J Vidyamandir to Kishorenagar Sachindra Siksha Sadan) to the WBCSSC. So is this not an excuse, just an attempt to confuse? By avoiding liability by not providing the information, the SPIO has been negligent in discharging his duty.

Therefore, you are requested to provide me with the information (as requested in my prayer to the SPIO) within the statutory period as per the RTI Act and Rules.



মহাশয়,

সসম্মানে জানাই - গত 26/12/2023 তারিখে SPIO, Office of the DI/S(SE), Purba Medinipur - মহোদয়ের কাছে RTI আইন-2005 -এর অধীনে কিছু তথ্য চেয়ে আদি আবেদন করেছিলাম। আবেদনের উত্তরে একজন সহকারী পরিদর্শক (স্কুল) (মাধ্যমিক শিক্ষা), পূর্ব মেদিনীপুর তাঁর চিঠিতে আমাকে জানিয়েছেন - '....ডিআই লগইন থেকে উল্লিখিত স্থানান্তর আবেদনের কোনো অ্যাক্সেস নেই'।

তাঁর এই উত্তরে সন্তুষ্ট না হয়ে First Appellate Authority হিসেবে আপনাকে আমি জানিয়েছি যে - এটি প্রকৃত সত্যকে চাপা দেওয়ার, তথ্য গোপন করে বিভ্রান্ত করার এবং অন্যায়ে দায় এড়ানোর চেষ্টা মাত্র। কারণ, সরকারি বিজ্ঞপ্তিতে [নং 707/SE/S/1S-04/95(Pt), তাং - 8ই সেপ্টেম্বর, 2021] শিক্ষকদের বদলি সংক্রান্ত বিষয়ে উল্লেখ করা হয়েছে -

'বিধি 6. আবেদন জমা দেওয়ার এবং বিবেচনা করার পদ্ধতি :

(3) স্কুল থেকে আপত্তি নেই সংক্রান্ত শংসাপত্র (NOC) সহ আবেদন প্রাপ্তির পর সংশ্লিষ্ট জেলা পরিদর্শক -

(ক) আবেদনকারীর সার্ভিস রেকর্ড এবং পাঠানো অন্যান্য তথ্য যাচাই করবেন;

(খ) স্কুল ম্যানেজিং কমিটির ডাক্তারের দ্বারা রিপোর্ট করা চিকিৎসার ভিত্তিতে বদলির আবেদনের বিষয়ে চিফ মেডিকেল অফিসার অফ হেলথের (সিএমওএইচ) মতামত নেবেন;

(গ) তার দৃষ্টিভঙ্গি সহ স্থানান্তরের আবেদন WBCSSC-এর কাছে ফরোয়ার্ড করবেন'।

তাই, সেক্ষেত্রে বিচুনিয়া জগন্নাথ বিদ্যামন্দির থেকে কিশোরনগর শচীন্দ্র শিক্ষাসদনে প্রধানশিক্ষক হিসেবে শ্রী রাধামাধব দাসের বদলির আবেদন WBCSSC-তে সুপারিশ করার ক্ষেত্রে দুটি স্কুলের মধ্যে প্রয়োজনীয় দূরত্ব এবং মেডিকেল রিপোর্ট (অসুখের প্রকৃতি) সংক্রান্ত যাচাইকরণ রিপোর্ট অফিসে রাখা অত্যন্ত স্বাভাবিক ও প্রয়োজনীয়। না রাখলে সে দায় আপনাদের, অপরাধ আপনাদের। আবার, রেখেও সযত্নে এড়িয়ে যাওয়াটাও অপরাধ।

সুতরাং SPIO-এর পক্ষ থেকে আমাকে যেটা জানানো হয়েছে, সেটা কি নিতান্তই অজুহাত নয়? শুধু বিভ্রান্ত করার চেষ্টা নয় কি? তাহলে কি তথ্য না দিয়ে দায় এড়িয়ে এস.পি.আই.ও. তাঁর দায়িত্ব পালনে অবহেলা করেন নি?

তাই, আর.টি.আই. আইন এবং নিয়ম অনুসারে বিধিবদ্ধ সময়ের মধ্যে আমাকে তথ্য (SPIO-র কাছে আমার প্রার্থনায় অনুরোধ করা হয়েছে) প্রদান করার জন্য আপনাকে গত 29/01/2024 তারিখে অনুরোধ করেছি। আজ শুনানিতে প্রাপ্ত সিদ্ধান্ত আমাকে জানানোর অনুরোধ জানাই, যা পরবর্তী ক্ষেত্রে প্রয়োজন।

আজ শুনানিতেও আমার বক্তব্য একই। বিবেচনা করবেন, পদ্ধতিমার্কিত তথ্য সরবরাহ করবেন দয়া করে।


