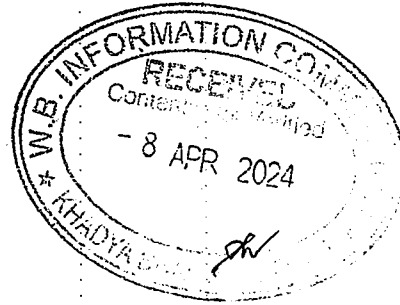

Brief facts of the case:

1. The Applicant had filed a RTI Application seeking information on the following grounds:

Please provide the following information under section 2(f) and 2(j) of the RTI act:

1) A certified copy of my Marriage Application cum Registration Form and the documents submitted to issue the attached Marriage certificate.

Marriage certificate Number- WB34200100010100002350-2020-23985 issued on 6th March, 2020.

2. As the reply from the PIO and the FAA is unsatisfactory, a second appeal should be preferred against the CPIO under Section 19(3) of Right to Information Act. The copy of the RTI application and first appeal have been annexed herewith as Annexure 1 and Annexure 2.

Grounds for Prayer or Relief:

1. As the reply from the PIO/FAA is unsatisfactory, a second appeal should be preferred against the CPIO under Section 19(3) of Right to Information Act. The copy of the RTI application and first appeal have been annexed herewith as Annexure 1 and Annexure 2.

2. The failure of the concerned public authorities to adequately and properly respond to the application is a violation of Section 5(3), 5(4) and 5(5) which mandates that the PIO is to make all efforts to ensure that the requested information is properly furnished to the applicant.

3. The failure of the authorities to give a proper response to the applicant amounts to refusal to respond to the application, is also a violation of Section 7(1)

8- of the RTI Act which obliges the PIO to provide access to information to a citizen unless furnishing of such information is covered by one of the exemptions provided under Section 8 or Section 9 of the RTI Act.

4. The PIO provided an incomplete and unsatisfactory reply. The PIO has provided a certified copy of Notice Number 2020-23985 dated 05/02/2020 and copies of other relevant documents available in the portal related to this marriage.

But the PIO has not provided the Marriage Application cum Registration Form which I have shown in the attached photo in the RTI application. Also, the documents (ID proof) provided by the PIO is not clear and the description of the documents is not provided.

5. The denial of information by the PIO is in violation of the provisions of the RTI Act, tantamounting to deemed refusal in terms of Section 7(1) of the RTI Act which makes the PIO liable for penal action under Section 20(1) of the RTI Act. The PIO has clearly failed to discharge its duties and obligations in the letter and spirit of the Act.

6. Under the RTI Act, 2005, a PIO is obliged to provide access to information to a citizen unless as stipulated by Section 7(1), furnishing of such information is covered by one of the exemptions provided under Section 8 or Section 9 of the RTI Act. The PIO has failed to discharge its duties and obligations by refusing to provide the information and failing to state the reasons for doing so under the law.

7. The response of the PIO even in respect of the inadequate information furnished is evasive and indicates a failure of RTI Act implementation. However, the incomplete response of the PIO highlights that the manner in which the said RTI application has been dealt with is not in consonance with the provisions and the purpose for which the RTI Act was enacted and fails the mandate of good governance.

8. Under Section 5(3) of the RTI Act, it is incumbent on every PIO to render reasonable assistance to all persons seeking information. To this end, the PIO has failed in his duties to assist the applicant in obtaining the information available with the Commission in whatever manner it is held. Under the RTI Act, 2005, a PIO is obliged to provide access to information to a citizen unless as stipulated by



Section 7(1), furnishing of such information is covered by one of the exemptions provided under Section 8 or Section 9 of the RTI Act. The PIO has failed to discharge its duties and obligations by refusing to provide the information and failing to state the reasons for doing so under the law.

9. The concerned public authorities have ignored the definition of information under Section 2(f) of RTI Act which clearly states that information includes any material in any form, including records, documents, memos, emails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data, material held in any electronic form by a public authority, including information relating to any private body which can be accessed by a public authority under any other law for the time being in force. The information requested for by the applicant clearly falls within the category of Section 2(f) as it forms part of the documents and records maintained by the public authority.

10. The information sought by the applicant in the RTI Application is very much a part of the information maintained by the concerned public authority falling under the definition of section 2(f) of the RTI Act and the PIO and FAA have no reasons whatsoever, of refusing to provide the information. In fact, the way in which the application has been dealt with highlights the negligent and apathetic manner and attitude.

11. In the present case, the First Appellate Authority ordered the PIO on 05/02/2024 to provide information to the applicant within 15 days the documents containing the original signatures of the parties to the Marriage.

12. To this the PIO replied that the PIO has inspected the flat of Mitali Sen, Ex N.O.M.O on 28/02/2024 in the presence of Police personnel. Smt Sen declared that on her retirement, she closed her office 4 years back, and kept not a single piece of paper in her custody since then.

13. The PIO has just replied that the Information is not available in this office. Merely replying that the information is not available will not absolve the PIO of its responsibility to ensure that the desired information forming part of public records ought to be provided to the applicant. If the PIO is not the concerned authority to reply to the RTI application, he/ she should have transferred the same to the appropriate PIO/ Public Authority within 5 days as prescribed under Section 6(3) of the RTI Act. By not doing so, the PIO has failed to discharge his/ her duties and obligations under the law.

14. Once the applicant makes an application, it is the duty of the concerned authority to make all efforts to facilitate the provision of information requested which includes transferring the application u/s 6(3) to the concerned department. The act of the PIO to respond that the information is not available with the department highlights the casual approach being adopted while dealing with the application.

15. It is evident from the conduct of the public authority that it has failed to perform its duties and obligations under the RTI Act and failed to provide a response to the RTI Application. The PIO as well as the FAA have failed to provide a reply to the applicant amounting to a no response from the authorities.

16. Various orders have been passed by the Hon'ble Central Information Commission to the effect that a no response from the PIO and the FAA calls for strict action against the concerned officer along with directions to be issued for the disclosure of the information sought at the earliest.

17. As the application of the applicant/appellant has not been handled properly and even the first appeal has not been disposed off accordingly, the concerned PIO is liable to face penal action. The applicant has suffered detriment, mental agony and harassment for not receiving timely and complete information and deserves to be compensated u/s 19(8)(b) of the RTI Act.

18. In the judgment of MINISTRY OF RAILWAYS vs. GIRISH MITTAL, W.P.(C) 6088/2014 & CM Nos.14799/2014, 14800/2014 & 14801/2014, the following has been laid down:

"Plainly, Section 18 of the Act enjoins the CIC to inter alia inquire into a complaint from any person who has been refused access to any information requested under the Act. In view of the unambiguous language of the provisions of the Act, the contention that CIC lacks the jurisdiction to impose a penalty on a complaint is ex facie without merit. The plain language of Section 20(1) of the Act indicates that it is not necessary that the penalty be imposed by the CIC only while considering an appeal; penalty can also be imposed by the CIC if on inquiry made pursuant to a complaint, it is found that a CPIO has not furnished the information in time or has knowingly given incorrect or incomplete information. Therefore, in my view, the jurisdiction exercised by CIC cannot be faulted."

The judgment lays down the provisions regarding imposing of penalties against

the PIO who err in their obligations and duties. Under Section 20 of the RTI Act, keeping in mind the lackadaisical approach adopted by the authorities in dealing with the RTI Application, the PIO is liable for penal action.

Prayers or Relief Sought:

I appeal to you to kindly direct the concerned PIO to provide the correct and relevant information to the undersigned at the earliest, that is complete in all respects. I also humbly appeal to the Hon'ble Commission to levy penal/punitive action against the concerned officer for failing to provide a timely response and compensating the undersigned/appellant for the detriment caused for the reasons mentioned in the appeal above. The Hon'ble Commission may also pass any other or further orders in the interest of justice.

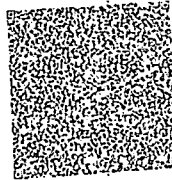

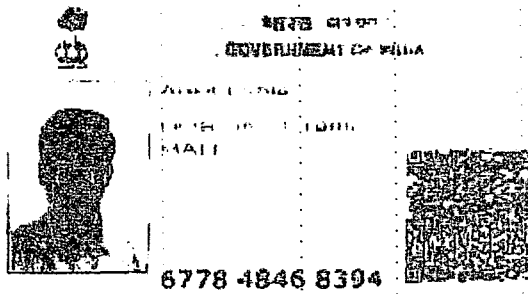

But the PIO has not provided my Marriage Application cum Registration Form which I have shown in the attached photo in the RTI application. Also, the documents (ID proof) provided by the PIO is not clear and the description of the documents is not provided.

4. Under the RTI Act, 2005, a PIO is obliged to provide access to information to a citizen unless as stipulated by Section 7(1), furnishing of such information is covered by one of the exemptions provided under Section 8 or Section 9 of the RTI Act. The PIO has failed to discharge its duties and obligations by refusing to



provide the information and failing to state the reasons for doing so under the law.

Thus according to the meaning provided under the RTI Act, it is obligatory upon the PIO to disclose the entire set of information requested for by the applicant.

8. The PIO has failed to discharge its duties and obligations and has adopted an arbitrary and lackadaisical approach towards dealing with the concerned RTI application. The PIO has also further failed to inform the applicant as to why this information has not been disclosed to the applicant and its reasons thereof. Section 4(1) (d) of the RTI Act clearly lays down that every public authority shall have to disclose the reasons for its decisions to the affected persons.

Written Submission

1. Background:

The Appellant filed an RTI Application under Section 6 of the Right to Information Act, 2005, seeking the following information:

- Certified copy of the Marriage Application cum Registration Form, and
- Copies of documents submitted for issuance of Marriage Certificate No. WB34200100010100002350-2020-23985, dated 6th March 2020.

The CPIO responded by providing only a certified copy of Notice No. 2020-23985 dated 05/02/2020 and some unclear copies of relevant documents. However, the key document requested — the Marriage Application cum Registration Form — was not provided, and the supporting documents furnished lacked clarity and proper description.

Despite clear directions in the First Appeal Order dated 05/02/2024, directing the PIO to provide the documents containing the original signatures of the parties within 15 days, the PIO failed to comply.

The response merely stated that “information is not available in this office,” citing a visit to the flat of one Smt. Mitali Sen (Ex-N.O.M.O), where it was allegedly found that she had disposed of all official records post-retirement.

The following sections of the RTI Act have been grossly violated by the Respondent:

- Section 2(f): The requested documents clearly fall under the definition of “information.”
- Section 6(3): The PIO failed to transfer the RTI application to the appropriate authority within 5 days.
- Section 7(1): There was a failure to respond properly within the stipulated time frame.
- Section 5(3), 5(4), 5(5): The PIO failed to render assistance and make reasonable efforts to retrieve or forward the application appropriately.

The denial of information constitutes a deemed refusal under Section 7(1). The reply stating that the records are “not available” does not absolve the PIO of responsibility. The PIO failed to either provide the information, retrieve it, or transfer the RTI to the concerned department, thereby exposing the PIO to penal action under Section 20(1) of the RTI Act.

There is a delay of 475 days in filing this second appeal. The delay was due to:

- The applicant's job transfer to Bengaluru,
- Medical emergencies concerning the applicant's parents,
- Inability to follow up in Kolkata in person,
- The applicant had previously attempted to file the appeal via speed post but received no acknowledgment or response.

Ranjeet Mukherjee

There is no willful negligence on part of the Appellant. The delay is bona fide and caused by circumstances beyond the Appellant's control. It is, therefore, prayed that the delay be condoned in the interest of justice.

In the case of Ministry of Railways vs. Girish Mittal, the Hon'ble Delhi High Court clarified that the CIC has jurisdiction to impose penalties even on complaints, and not only in appeal proceedings.

Thus, the PIO's failure to provide complete information or transfer the RTI to the correct authority is liable for penal action under Section 20.

The Appellant has suffered mental agony, inconvenience, and detriment due to the indifferent and uncooperative attitude of the authorities. The case is a clear example of poor governance and misuse of power by the custodian of public records.

In light of the above, the Appellant respectfully prays that the Hon'ble Commission may be pleased to:

1. Condone the delay of 475 days in filing the second appeal;
2. Direct the Respondent PIO to furnish the complete and correct information as originally sought, including:
 - o Certified copy of the Marriage Application cum Registration Form;
 - o Clear and legible copies of supporting documents submitted for marriage registration;
3. Initiate appropriate penal proceedings under Section 20(1) of the RTI Act against the erring PIO for failing to discharge duties under the Act;
4. Award compensation under Section 19(8)(b) of the RTI Act to the Appellant for mental harassment, loss of time, and detriment caused;
5. Pass any other appropriate orders or directions as this Hon'ble Commission deems fit in the interest of justice.

AND WHEREAS the Governor has been pleased to consider the question of **ONLINE** marriage registration in the state of West Bengal under the Special Marriage Act, 1954;

AND WHEREAS the **MARREG** portal (www.rgmwb.gov.in) for **ONLINE** marriage registration has been designed and developed by National Informatics Centre (NIC), WBSC and is being maintained by the Office of the Registrar General of Marriages, West Bengal;

NOW, therefore, the Governor has been pleased to notify that solemnization/ registration (as the case may be) of marriage under the under the Special Marriage Act, 1954 (43 of 1954) read with West Bengal Special Marriage Rules, 2010 shall be done by electronic mode on and from 01-12-2018. However, the solemnization/ registration (as the case may be) of marriage may be continued manually till 31-05-2019. The Non Official Marriage Officers/ Ex- Officio Marriage Officers may also continue registration of marriage manually till 30-11-2019 of the parties one of whom is residing abroad. Once a Non Official Marriage Officer/ Ex- Officio Marriage Officer receives Notice u/s- 5 and / or Application u/s- 15 (Form-IV) by electronic mode, such Non Official Marriage Officer/ Ex- Officio Marriage Officer shall not receive Notice u/s- 5 and / or Application u/s- 15 (Form-IV) manually by any means. No registration of marriage under the Rules shall be done manually after 30-11-2019. Non Official Marriage Officers shall submit all used/ unused Books/ Registers and Forms to the Office of the Registrar General of Marriages, West Bengal within 15 (fifteen) days of completion of solemnization/ registration (as the case may be) manually.
